SUMMARY—Revises provisions relating to the subject area of reading. (BDR 34-93)

AN ACT relating to education; revising provisions relating to the retention of certain pupils enrolled in grade 3; revising provisions relating to plans to improve the literacy of pupils; revising provisions relating to teachers who teach in a public elementary school; revising provisions relating to reports concerning pupil performance in the subject area of reading; revising provisions relating to notices concerning pupils who exhibit a deficiency in the subject area of reading; requiring certain interventions and services for pupils who exhibit a deficiency in the subject area of reading and the parent or legal guardian of such a pupil; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

1 Existing law to become effective on July 1, 2019, provides that, unless a pupil  
2 receives a good-cause exemption, a pupil enrolled in grade 3 must be retained in  
3 grade 3 rather than promoted to grade 4 if the pupil does not obtain the  
4 score prescribed by the State Board of Education on the criterion-referenced  
5 examination in reading. (NRS 388A.487, 392.760) **Section 7** of this bill: (1)  
6 removes this requirement and instead provides that a pupil must be retained in  
7 grade 3 if the pupil does not obtain the score prescribed by the State Board on the



8 criterion-referenced examination in reading and his or her parent or legal guardian  
9 provides informed written consent, in consultation with the teacher of the pupil and  
10 the principal of the school; and (2) includes additional good-cause exemptions.

11 Existing law requires the board of trustees of each school district or the  
12 governing body of a charter school to prepare a plan to improve the literacy of  
13 pupils enrolled in kindergarten and grades 1, 2 and 3. (NRS 388.157) **Section 1** of  
14 this bill instead requires this plan to address pupils enrolled in all grades of an  
15 elementary school.

16 Existing law requires that a plan to improve the literacy of pupils include a  
17 program to provide intensive instruction to pupils who have been identified as  
18 deficient in the subject area of reading to ensure that those pupils achieve adequate  
19 proficiency in that subject area. (NRS 388.157) **Section 1** provides that in order to  
20 achieve adequate proficiency in reading, a pupil must perform at a level considered  
21 by the school district or charter school to be within the average range for a pupil  
22 enrolled in the same grade in which the pupil is enrolled.

23 Under existing law, the principal of a public elementary school, including,  
24 without limitation, a charter school, is required to designate a licensed teacher  
25 employed by the school who has demonstrated leadership abilities to serve as a  
26 learning strategist to train and assist teachers in providing intensive instruction to  
27 pupils who have been identified as deficient in the subject area of reading. (NRS  
28 388.159) **Section 2** of this bill instead requires the principal to designate a licensed  
29 teacher to serve as a literacy specialist and prescribes the qualifications and duties  
30 of the literary specialist. Existing law authorizes a school district or charter school  
31 to provide additional compensation to: (1) a licensed teacher designated as a  
32 learning strategist or to a teacher who teaches kindergarten; or (2) a licensed  
33 teacher who teaches grade 1, 2, 3 or 4 whose overall performance is determined to  
34 be highly effective. (NRS 388.159) **Section 2** expands the list of licensed teachers  
35 who are eligible for additional compensation, to include any teacher who teaches in  
36 an elementary school whose overall performance is determined to be highly  
37 effective.

38 Existing law, which becomes effective on July 1, 2019, requires the board of  
39 trustees of each school district and the governing body of a charter school to  
40 prepare a report concerning the number and percentage of pupils who are retained  
41 in grade 3 for deficiency in reading. (NRS 388A.487, 392.775) **Sections 3 and 10**  
42 of this bill additionally require the board of trustees of each school district and the  
43 governing body of a charter school to include in a report certain information  
44 concerning pupils who received educational programs or services in the subject  
45 area of reading.

46 **Section 6** of this bill requires that the plan to assess the proficiency of a pupil  
47 who is deficient in the subject area of reading be established by a licensed teacher.  
48 **Section 6** also removes the requirement that a school assess the proficiency of a  
49 pupil who is receiving services to correct a deficiency in the subject area of reading  
50 at the beginning of the school year and instead requires the school frequently to  
51 assess the progress of the pupil in any areas of deficiency in the subject area of  
52 reading.

53 Existing law requires the principal of a school to offer the parent or legal  
54 guardian of a pupil who is retained in grade 3 certain additional instructional  
55 options. (NRS 392.770) **Section 9** of this bill additionally requires the principal of a  
56 school to offer these options to the parent or legal guardian of a pupil who exhibits  
57 a deficiency in the subject area of reading.

58 Existing law requires the Department of Education to distribute money that is  
59 appropriated to the Other State Education Programs Account through a competitive  
60 grants program. (Section 15 of chapter 334, Statutes of Nevada 2015, p. 1867)  
61 **Section 11** of this bill revises the program to: (1) distribute the money through a  
62 noncompetitive grants program; and (2) authorize schools that receive a grant of



63 money to use the money for literacy programs, additional staff or both, to support  
64 school-based efforts to ensure that all pupils are proficient in reading by the end of  
65 elementary school.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1       **Section 1.** NRS 388.157 is hereby amended to read as follows:

2       388.157 1. The board of trustees of each school district and  
3 the governing body of each charter school shall prepare a plan to  
4 improve the literacy of pupils enrolled in ~~kindergarten and grades~~  
5 ~~1, 2 and 3.~~ *an elementary school.* Such a plan must include,  
6 without limitation:

7       (a) A program to provide intensive instruction to pupils who  
8 have been identified as deficient in the subject area of reading to  
9 ensure that those pupils achieve adequate proficiency in ~~that subject~~  
10 ~~area.~~ *the requisite reading skills and reading comprehension*  
11 *skills necessary to perform at a level considered by the school*  
12 *district or charter school to be within the average range for a pupil*  
13 *enrolled in the same grade in which the pupil is enrolled.* Such a  
14 program must include, without limitation, regularly scheduled  
15 reading sessions in small groups and specific instruction ~~on~~  
16 *designed to target any area of reading in which the pupil*  
17 *demonstrates a deficiency, including, without limitation,*  
18 *phonological and phonemic awareness, decoding skills ,* ~~and~~  
19 *reading fluency* ~~;~~ *and vocabulary and reading comprehension*  
20 *strategies;*

21       (b) Procedures for assessing a pupil's proficiency in the subject  
22 area of reading using valid and reliable *curriculum-based*  
23 assessments that have been approved by the State Board by  
24 regulation:

25       (1) Within the first 30 days of school after the pupil enters  
26 kindergarten or upon enrollment in kindergarten if the pupil enrolls  
27 after that period; and

28       (2) During ~~grades 1, 2 and 3;~~ *each grade level in*  
29 *elementary school;*

30       (c) A program to improve the proficiency in reading of pupils  
31 who are English learners; and

32       (d) Procedures for facilitating collaboration between ~~learning~~  
33 ~~strategists;~~ *licensed teachers designated as literacy specialists* and  
34 classroom teachers.

35       2. The board of trustees of each school district or the governing  
36 body of a charter school, as applicable, shall:



1 (a) Submit its plan to the Department for approval on or before  
2 the date prescribed by the Department on a form prescribed by the  
3 Department; and

4 (b) Make such revisions to the plan as the Department  
5 determines are necessary.

6 **Sec. 2.** NRS 388.159 is hereby amended to read as follows:

7 388.159 1. The principal of a public elementary school,  
8 including, without limitation, a charter school, shall designate a  
9 licensed teacher employed by the school who has demonstrated  
10 ~~leadership abilities~~ *the ability to improve the literacy of pupils* to  
11 serve as a ~~learning strategist~~ *literacy specialist* to ~~train~~ *provide*  
12 *professional development to* and assist teachers at the school to  
13 *implement a system of support which includes various methods to*  
14 provide intensive ~~instruction to~~ *intervention for* pupils who have  
15 been identified as deficient in the subject area of reading.

16 2. A school district or charter school may provide additional  
17 compensation to:

18 (a) A licensed teacher designated as a ~~learning strategist~~  
19 *literacy specialist* pursuant to this section; or

20 (b) A *licensed* teacher who is employed by a school district or  
21 charter school ~~to teach kindergarten or grade 1, 2, 3 or 4~~ *in an*  
22 *elementary school* whose overall performance is determined to be  
23 highly effective under the statewide performance evaluation system  
24 established by the State Board pursuant to NRS 391.465.

25 3. Each *licensed* teacher employed by a school district or  
26 charter school to teach ~~kindergarten or grade 1, 2, 3 or 4~~ *in an*  
27 *elementary school* shall complete professional development  
28 provided by a ~~learning strategist designated~~ *licensed teacher*  
29 *designated as a literacy specialist* pursuant to subsection 1 in the  
30 subject area of reading.

31 4. The State Board shall prescribe by regulation:

32 (a) Any training or professional development that a ~~learning~~  
33 ~~strategist~~ *licensed teacher designated as a literacy specialist* is  
34 required to successfully complete;

35 (b) Any professional development that a teacher employed by a  
36 school district or charter school to teach ~~kindergarten or grade 1, 2,~~  
37 ~~3 or 4~~ *in an elementary school* is required to receive from a  
38 ~~learning strategist~~ *licensed teacher designated as a literacy*  
39 *specialist* in the subject area of reading; and

40 (c) The duties and responsibilities of a ~~learning strategist.~~  
41 *licensed teacher designated as a literacy specialist.*

42 **Sec. 3.** Chapter 388A of NRS is hereby amended by adding  
43 thereto a new section to read as follows:

44 *On or before September 1 of each year, the governing body of a*  
45 *charter school that operates as an elementary school shall:*



1 *1. Prepare a report concerning the number and percentage of*  
2 *pupils at each grade level at the charter school who received*  
3 *educational programs and services identified pursuant to*  
4 *subsection 1 of NRS 392.750 and whose proficiency in the subject*  
5 *area of reading:*

6 *(a) Did not improve at a rate prescribed by the governing body*  
7 *of the charter school, indicating a need for more intensive or*  
8 *different interventions;*

9 *(b) Improved at a rate prescribed by the governing body of the*  
10 *charter school, indicating progress toward performing at a level*  
11 *considered by the charter school to be within the average range*  
12 *for pupils enrolled in the same grade level in which the pupils are*  
13 *enrolled; and*

14 *(c) Is considered by the charter school to be within the average*  
15 *range for pupils in the same grade level in which the pupils are*  
16 *enrolled.*

17 *2. Submit a copy of the report to the Department, the*  
18 *Legislature and the sponsor of the charter school.*

19 *3. Post the report on the Internet website maintained by the*  
20 *charter school and otherwise make the report available to the*  
21 *parents and legal guardians of pupils enrolled in the charter*  
22 *school and the general public.*

23 **Sec. 4.** NRS 388A.487 is hereby amended to read as follows:

24 388A.487 1. The governing body of a charter school shall  
25 adopt rules for the academic retention of pupils who are enrolled in  
26 the charter school that are consistent with NRS 392.750, 392.760  
27 and 392.765. The rules must:

28 (a) Prescribe the conditions under which a pupil may be retained  
29 in the same grade rather than promoted to the next higher grade for  
30 the immediately succeeding school year.

31 (b) Require a pupil enrolled in grade 3 to be retained in the same  
32 grade rather than promoted to grade 4 when required pursuant to  
33 NRS 392.760.

34 2. On or before September 1 of each year, the governing body  
35 of each charter school shall:

36 (a) Prepare a report concerning the number and percentage of  
37 pupils at the charter school who were:

38 (1) Retained in grade 3 pursuant to NRS 392.760 for a  
39 deficiency in the subject area of reading, including whether or not  
40 any such pupils were previously retained in kindergarten or grade 1  
41 or 2; and

42 (2) Not retained in grade 3 because a good cause exemption  
43 was approved pursuant to NRS 392.760 but who were previously  
44 retained in kindergarten or grade 1 or 2 for a total of 2 years;



1 (b) Submit a copy of the report to the Department ~~[ ]~~, *the*  
2 *Legislature and the sponsor of the charter school*; and

3 (c) Post the report on the Internet website maintained by the  
4 charter school and otherwise make the report available to the parents  
5 and legal guardians of pupils enrolled in the charter school and the  
6 general public.

7 **Sec. 5.** NRS 392.750 is hereby amended to read as follows:

8 392.750 If a pupil enrolled at a public elementary school ~~[in~~  
9 ~~kindergarten or grade 1, 2 or 3]~~ exhibits a deficiency in the subject  
10 area of reading based upon state or local assessments and the  
11 observations of the pupil's teacher, the principal of the school must  
12 provide written notice of the deficiency to the parent or legal  
13 guardian of the pupil within 30 days after the date on which the  
14 deficiency is discovered. The written notice must, without  
15 limitation:

16 1. Identify the educational programs and services that the pupil  
17 will receive to improve the pupil's proficiency in the subject area of  
18 reading, including, without limitation, the programs and services  
19 included in the plan to improve the literacy of pupils enrolled in  
20 ~~[kindergarten and grades 1, 2 and 3]~~ *elementary school* that has  
21 been approved by the Department pursuant to NRS 388.157;

22 2. Explain that if the pupil does not achieve adequate  
23 proficiency in the subject area of reading before the completion of  
24 grade 3, the pupil will be retained in grade 3 rather than promoted to  
25 grade 4, unless the pupil receives a good-cause exemption pursuant  
26 to NRS 392.760;

27 3. Describe, explain and, if appropriate, demonstrate the  
28 strategies which the parent or legal guardian may use at home to  
29 help improve the proficiency of the pupil in the subject area of  
30 reading;

31 4. Explain that the criterion-referenced examination in the  
32 subject area of reading administered pursuant to NRS 390.105 is not  
33 the only factor used to determine whether the pupil will be retained  
34 in grade 3 and that other options are available for the pupil to  
35 demonstrate proficiency if the pupil is eligible for a good-cause  
36 exemption pursuant to NRS 392.760;

37 5. Describe the policy and specific criteria adopted by the  
38 board of trustees of the school district or governing body of a  
39 charter school, as applicable, pursuant to NRS 392.765 regarding  
40 the promotion of a pupil to grade 4 at any time during the school  
41 year if the pupil is retained in grade 3 pursuant to NRS 392.760;

42 6. Include information regarding the English literacy  
43 development of a pupil who is an English learner; and

44 7. Describe, explain and, if appropriate, demonstrate the  
45 strategies which the parent or legal guardian may use at home to



1 help improve the English literacy of a pupil who is an English  
2 learner.

3 **Sec. 6.** NRS 392.755 is hereby amended to read as follows:

4 392.755 1. A public elementary school that has notified the  
5 parent or legal guardian of a pupil that, based upon the results of  
6 state or local assessments, it has been determined that the pupil has a  
7 deficiency in the subject area of reading pursuant to NRS 392.750  
8 shall, within 30 days after providing such notice, establish a plan to  
9 monitor the progress of the pupil in the subject area of reading.

10 2. A plan to monitor the progress of a pupil in the subject area  
11 of reading must be established by ~~[the]~~ *a licensed* teacher ~~[of the~~  
12 ~~pupil]~~ and any other relevant *licensed* school personnel and  
13 approved by the principal of the school and the parent or legal  
14 guardian of the pupil. The plan must include a description of any  
15 intervention services that will be provided to the pupil to correct the  
16 *area of* deficiency and must include that the pupil will receive  
17 intensive instruction in reading ~~[to ensure]~~ *until* the pupil achieves  
18 adequate proficiency in *the requisite* reading ~~[ ]~~ *skills and reading*  
19 *comprehension skills necessary to perform at a level considered by*  
20 *the school to be within the average range for a pupil enrolled in*  
21 *the same grade in which the pupil is enrolled.* Such instruction  
22 must include, without limitation, the programs and services included  
23 in the plan to improve the literacy of pupils enrolled in ~~[kindergarten~~  
24 ~~and grades 1, 2 and 3]~~ *elementary school* approved by the  
25 Department pursuant to NRS 388.157.

26 3. A school that establishes a plan to monitor the progress of a  
27 pupil in the subject area of reading shall *frequently* assess the  
28 ~~[proficiency]~~ *progress* of the pupil in ~~[the subject]~~ *any* area of  
29 *deficiency in the subject area of* reading ~~[at the beginning of the~~  
30 ~~next school year after the plan is established pursuant to this~~  
31 ~~section.]~~ *to ensure that the programs and services provided to the*  
32 *pupil pursuant to subsection 1 of NRS 392.750 continue to*  
33 *increase the proficiency of the pupil in the subject area of reading*  
34 *until the pupil performs at a level considered by the school to be*  
35 *within the average range for a pupil enrolled in the same grade in*  
36 *which the pupil is enrolled.*

37 **Sec. 7.** NRS 392.760 is hereby amended to read as follows:

38 392.760 1. Except as otherwise provided in this section, a  
39 pupil enrolled in grade 3 must be retained in grade 3 rather than  
40 promoted to grade 4 if the ~~[pupil]~~ :

41 (a) *Pupil* does not obtain a score in the subject area of reading  
42 on the criterion-referenced examination administered pursuant to  
43 NRS 390.105 that meets the passing score prescribed by the State  
44 Board pursuant to subsection 7 ~~[ ]~~ ; *and*



1 (b) *Parent or legal guardian of the pupil provides informed*  
2 *written consent, in consultation with the teacher of the pupil and*  
3 *principal of the school, that the pupil must be retained.*

4 2. The superintendent of schools of a school district or the  
5 governing body of a charter school, as applicable, *or designee* may  
6 authorize the promotion of a pupil to grade 4 who would otherwise  
7 be retained in grade 3 only if the superintendent or governing body,  
8 as applicable, approves a good-cause exemption for the pupil upon a  
9 determination by the principal of the school pursuant to subsection 4  
10 that the pupil is eligible for such an exemption.

11 3. A good-cause exemption must be approved for a pupil who  
12 previously was retained in *kindergarten or* grade *1, 2 or* 3. Any  
13 other pupil is eligible for a good-cause exemption if the pupil:

14 (a) Demonstrates an acceptable level of proficiency in reading  
15 on an alternative standardized reading assessment approved by the  
16 State Board;

17 (b) Demonstrates ~~{}~~ *progress in reading* through a *growth*  
18 portfolio of the pupil's work, ~~{proficiency}~~ *which demonstrates*  
19 *improvement at a rate indicating the pupil is making progress in*  
20 *the subject of* reading ~~{at grade level, as evidenced by~~  
21 ~~demonstration of mastery of the academic standards in reading~~  
22 ~~beyond the retention level;}~~ *towards performing at a level*  
23 *considered to be within the average range for a pupil enrolled in*  
24 *the same grade in which the pupil is enrolled;*

25 (c) Is an English learner and has received less than 2 years of  
26 instruction in a program of instruction that teaches English as a  
27 second language;

28 (d) Received intensive remediation in the subject area of reading  
29 for 2 or more years but still demonstrates a deficiency in reading *at*  
30 *his or her level of instruction* and was previously retained in  
31 kindergarten or grade 1 or 2 for a total of 2 years;

32 (e) Is a pupil with a disability and his or her individualized  
33 education program indicates that the pupil's participation in the  
34 criterion-referenced examinations administered pursuant to NRS  
35 390.105 is not appropriate; ~~{or}~~

36 (f) *Received instruction pursuant to paragraph (b) of*  
37 *subsection 2 of NRS 392.765; or*

38 (g) Is a pupil with a disability and:

39 (1) He or she participates in the criterion-referenced  
40 examinations administered pursuant to NRS 390.105;

41 (2) His or her individualized education program or plan  
42 developed in accordance with section 504 of the Rehabilitation Act  
43 of 1973, 29 U.S.C. § 794, documents that the pupil ~~{has received~~  
44 ~~intensive remediation in reading for more than 2 years, but he or she~~





1 ~~still~~ demonstrates a deficiency in reading ~~{}~~ *which requires*  
2 *intensive remediation;* and

3 (3) He or she was previously retained in kindergarten or  
4 grade 1, 2 or 3.

5 4. The principal of a school in which a pupil who may be  
6 retained in grade 3 pursuant to subsection 1 is enrolled shall  
7 consider the factors set forth in subsection 3 and determine whether  
8 the pupil is eligible for a good-cause exemption. In making the  
9 determination, the principal must consider documentation provided  
10 by the pupil's teacher indicating whether the promotion of the pupil  
11 is appropriate based upon the record of the pupil. Such  
12 documentation must ~~{only}~~ consist of the existing plan for  
13 monitoring the progress of the pupil, the pupil's individualized  
14 education program, if applicable, *data collected relating to the*  
15 *progress of the pupil* and the pupil's plan in accordance with section  
16 504 of the Rehabilitation Act of 1973, 29 U.S.C. § 794, if  
17 applicable. If the principal determines that promotion of the pupil to  
18 grade 4 is appropriate, the principal must submit a written  
19 recommendation to the superintendent of schools of the school  
20 district or to the governing body of the charter school, as applicable  
21 ~~{}~~, *or to a designee*. The superintendent of schools or the governing  
22 body of the charter school, as applicable, *or the designee* shall  
23 approve or deny the recommendation of the principal and provide  
24 written notice of the approval or denial to the principal.

25 5. A principal who determines that a pupil is eligible for a  
26 good-cause exemption shall notify the parent or legal guardian of  
27 the pupil whether the superintendent of schools of the school district  
28 or the governing body of the charter school, as applicable, *or the*  
29 *designee* approves the good-cause exemption.

30 6. The principal of a school in which a pupil for whom a good-  
31 cause exemption is approved and who is promoted to grade 4 must  
32 ensure that the pupil continues to receive intensive instruction in the  
33 subject area of reading. Such instruction must include, without  
34 limitation, strategies based upon evidence-based research that will  
35 improve proficiency in the subject area of reading.

36 7. The State Board shall prescribe by regulation:

37 (a) The score which a pupil enrolled in grade 3 must obtain in  
38 the subject area of reading on the criterion-referenced examination  
39 administered pursuant to NRS 390.105 to be promoted to grade 4  
40 without a good-cause exemption; and

41 (b) An alternate examination for administration to pupils  
42 enrolled in grade 3 who do not obtain the passing score in the  
43 subject area of reading on the criterion-referenced examination  
44 administered pursuant to NRS 390.105 and the passing score such a



1 pupil must obtain on the alternate examination to be promoted to  
2 grade 4 without a good-cause exemption.

3 8. As used in this section, “individualized education program”  
4 has the meaning ascribed to it in 20 U.S.C. § 1414(d)(1)(A).

5 **Sec. 8.** NRS 392.765 is hereby amended to read as follows:

6 392.765 1. If a pupil will be retained in grade 3 pursuant to  
7 NRS 392.760, the principal of the school must:

8 (a) Provide written notice to the parent or legal guardian of the  
9 pupil *confirming* that the pupil will be retained in grade 3. The  
10 written notice must include, without limitation, a description of the  
11 intensive instructional services in the subject area of reading that the  
12 pupil will receive to improve the proficiency of the pupil in that  
13 subject area.

14 (b) Develop a plan to monitor the progress of the pupil in the  
15 subject area of reading.

16 (c) Require the teacher of the pupil to develop a portfolio of the  
17 pupil’s work in the subject area of reading, which must be updated  
18 as necessary to reflect progress made by the pupil.

19 (d) Ensure that the pupil receives intensive instructional services  
20 in the subject area of reading that are designed to improve the  
21 pupil’s proficiency in the subject area of reading, including, without  
22 limitation:

23 (1) Programs and services included in the plan to improve  
24 the literacy of pupils enrolled in ~~kindergarten and grades 1, 2 and 3~~  
25 *elementary school* approved by the Department pursuant to  
26 NRS 388.157;

27 (2) Instruction for at least 90 minutes each school day based  
28 upon evidence-based research concerning reading instruction; and

29 (3) Intensive instructional services prescribed by the board of  
30 trustees of the school district pursuant to subsection 2, as determined  
31 appropriate for the pupil.

32 2. The board of trustees of each school district or the governing  
33 body of a charter school, as applicable, shall:

34 (a) Review and evaluate the plans for monitoring the progress of  
35 pupils developed pursuant to subsection 1.

36 (b) Prescribe the intensive instructional services in the subject  
37 area of reading which the principal of a school must implement as
