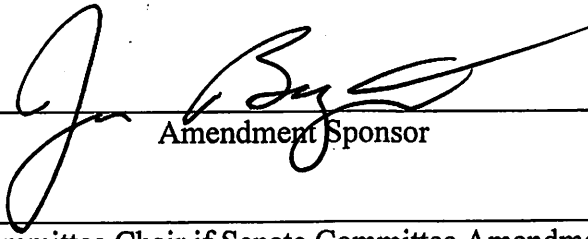

"with one or more LME/MCOs for the purposes of contracting for DCCRP's under this subsection."

SECTION 6.1.(b) The Department of Health and Human Services (DHHS) and the Administrative Office of the Courts, in collaboration with the North Carolina Sheriff's Association, Indigent Defense Services, the Conference of District Attorneys, and other stakeholders as deemed necessary, shall study relevant statutes and practices, and propose legislative changes to create a permanent process and procedure for capacity restoration that does not require involuntary commitment pursuant to Part 7 of Article 5 of Chapter 122C of the General Statutes. DHHS and the Administrative Office of the Courts shall submit a report to the Joint Legislative Oversight Committee on Health and Human Services with the proposed legislative changes by January 1, 2026."
