6	SECT	TON 1. The grants funded by this act shall be provided to municipal police		
7	departments and o	county sheriffs' offices for at least one of the following purposes:		
8	(1)	To establish nonpolice units to address nonviolent, noncriminal 911 calls		
9		regarding mental health, homelessness, substance use, or other behavioral		
10		health crises.		
11	(2)	To establish co-responder response models in which law enforcement		
12		personnel and mental health specialists jointly respond to 911 calls regarding		
13		mental or behavioral health crises.		
14	(3)	To establish a mental health division or to bolster existing mental health		
15		services within a police department or sheriff's office and to increase the		
16		amount of law enforcement personnel and 911 communications personnel that		
17		have received Crisis Intervention Training.		
18		TON 2. There is appropriated from the General Fund to the Department of $(12, 100, 100, 100, 100, 100, 100, 100, 1$		
19		sum of two million dollars (\$2,000,000) in nonrecurring funds in the 2023-2024		
20	fiscal year to be distributed as grants to either municipal police departments or county sheriffs'

22	(1)	\$800,000 to establish eight nonpolice response units with a grant of \$100,000 each.		
23 24	(2)	\$700,000 to establish seven co-responder response models with a grant of

26	(3)	\$500,000 to increase the amount of law enforcement officers and 911		
20	(3)	communications personnel that have received Crisis Intervention Training.		
28		These funds shall be awarded as five separate grants of \$100,000 each.		
29	SECT	TON 3. Grants awarded pursuant to Section 2 of this act shall be awarded to

33	SECT	TON 4. No later than February 1, 2025, the police departments and sheriffs'

20	funded by this act. The report shall include, at a minimum, the information provided to the		
21	Department of Public Safety pursuant to Section 4 of this act.		
22	SECT	TION 6. This act becomes effective July 1, 2023.
