| 12 | § 22.1-207.1. Family life education. |
| 13 | A. As used in this section, "abstinence education" means an educational or motivational component |
| 14 | that has as its exclusive purpose teaching the social, psychological, and health gains to be realized by |
| 15 | teenagers' abstaining from sexual activity before marriage. |
| 16 | B. The Board of Education shall develop Standards of Learning and curriculum guidelines for a |
| 17 | comprehensive, sequential family life education curriculum in grades kindergarten through 12. Such |
| 18 | curriculum guidelines shall include instruction as appropriate for the age of the student in family living |
| 19 | and community relationships; the benefits, challenges, responsibilities, and value of marriage for men, |
