9 SYNOPSIS: This bill makes a supplemental appropriation
10 from the Education Trust Fund to the State
11 Department of Education in the amount of \$3,112,615
12 for the fiscal year ending September 30, 2019;
13 makes a supplemental appropriation from the
14 Education Trust Fund to the Department of
15 Rehabilitation Services in the amount of \$1,550,000
16 for the fiscal year ending September 30, 2019;
17 makes a supplemental appropriation from the
18 Education Trust Fund to the Alabama Public Library
19 Service in the amount of \$500,000 for the fiscal
20 year ending September 30, 2019; makes a
21 supplemental appropriation from the Education Trust
22 Fund to the Alabama Building Renovation Finance
23 Authority in an amount up to \$650,000 for the
24 fiscal year ending September 30, 2019; makes a
25 supplemental appropriation from the Education Trust
26 Fund to the Lieutenant Governor Workforce
27 Commission in the amount of \$150,000 for the fiscal

1 year ending September 30, 2019; and makes a
2 supplemental appropriation from the Education Trust
3 Fund to the Alabama Community College System for
4 the Dual Enrollment Program in the amount of
5 \$977,997 for the fiscal year ending September 30,
6 2019.

12 To make a supplemental appropriation from the
13 Education Trust Fund to the State Department of Education in
14 the amount of \$3,112,615 for the fiscal year ending September
15 30, 2019; to make a supplemental appropriation from the
16 Education Trust Fund to the Department of Rehabilitation
17 Services in the amount of \$1,550,000 for the fiscal year
18 ending September 30, 2019; to make a supplemental
19 appropriation from the Education Trust Fund to the Alabama
20 Public Library Service in the amount of \$500,000 for the
21 fiscal year ending September 30, 2019; to make a supplemental
22 appropriation from the Education Trust Fund to the Alabama
23 Building Renovation Finance Authority in an amount up to
24 \$650,000 for the fiscal year ending September 30, 2019; to
25 make a supplemental appropriation from the Education Trust
26 Fund to the Lieutenant Governor Workforce Commission in the
27 amount of \$150,000 for the fiscal year ending September 30,

1 2019; and to make a supplemental appropriation from the
2 Education Trust Fund to the Alabama Community College System
3 for the Dual Enrollment Program in the amount of \$977,997 for
4 the fiscal year ending September 30, 2019.

5 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

6 Section 1. In addition to all other appropriations
7 heretofore or hereafter made, there is hereby appropriated
8 \$3,112,615 from the Education Trust Fund to the State
9 Department of Education for the fiscal year ending September
10 30, 2019. Of this appropriation, \$1,809,535 shall be expended
11 for start-up costs incurred in connection with the
12 implementation of a new Student Administration System;
13 \$303,080 shall be expended for pilot projects to address
14 dyslexia; and \$1,000,000 shall be expended to support the
15 development of programs specifically targeted at literacy,
16 numeracy, and career and technical education through the
17 expansion of professional development opportunities for
18 teachers in the summer of 2019.

19 Section 2. In addition to all other appropriations
20 heretofore or hereafter made, there is hereby appropriated
21 \$1,550,000 from the Education Trust Fund to the Department of
22 Rehabilitation Services for the fiscal year ending September
23 30, 2019. Of this appropriation, \$1,300,000 shall be expended
24 for the Early Intervention Program and \$250,000 shall be
25 transferred to the Alabama Head and Spinal Cord Injury Trust
26 Fund.

1 Section 3. In addition to all other appropriations
2 heretofore or hereafter made, there is hereby appropriated
3 \$500,000 from the Education Trust Fund to the Alabama Public
4 Library Service for the fiscal year ending September 30, 2019.
5 Of this appropriation, \$250,000 shall be distributed to the
6 Alabama Supreme Court Library and \$250,000 is to be
7 distributed to public libraries within the State.

8 Section 4. In addition to all other appropriations
9 heretofore or hereafter made, there is hereby appropriated up
10 to \$650,000 from the Education Trust Fund to the Alabama
11 Building Renovation Finance Authority for the fiscal year
12 ending September 30, 2019. This appropriation shall be
13 expended to reimburse the Authority for expenditures incurred
14 related to bicentennial activities. This appropriation shall
15 be limited to the amount necessary to reimburse the Authority.

16 Section 5. In addition to all other appropriations
17 heretofore or hereafter made, there is hereby appropriated
18 \$150,000 from the Education Trust Fund to the Lieutenant
19 Governor Workforce Commission for the fiscal year ending
20 September 30, 2019.

21 Section 6. In addition to all other appropriations
22 heretofore or hereafter made, there is hereby appropriated
23 \$977,997 from the Education Trust Fund to the Alabama
24 Community College System for the Dual Enrollment Program for
25 the fiscal year ending September 30, 2019.

1 Section 7. This act shall become effective
2 immediately upon its passage and approval by the Governor, or
3 upon its otherwise becoming law.
