AN ACT ESTABLISHING A TASK FORCE TO STUDY THE USE OF BREED OF DOG AS AN UNDERWRITING FACTOR FOR HOMEOWNERS INSURANCE POLICIES.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

- 1 Section 1. (*Effective from passage*) (a) There is established a task force
- 2 to study the use of breed of dog as an underwriting factor for
- 3 homeowners insurance policies delivered, issued for delivery, renewed,
- 4 amended or endorsed in this state. Such study shall include, but need
- 5 not be limited to, an examination of the feasibility and effects of
- 6 prohibiting the use of breed of dog as an underwriting factor for such
- 7 homeowners insurance policies.
- 8 (b) The task force shall consist of the following members:
- 9 (1) Two appointed by the speaker of the House of Representatives;
- 10 (2) Two appointed by the president pro tempore of the Senate;
- 11 (3) One appointed by the majority leader of the House of

- 13 (4) One appointed by the majority leader of the Senate;
- 14 (5) One appointed by the minority leader of the House of 15 Representatives;
- 16 (6) One appointed by the minority leader of the Senate;
- 17 (7) The Insurance Commissioner, or the commissioner's designee; 18 and
- 19 (8) Two appointed by the Governor.
- 20 (c) Any member of the task force appointed under subdivision (1), 21 (2), (3), (4), (5) or (6) of subsection (b) of this section may be a member
- 22 of the General Assembly.
- 23 (d) All initial appointments to the task force shall be made not later 24 than thirty days after the effective date of this section. Any vacancy shall
- 25 be filled by the appointing authority.
- (e) The speaker of the House of Representatives and the president pro
 tempore of the Senate shall select the chairpersons of the task force from
 among the members of the task force. Such chairpersons shall schedule
 the first meeting of the task force, which shall be held not later than sixty
- 30 days after the effective date of this section.
- 31 (f) The administrative staff of the joint standing committee of the 32 General Assembly having cognizance of matters relating to insurance
- 33 shall serve as administrative staff of the task force.
- 34 (g) Not later than January 1, 2021, the task force shall submit a report
- on its findings and recommendations to the joint standing committee of
- 36 the General Assembly having cognizance of matters relating to
- 37 insurance, in accordance with the provisions of section 11-4a of the
- 38 general statutes. The task force shall terminate on the date that it
- 39 submits such report or January 1, 2021, whichever is later.
