Amend C.S.S.B. No. 1 (house committee report) as follows:

(1) In Article II of the bill, in the appropriations to the
Department of Family and Protective Services (page II-1),
proportionately reduce the amount of the general revenue
appropriation for each strategy by a total of \$5,000,000 for the
state fiscal year ending August 31, 2026.

7 (2) In Article II of the bill, following the appropriations 8 to the Department of Family and Protective Services, strike Rider 9 38, Community Services Construction Grant (page II-18), and 10 renumber subsequent riders accordingly.

(3) In Article II of the bill, in the appropriations to the Health and Human Services Commission (page II-34), strike Strategy D.1.2, Thriving Texas Families Program, and the amount of the general revenue appropriation for that strategy for each state fiscal year of the state fiscal biennium ending August 31, 2027.

16 (4) Strike each reference in the bill to Strategy D.1.2,
17 Thriving Texas Families Program.

18 (5) In Article II of the bill, following the appropriations 19 to the Health and Human Services Commission, strike Rider 49, 20 Thriving Texas Families (page II-62), and renumber subsequent 21 riders accordingly.

(6) In Article II of the bill, following the appropriations to the Health and Human Services Commission, in Rider 107, Limitations on Transfer Authority (page II-82), strike Subsection (d) of the rider and reletter subsequent subsections of the rider accordingly.

(7) In Article II of the bill, following the appropriations
to the Health and Human Services Commission, in Rider 138, Maximize
Federal Funds for Maternal Home Visiting Services (page II-90), in

1 Subsection (d) of the rider strike "Thriving Texas Families and".

(8) In Article III of the bill, in the appropriations to the
Texas Education Agency, increase the general revenue
appropriations for Strategy B.2.3, Child Nutrition Programs (page
III-2), by the amount of \$145,000,000 for the state fiscal biennium
ending August 31, 2027.

7 (9) In Article XI of the bill, in the Article II items for 8 consideration listed for the Health and Human Services Commission 9 (page XI-7), strike "Thriving Texas Families" in each instance it 10 appears and the associated amount for the state fiscal biennium 11 ending August 31, 2027.

12 (10) In Article XI of the bill, in the Article II items for 13 consideration listed for the Health and Human Services Commission 14 (page XI-7), strike "Thriving Texas Families, Payment Method 15 Models".

16 (11) In Article XI of the bill, in the Article II items for 17 consideration listed for the Health and Human Services Commission 18 (page XI-8), strike "Thriving Texas Families, Parenting in 19 Recovery" and the associated amount for the state fiscal biennium 20 ending August 31, 2027.

(12) Adjust totals and methods of financing accordingly.
