Common Misconceptions

There are some common misconceptions that you'll hear a lot when it comes to some of the topics that we are covering in this book. We would like to take this opportunity now to address them.

Misconception:

Free energy is impossible because it breaks the first law of thermodynamics which states, 'energy can neither be created nor destroyed. Heat and mechanical work being mutually convertible.'

This is not correct. The laws of thermodynamics are a part of the 'laws of physics' which are themselves incomplete. Fifty percent of the original theories that created the laws of physics were purposefully redacted from our public knowledge base by the financial interests of JP Morgan, Hendrick Lorenz and Thomas Edison. The missing theories are found in the 'laws of nature,' for which there are several law-breaking examples, such as the flight of the bumblebee which is fully explained in the section of this book called Maxwell's Theories Redacted.

Misconception:

Perpetual motion is impossible.

If this were true, then how does the earth rotate? How do electrons spin around an atom? There are many examples of perpetual motion all around us, yet we are told to believe that this is not possible. We cover

this in the Laws of Nature section and also provide many examples throughout that show examples of natural energetic phenomena that can't be explained by the incomplete Laws of Physics.

Misconception:

No one has ever successfully demonstrated a device which produces more energy than is fed into it. If anyone ever did they would instantly be a billionaire.

Again this is not true. We cover some of them in this book including, Stanley Meyer, Paul Pantone, Bruce DePalma, and Pons & Fleischman. These inventors were ridiculed, threatened, and even murdered in one case. Their inventions were silenced, and they usually were made financially destitute.

Misconception:

If you believe any of this stuff you are a crazy, tin foil hat-wearing conspiracy theorist.

This is a prime example of social programming. Many conspiracy theories have been recently proven to be conspiracy facts.

Nevertheless, most people just disregard many new technologies as conspiracy theories. Governments and energy companies have spent decades, and billions of dollars in social engineering programs to influence people. We cover this in our sections on JTRIG, COINTELPRO, Gangstalking and Electronic Harassment. Some of the measures that have been taken are diabolical to say the least.

Energy Vocabulary Basics

In the world of free energy development, you'll hear a lot of terms tossed around. Here are a few definitions to help you with some of the basics:

Free Energy

Free energy means energy at no cost, like mechanical energy which drives a wind mill, or light in a solar cell which is transformed into DC electric current. Energy from free sources include wind, solar, water, atmospheric electricity, resonance and mechanical vibrations, earth batteries, chemical reactions, and pressure system changes. These are all ways of generating or accumulating energy that cannot be bought, metered or sold.

Efficiency

Efficiency is the useful energy (output) from a device, over the energy that is put into the device (input). And if you want to find the percent, like this motor is 75% of or this transformer is 95% efficient and the energy efficiency, you would use the following equation; it is energy output over energy input times 100 percent.

$$\text{Efficiency} = \frac{\text{Useful Energy Output}}{\text{Energy Input}} \times 100\%$$

$$\text{Efficiency} = \frac{\text{Useful Power Output}}{\text{Power Input}} \times 100\%$$

Currently the systems we are using right now are extremely wasteful and inefficient. For example, the average home backup generator requires 15kw worth of power in (in the form of gasoline for example) in order to generate 10kw of electrical power out. Most generators operate at a loss. They are designed this way in order to encourage the consumption of fossil fuels.

Planned Obsolescence

Planned obsolescence, or built-in obsolescence, is a design policy followed in big industrial manufacturing that gives a product a planned artificially limited useful life. This means the product will become obsolete or unfunctional after a certain period of time. The logic behind this strategy is to generate long term sales volume by reducing the time between repeat purchases. The result is lower quality products that just don't last as long as they should.

“They just don't build them like they used to” is a term you hear a lot when it comes to appliances and devices that we depend on in our

daily lives. In truth it would be more accurate to say “They don’t build them like they should.” The technology exists to build more efficient and longer lasting products. Inefficient motors is a prime example of something that could be improved. However current corporate structuring (that many customers feel is corrupt) won’t allow for quality improvement to effect their profit margin.

Overunity

Overunity simply means you get more energy out than you put in, the scientific term meaning greater than 1. This is when the useful energy output versus the useful energy input is higher than 100%. In physics (and elsewhere) unity is another name for 1. It is confused with perpetual motion because the idea then is that you could connect an over-unity device's output to its input and then it would run itself.

Perpetual Motion

A hypothetical machine that can do work indefinitely without an energy source (exists in isolation) often confused with overunity. The theory of such a device is that it can exist in isolation meaning, it operates on its own without any additional external support system. However it does access a reservoir of energy. It is not something that is bound by a closed system.

COP over 1

The Co-efficiency of Performance is similar to overunity. It is the same equation, basically. It's normal to express the co-efficient as the ratio of energy output to the energy input, so it's basically the same. The examples normally used deal with temperatures because this equation was based on the efficiency of heat pumps. What is well known is that with the heat pumps you can get efficiency over 1 regularly because you are not dealing with transferring that heat from one form into another, like electrical. With heat pumps you are measuring how much energy you use to create that heat, and using that to heat other parts of your system. Typical heat pumps operate from a source temperature of 5 degrees centigrade and are designed for heating only a COP of 3, which is over 1. Whereas a reversal machine of the same conditions would have a COP of 2.6. The point is, these are co-efficient performance over 1; you put so much energy in and you get a lot of energy in the form of heat stored that is being used for that period of time.

Coefficient of Performance (COP) - 2

•It is normal to express this coefficient as the ratio of energy output to energy input, rather than use temperatures, as shown below.

$$\bullet \text{COP} = Q / W$$

•Where;

•COP = coefficient of performance

•Q = high grade energy output (kWh or kJ).

•W = electrical or mechanical energy input (kWh or kJ).

•Typically, a heat pump operating from a source temperature of 5°C and designed for heating only would have a COP of about 3.0, whereas a reversible machine for the same conditions would have a COP of about 2.6

EMF and Back EMF

Electromotive force, also called EMF, is the voltage developed by any source of electrical energy, such as a battery or dynamo. It is defined as the electrical potential for a source in a circuit.

Back EMF, also known as counter-electromotive force (CEMF), is the voltage, or electromotive force, that pushes against the current which induces it. CEMF is the voltage drop in an alternating current (AC) circuit caused by magnetic induction.

The term back electromotive force, or just back-EMF, is commonly used to refer to the voltage that occurs in electric motors where there is relative motion between the armature of the motor and the magnetic field from the motor's field magnets, or windings. From Faraday's law,

the voltage is proportional to the magnetic field, length of wire in the armature, and the speed of the motor. This effect is not due to the motor's inductance and is a completely separate effect.

In a motor using a rotating armature in the presence of a magnetic flux, the conductors cut the magnetic field lines as they rotate. This produces a voltage in the coil; the motor is acting like a generator at the same time it is a motor. This voltage opposes the original applied voltage; therefore, it is called back-electromotive force. With a lower overall voltage across the armature, the current flowing into the motor is reduced.

To observe the effect of Back-EMF of a motor, one can perform this simple exercise. With an incandescent light on, cause a large motor such as a drill press, saw, air conditioner compressor, or vacuum cleaner to start. The light may dim briefly as the motor starts. When the armature is not turning (called locked rotor) there is no Back-EMF and the motor's current draw is quite high. If the motor's starting current is high enough it will pull the line voltage down enough to notice the dimming of the light.

Faraday's Law of Induction

Faraday's law of induction is a basic law of electromagnetism predicting how a magnetic field will interact with an electric circuit to produce an electromotive force (EMF)—a phenomenon called electromagnetic induction. It is the fundamental operating principle of transformers, inductors, and many types of electrical motors,

generators and solenoids. The Maxwell–Faraday equation is a generalization of Faraday's law.

Lenz Law

The Lenz law was named after the physicist Heinrich Lenz who formulated it in 1834. It states that the direction of current, induced in a conductor by a changing magnetic field, due to Faraday's law of induction, will be such that it will create a field that opposes the change that produced it.

The Lenz effect can best be seen in a simple experiment when a highly magnetized ball is passed through a metal tube. The magnetic field causes the ball to move slowly through the tube showing resistance.



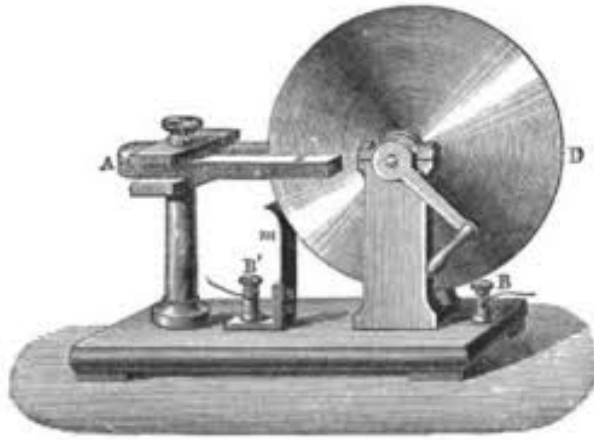
Lenz Effect

Early Inventors and Scandals



Inventor: Michael Faraday

Michael Faraday, FRS (22 Sep 1791–Aug 25 1867) was an English chemist and physicist who studied the magnetic field around a conductor carrying an electric direct current (DC), and established the basis for the magnetic field concept in physics. He discovered electromagnetic induction, diamagnetism, and laws of electrolysis. In his scientific studies Faraday was consciously seeking to understand the beauty, symmetry, and organization of creation. His inventions of electromagnetic rotary devices formed the foundation of electric motor technology, and it was largely due to his efforts that electricity became practical for use in technology.



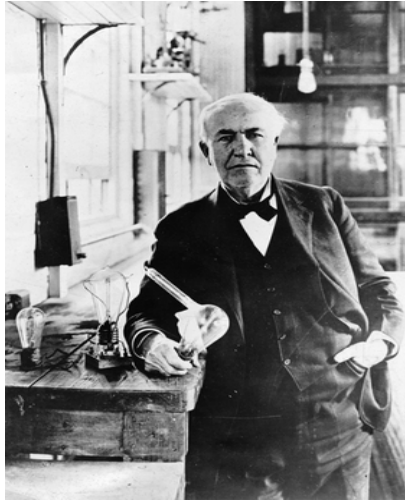
Faraday Homopolar Generator

Faraday Homopolar Generator

Michael Faraday did an experiment on December 26th, 1831, in which he co-rotated a magnet with a copper disk and measured a current output. Even though he had done that experiment, his own law of induction tended to ignore that fact, meaning he didn't know that he had generated a current having rotated both the copper disc and the magnet. He wasn't expecting that. Known for over 150 years, the operation of Faraday's homopolar current generation cannot be properly explained.

The world later embraced Faraday's two piece induction generator (like a DC motor in reverse with commutators), whose drawbacks include mechanical friction and electrical losses. Commutators are

mechanical switches on the shaft and stator piece of an electric DC motor. When the rotor spins, it touches and connects and disconnects from the stator which controls the on and off of the current generated.

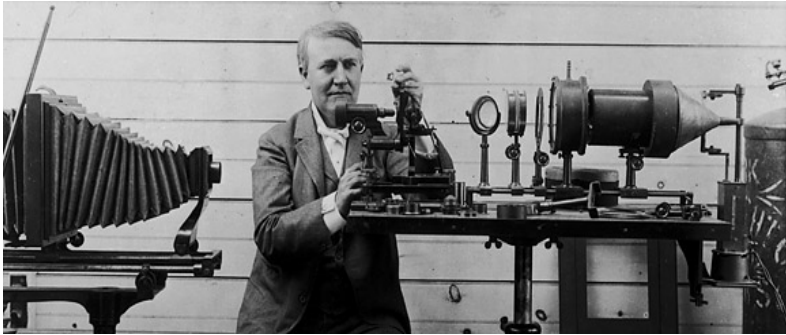


Inventor: Thomas Edison (his laboratory)

Thomas Edison was born February 11, 1847 in Milan, Ohio. At age 15, Edison became a ‘tramp telegrapher,’ sending and receiving messages via Morse code, an electronically-conveyed alphabet using different clicks for each letter. Eventually, he worked for the Union Army as a telegrapher. Edison often entertained himself by taking things apart to see how they worked. Soon after, he decided to become an inventor.

In 1884, after he attained great fame and fortune, and built one of the largest laboratories in the world, he worked extremely hard and registered 1,093 patents. Edison continued to invent or improve

products and make significant contributions to x-ray technology, storage batteries, and motion pictures (movies). There could be a whole discussion on the Edison batteries because this is still used today in the renewable energy industry. His inventions changed the world forever, and still influence the way we live today.

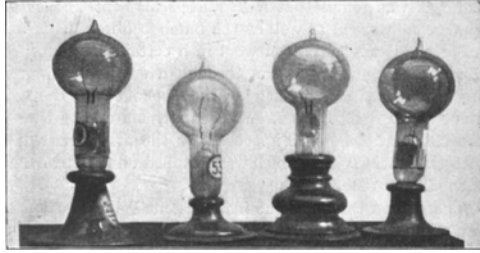


Edison and his inventions

In the late 1800s, DC could not be easily converted to high voltages. As a result, Edison proposed a system of small, local power plants that would power individual neighborhoods or city sections. By 1887, Edison had constructed 121 DC power stations in the United States. His notable inventions include: Incandescent light bulb, phonograph, cement making technology, motion picture camera, DC motors, and electric power.

Edison's Incandescent Lightbulbs

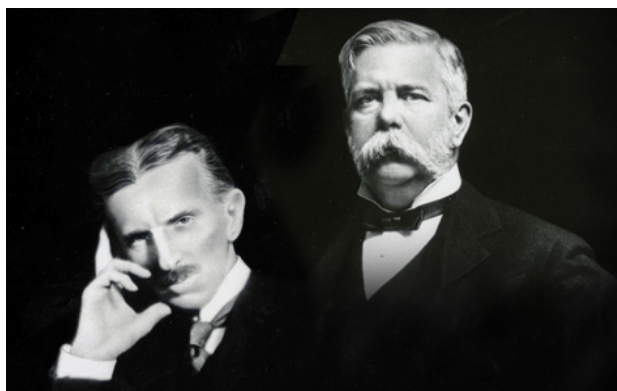


Inventor: Nikola Tesla (in front of a Tesla Secondary Coil)

Nikola Tesla was born in 1856 in what is now known as Croatia. He came to the United States in 1884 and briefly worked with Edison before they parted ways. In 1887, he was able to find interest in his alternating current (AC) electrical system and funding for his new

Tesla Electric Company. By the end of the year, Tesla had successfully filed several patents for AC-based inventions.

Tesla's AC system eventually caught the attention of American engineer and business man George Westinghouse, who was seeking a solution to supplying the nation with long-distance power. There are advantages to AC, including the ability distribute this form of electricity over large distances. You can't do this with DC.

Convinced that Tesla's inventions would help him achieve this, in 1888 he purchased his patents for \$60,000 in cash and stock in the Westinghouse Corporation. In those days Tesla would have been a millionaire.

As interest in an alternating-current system grew, Tesla and Westinghouse were put in direct competition with Thomas Edison. Edison was intent on selling his direct-current system to the nation.

Between the two, a negative smear campaign ensued that was waged by Edison, in an attempt to undermine the interest in AC power. Tesla, for his part, continued in his work and would patent several more inventions during this period, including his 1891 patent of the Tesla coil, which you see a lot of hobbyists doing today for all kinds of things and shows. But it laid the foundation for wireless technologies and is still used in radio technology today. Air-core transformers are an example of a Tesla coil.

Tesla died in New York City on January 7, 1943. His experiments showed that there was a radiant energy field present everywhere, it just needed the right equipment to extract this energy, and sometimes you needed to put energy into a system to make the radiant energy visible. One of the main features of his technology that's still being used today

is the Niagara Falls generators which were originally designed by Tesla. That's just one of the many examples of inventions that were the legacy of Tesla.

"One day man will connect his apparatus to the very wheelwork of the universe... and the very forces that motivate the planets in their orbits and cause them to rotate will rotate his own machinery," -Nikola Tesla

Tesla's Notable inventions: Tesla coil, resonant transformer circuit radio transmitter, fluorescent light, AC motors and electric power generation systems.

The Current War

In 1897 Nikola Tesla was involved in a DC vs. AC ‘current war’ with Thomas Edison. You would have never found two geniuses so spiteful of each other. They worked together and hated each other.

Tesla was financially backed by Westinghouse to promote AC current, and Edison was financially backed by J.P. Morgan to promote DC current. AC current won the war and is still used to this day. While Tesla’s AC current was only one of his many inventions, his true passion was to bring a source of energy to the world that would be freely available to everyone. However, J.P. Morgan told Tesla “If I can’t put a meter on it, it will never happen!”

From that day forward, many of Tesla’s inventions, which were nonpolluting and worked according to the laws of nature, intended for the benefit of humanity, would be stolen, suppressed, marginalized and removed from the public eye due to the financial interests of banking families such as J.P. Morgan and Rockefeller. Many of the inventions we all use today would not exist if it wasn’t for Tesla’s work. Many,

such as Edison and Marconi, have stolen Tesla's work, and taken the credit.

During the current war, DC towers were used to power everything, and it was all put up by Edison. There are stories about how horses from carriages were getting shocked and electrified as they were running in the streets because of the metal in their shoes. There were also fires breaking out everywhere. While electricity was an exciting new and modern thing to have in the home, it still was a very dangerous electrical system.

Edison would electrify animals in gruesome public events in an attempt to smear Tesla's work and convince the public that Tesla's system was dangerous. This was all entirely new ground. It was the Wild West and even Edison, had some fires with his Edison batteries and his laboratories were burnt to the ground. So it was dirty then. And that was just the environment, everyone played rough. When compared to some of the modern day stories around energy suppression it would appear that not much has changed in 130 years.

The current war sequence of events

AC / DC

DC, or direct current, is the flow of electricity in one direction only. The system operates at the same voltage level throughout and is not as efficient for high-voltage, long distance transmission. Direct current runs through battery powered devices, fuel and solar cells, and light emitting diodes.

AC or alternating current is when an electric charge periodically reverses direction and is transmitted to customers by a transformer that could handle much higher voltages. Alternating current runs through car motors, radio signals, and appliances.

He said, He said

Thomas Edison said about Tesla: “Tesla’s ideas are splendid, but they are utterly impractical.”

Nikola Tesla said about Edison: “If Edison had a needle to find in a haystack, he would proceed at once... until he found the object of his search. I was a sorry witness of such doings, knowing that a little theory and calculation would have saved him 90 percent of his labor.”

The Falling Out

Edison promised Tesla a generous reward if he could smooth out his direct current system. The young engineer took on the assignment and ended up saving Edison more than \$100,000 (millions of dollars by today’s standards). When Tesla asked for his rightful compensation,

Edison declined to pay him. Tesla resigned shortly after, and the elder inventor spent the rest of his life campaigning to discredit his counterpart.

Edison Fries an Elephant

In order to prove the dangers of Tesla's alternating current, Thomas Edison staged a highly-publicized electrocution of the three-ton elephant known as Topsy. She died instantly after being shocked with a 6,600-volt AC charge.

War of Currents officially settled

In 2007, Con Edison ended 125 years of direct current electricity service that began when Thomas Edison opened his power station in 1882. It changed to only provide alternating current. That's a long time

to waste power!

Nobel Prize Controversy

In 1915, both Edison and Tesla were to receive Nobel Prizes for their strides in physics, but ultimately, neither won. It is rumored to have been caused by their animosity towards each other and refusal to share the coveted award.

Tesla Spoke to Aliens

In 1900 Tesla announced that he had detected intelligent signals from outer space. Timed pulses coming as1,...2,...3. He referred to these as 'counting codes.' Having just detected cosmic radio signals for the first time, Tesla believed them to be attempted communication from aliens on either Mars or Venus.

In this letter, Tesla wrote to the American Red Cross:

"The retrospect is glorious, the prospect is inspiring: Much might be said of both. But one idea dominates my mind. This — my best, my dearest — is for your noble cause.

I have observed electrical actions, which have appeared inexplicable. Faint and uncertain though they were, they have given me a deep conviction and foreknowledge, that ere long all human beings on this globe, as one, will turn their eyes to the firmament above, with feelings of love and reverence, thrilled by the glad news: "Brethren! We have a message from another world, unknown and remote. It reads: one... two... three..."

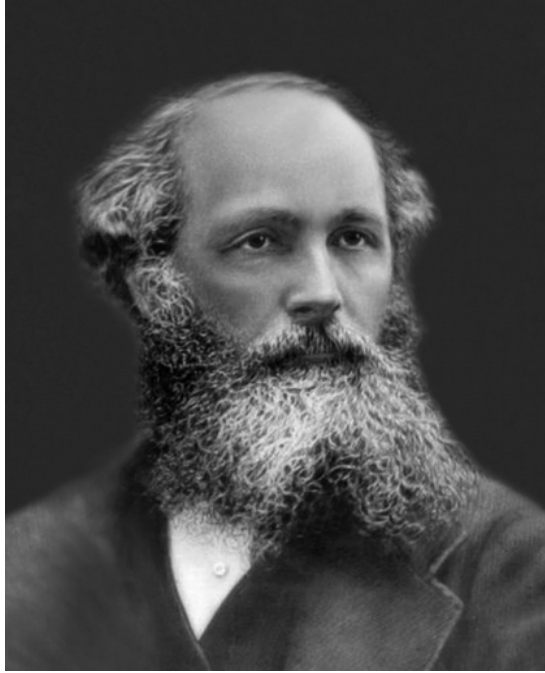
The retrospect is glorious, the prospect is inspiring: much might be said of both. But one idea dominates my mind. This - my best, my dearest - is for your noble cause.

James Clerk Maxwell

James Clerk Maxwell FRS FRSE (1831–1879) was a Scottish mathematical physicist. His most prominent achievement was to formulate a set of equations that describe electricity, magnetism and optics as manifestations of the same phenomenon, namely the electromagnetic field. His discoveries helped usher in the era of modern physics, laying the foundation for such fields as special relativity and quantum mechanics.

Asymmetrical and Symmetrical Systems

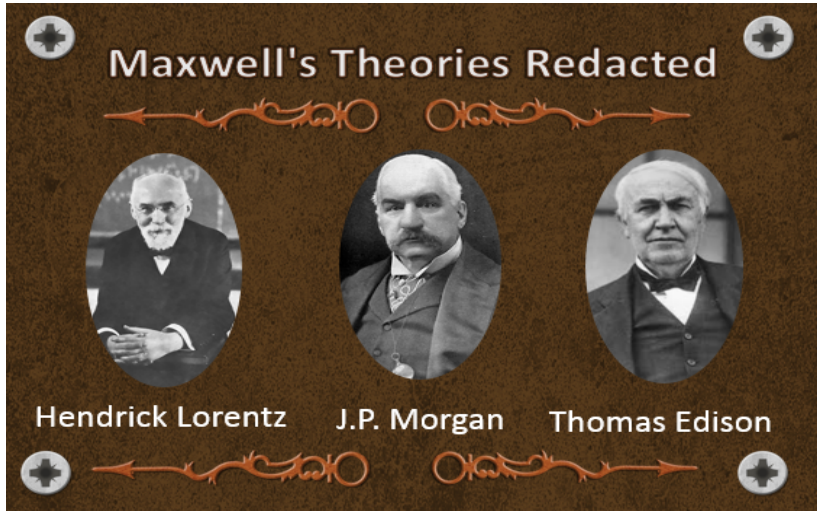
The Laws of Physics are indeed the Laws of Physics. However, they are not complete. Did you know that fifty percent of them have been redacted?

In his ORIGINAL work: 'The Dynamical Theory of the Electromagnetic Field', Maxwell identified two separate systems, both of which were completely different from each other:

1) **Asymmetrical system** - an 'open' system (solar panels, wind, those types of things) that allows the creation of a series of exchange of energy reaction to our inputs, based on electromagnetic resonance or electromagnetic feedback in every spin (on a motor), or in every pulse of input in a static coil. One of the first asymmetrical motors was Faraday's 'Unipolar Motor,' later modified by Nikola Tesla. These systems generate their own energy and do not require fossil fuels.

2) **Symmetrical system** – a 'closed' system that cancels the electromagnetic resonance with every spin, which creates wasted energy in the form of excess heat, and requires an additional energy source to run, such as fossil fuels. These are the symmetrical obsolete systems we use every day in all of our electrical appliances.

Solar panels and wind power are examples of open systems. These systems have been available, but we've been using outdated and wasteful closed systems. Closed systems were built so that it would require fossil fuels to run, thus controlling the supply of power.



Laws of Physics

Today in your high schools, in your colleges, in your universities, Maxwell's brilliant equations were truncated and assumed complete for those equations. These equations were now meant for systems that you can put a box around as a closed system, which is the framework of the fundamental laws of thermodynamics.

While the laws of physics do indeed apply to symmetrical closed systems of energy, there is another set of laws called The Laws of Nature, which apply to the asymmetrical systems that have been suppressed by the financial interests of the banking families for the last 130 years.

This knowledge was banned from our educational system, and no physics or electrical engineering school on our planet would ever teach

about asymmetrical systems. Rather, the first and second laws of thermodynamics, which depend on the consumption of profitable fossil fuels, continues to prevail in our public education.

Currently, the laws of physics only apply to symmetrical systems (closed systems) and are therefore incomplete. Fifty percent of them (those that apply to free energy) were removed from our public teachings by JP Morgan and Thomas Edison. This is why you will never learn about this in engineering school. The missing 50% of Maxwell's theories apply to free energy concepts and explains how free energy works.



The Laws of Nature

Why do we have to waste and consume energy if it is freely available around us in nature? The conventional laws of physics tell us that perpetual motion is not possible. Yet, how does the earth rotate? The Laws of Aerodynamics tell us that bumble bees are incapable of flying. Yet how do they fly?



How does the earth perpetually rotate?

Conventional scientists from all over the world will make statements such as: “The claim that this is going to run permanently or indefinitely doesn't seem to hold because the second law of thermodynamics tells us that this is not possible”

Around the turn-of-the-century eminent British scientist Lord Kelvin said “Radio has no future, heavier-than-air flying machines are impossible, and x-rays are a hoax” - so much for conventional science!

The laws of nature contain concepts that focus on frequency, resonance, vibration, magnetism and energy. A perfect example of this can be found in the aerodynamics-law-breaking flight of the bumblebee.



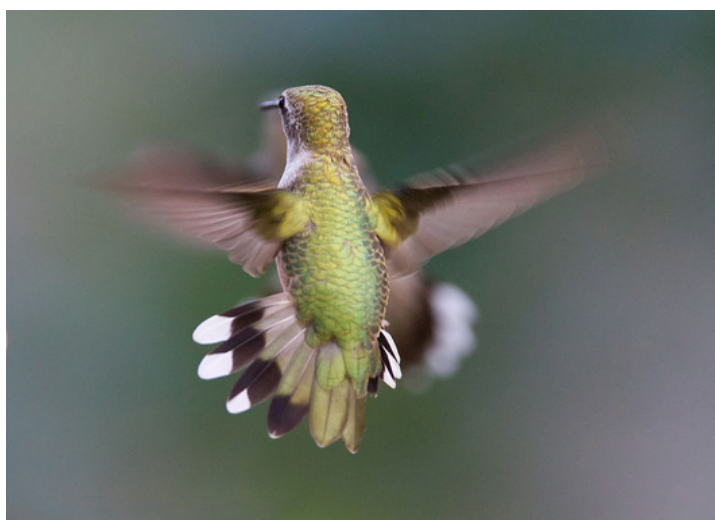
Flight of the bumblebee

Ralph Ring is an innovative technician who worked with Otis T. Carr, a direct apprentice of Nikola Tesla. In his presentation at the Breakthrough Energy Movement Conference, (below) Mr. Ring gives an amazing explanation of the flight of the bumblebee:

"Next to the larynx in the bumblebee's throat, there is a tiny hollow tube that acts as a resonance cavity that accumulates frequency. When the bee starts beating its wings, it does this to accumulate frequency which bounces back and forth in the resonator cavity until it reaches the same frequency of the earth, known as the Schumann frequency. Once the bee reaches the same frequency as its surroundings it evens out into what is known as zero point. When anything reaches zero point you can then change the energy. The bee is now free from the gravitational influence around it, creates its own little magnetic bubble

and hovers around. There are some lizards and hummingbirds that do the same thing.

And if you see the way a bee flies and the way a hummingbird fly it's almost magical. It doesn't sit there and exert tons of energy. The only reason why it's beating its wings is to make something vibrate inside to change the magnetic field around it so that it can hover.



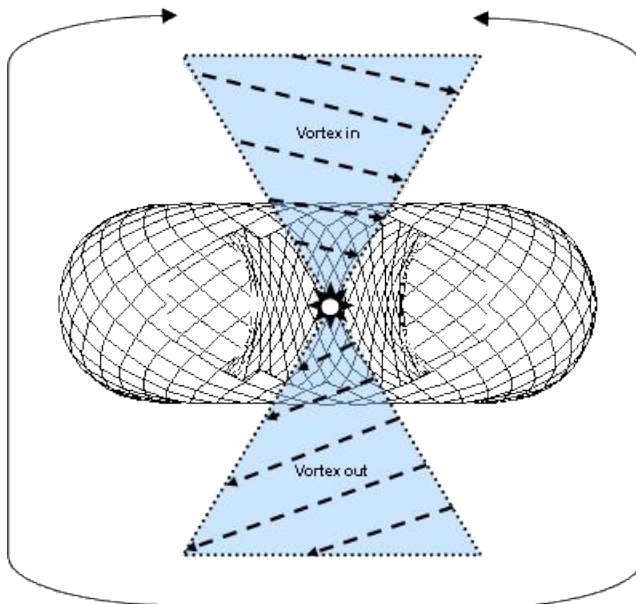
When you can tune something to vibrate at the same frequency as the earth and reach zero point, you are freed from the frequency influence of your environment and can then change the energy into anything you want, including levitation, or electrical energy.“

Zero Point Energy

Also known as ground state energy, zero point energy is the lowest

possible energy that a quantum mechanical system may have. It is the energy of the system's ground state. All quantum mechanical systems undergo fluctuations even in their ground state and have an associated zero-point energy, a consequence of their wave-like nature.

The concept of zero-point energy was developed in Germany by Albert Einstein and Otto Stern in 1913, using a formula developed by Max Planck in 1900. The term zero-point energy originates from the German Nullpunktsenergie. Vacuum energy is the zero-point energy of all the fields in space.



Patents and Solutions



The Patent Trap

A patent is a temporary government-granted monopoly right on something made by an inventor. This monopoly period usually lasts about 20 years. While there are many types of patents, the most well-known type is the utility patent, which protects inventions. There are also design patents, and plant patents such as those utilized by Monsanto.

Historical Purposes of Patents

The historical purpose of the patent system was to encourage the development of new inventions by helping inventors feel that they had some protection from theft of their invention. Inventors are often

hesitant to reveal the details of their invention, for fear that someone else might copy it. This leads to keeping inventions secret and impedes innovation.

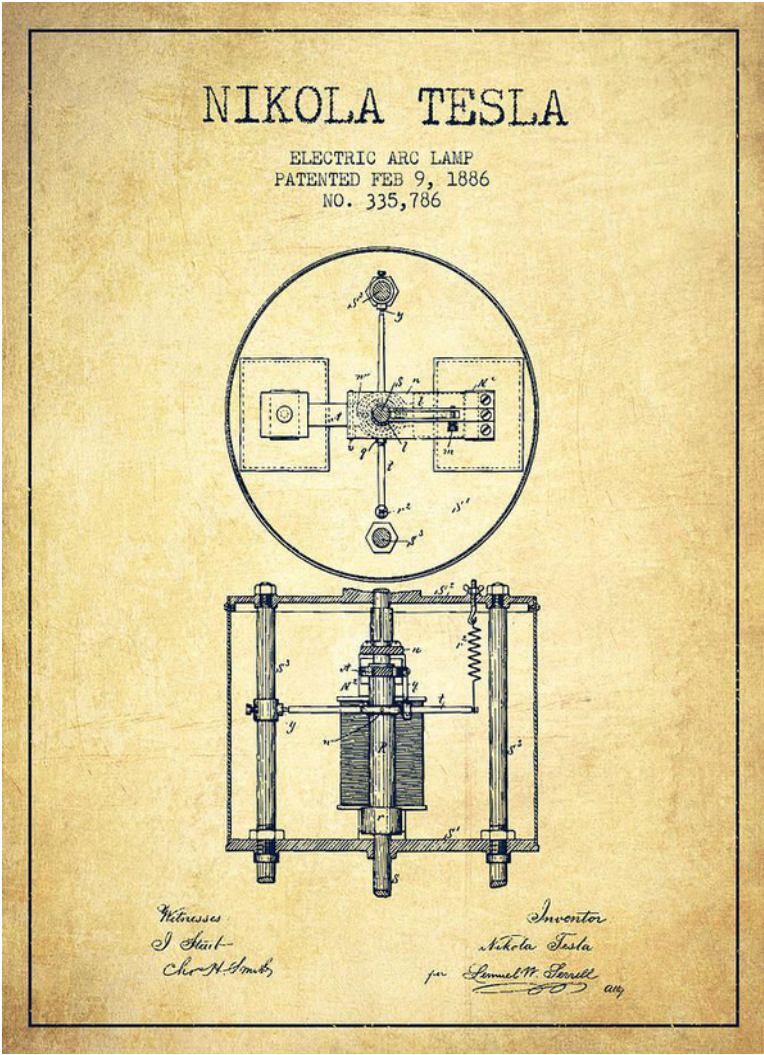


1924 photo of the US Patent Office

A patent was meant to alleviate this fear and was intended to allow others to copy the invention after a 20 year time period had passed. This would also allow the inventor to recoup the investments he made during the development of his invention. It was also intended that after the patent was put into the public domain, this would allow for others to add improvements and innovations to the original design.

Applying for patents can be very expensive, especially when doing so in multiple countries. This is usually something that only large companies can afford. Small inventors will often only apply for

patents in their own country. In many cases, the patent office process can take up for several years. As a workaround, many small inventors use ‘patent pending’ on their products. However, this is a loophole option which may not be as effective in the future as it was in the past.

The difference between a patent and copyright

A copyright protects an individual expression of an idea and does not protect against independent re-development of that idea as patents do. A copyright lasts for 75 years after the death of the copyright owner.

The problems with the modern-day patent system

This is probably one of the least known, misunderstood things that an inventor can come up against when applying for patents. The general thinking is, if you had a free energy device that works, you would get both a billion dollars and the patent. There are many stories that talk about how an inventor discovered something promising and then they suddenly disappear. The problem is that the patent system has been changed to create a trap that confiscates inventions, and forbids inventors from further developing. There are over 5,000 patents censored that have to do with ‘free energy’ devices.





US Patent and Trademark Office Today

The U.S. Patent Office classification system

The U.S. Patent Office has a nine-member committee that screens patents in order to protect ‘national security.’ Another purpose of this committee is to find and remove from public access, energy-related patents which could threaten the fossil fuel and power monopolies. Anytime someone applies for a patent, it goes through this screening process. If the device has anything to do with the production of free energy they classify it, confiscate it, conceal it in a vault and forbid the inventor to reproduce it.

Secrecy orders

The inventor will then receive the following Secrecy Order Notice:

SECRECY ORDER

(Title 35, United States Code (1952), sections 181-188)

NOTICE: To the applicant above named, his heirs, and any and all of his assignees, attorneys and agents, hereinafter designated principals:

You are hereby notified that your application as above identified has been found to contain subject matter, the unauthorized disclosure of which might be detrimental to the national security, and you are ordered in nowise to publish or disclose the invention or any material information with respect thereto, including hitherto unpublished details of the subject matter of said application, in any way to any person not cognizant of the invention prior to the date of the order, including any employee of the principals, but to keep the same secret except by written consent first obtained of the Commissioner of Patents, under the penalties of 35 U.S.C. (1952) 182, 186.

Any other application already filed or hereafter filed which contains any significant part of the subject matter of the above identified application falls within the scope of this order. If such other application does not stand under a security order, it and the common subject matter should be brought to the attention of the Security Group, Licensing and Review, Patent Office.

If, prior to the issuance of the secrecy order, any significant part of

the subject matter has been revealed to any person, the principals shall promptly inform such person of the secrecy order and the penalties for improper disclosure. However, if such part of the subject matter was disclosed to any person in a foreign country or foreign national in the U.S., the principals shall not inform such person of the secrecy order, but instead shall promptly furnish to the Commissioner of Patents the following information to the extent not already furnished: date of disclosure; name and address of the disclosee; identification of such part; and any authorization by a U.S. government agency to export such part. If the subject matter is included in any foreign patent application, or patent, this should be identified. The principals shall comply with any related instructions of the Commissioner.

This order should not be construed in any way to mean that the Government has adopted or contemplates adoption of the alleged invention disclosed in this application; nor is it any indication of the value of such invention.

If an inventor proceeds with their invention, after getting this notice, they can face up to 20 years in federal prison.

In the documentary film titled, A Machine to Die For; The Quest For Free Energy, an ex-secret service agent assigned to electronic intelligence (whose identity was concealed in the film) made the following statement:

“If you’re an idiot and try to go and patent your device, you’ve given them all your information on where you are and how to find you, and they will try to find some legal mechanism to close you down.”

The Invention Secrecy Act of 1951

The Invention Secrecy Act of 1951 is a body of United States federal law designed to prevent disclosure of new inventions and technologies that, in the opinion of selected federal agencies, present a possible threat to the national security of the United States.

The U.S. government has long sought to control the release of new technologies that might threaten the national defense and economic stability of the country. During World War I, Congress authorized the United States Patent and Trademark Office to classify certain defense-related patents. This initial effort lasted only for the duration of that war, but was re-imposed in October 1941 in anticipation of the U.S. entry into World War II. Patent secrecy orders were initially intended to remain effective for two years, beginning on July 1, 1940, but were later extended for the duration of the war.

Then 10 years later, the Invention Secrecy Act of 1951 made such patent secrecy permanent. A secrecy order stops the award of a patent, restricts the filing of foreign patents, orders that the invention be kept secret, and specifies procedures necessary for the inventor to take in order to prevent disclosure of ideas contained in the patent application. The only way an inventor can avoid the risk of such imposed secrecy

is to forgo patent protection.

Over 5,000 patents censored

By 1991, there were 6,193 patent secrecy orders issued, mostly on private citizens and independent inventors. As the orders need to be renewed on a yearly basis the number of orders has shrunk over the years. As of today, there are still over 5,000 patents censored.

Main Stream and Government Funded Labs, Research & Education

In today's society, the typical training for an engineer follows some certain systematic criteria. Many institutions have a specific budget to

do research and pay for equipment. In schools, an engineer in-training will learn how to do proper measurements, how to properly collect data, and see how it correlates to any kind of expected outcome. In cases of errors, usually you have what you need to fix a problem.

Most of the main stream scientific research and higher education systems today are funded by government grants and corporate interests. Such funding comes with a set of rules and regulations that must be followed in order to continue to receive that funding, even if the rules are unreasonable.

If someone in the command chain makes a decision not to teach a certain topic, that topic is omitted from the body of knowledge. If someone objects, and wants to push forward and teach the topic, then

that department might lose its funding. This reality behind curriculum is rarely if ever discussed. Instead, it is assumed that the body of knowledge is incorrect or doesn't exist. In some cases, (as will be discussed later in this book) what is considered to be science has been decided by a vote.

Examples of Government Funded Research Scenarios:

Harold Ashburton (degree in engineering from Cambridge University) is the retired head of IBM's European patent division. When presented with undeniable proof of a perpetual motion machine designed by John Searl he made the following statement:

“The government doesn't know about this work because the government only knows what their advisers tell them. Their advisers get money from the government and they want to keep getting the grants so they're not giving the advice they should from matters like this.”

Ralph Ring was a laboratory technician in a government-funded research and development laboratory in Costa Mesa, California. His job was to fire an electron through a magnetic field without deflection, and to do it the way they told him to do it. He was employed to repeat this experiment every day, which always failed, at a cost of \$10,000 per day paid for by a government grant. He went home and replicated the experiment using the laws of nature, and the experiment was successful. The next day he took his results to the head of the

Department of Advanced Kinetics, Dr. Weinhart, who gave the following response:

“I see what you're doing there and I do understand, but Ralph what you don't understand is that this is a government-funded lab, and we are paid to look for answers, but not find them. Just go back to work and don't say anything to the engineers. This is not to be talked about at all.”

MIT graduates cannot power a light bulb with a battery

If you understand some basic fundamental principles in electricity you can take a battery and a wire and a little light bulb and you can get all three of them to work together to light the lightbulb. Sounds simple right? A recent video done at MIT shows that many of its graduates do not have this basic engineering knowledge.

Harvard and MIT are considered the premier engineering and science institution in the world. On graduation day, students were given a light bulb, a battery, and a wire and asked:

“Do you think you could light a bulb with a battery and a wire?”

Immediately most students said they thought they could do it. Professor Phillip M. Sadler, of Harvard University states “The interesting part about a battery and a bulb question is that people always predict that they can do it. Students say of course I can do that! Teachers say of course my students can do that!”

Then when all students tried and failed to make it work they gave some of the following excuses:

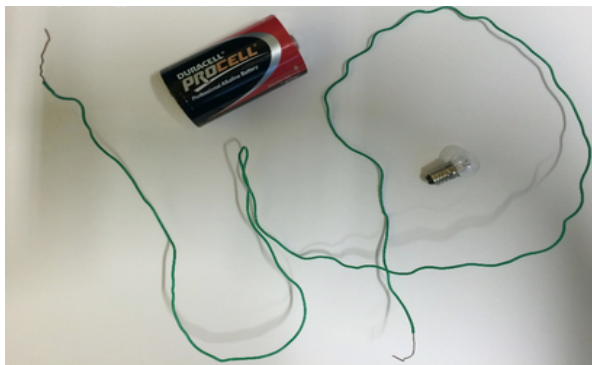
“The battery could be dead, the build could be bad.”

“I am hooking it up totally incorrectly”

“I am not an electrical engineer.”

“If I have to guess I would say it is operator error.”

“You don't have a current in it, you need a full closed circuit.”

Professor Phillip M. Sadler continues to state, “It's only after failing that you begin to get upset with the question and think maybe it's a trick question. Maybe this has something to do with manipulating the wires because they couldn't hold all the wires together. But that's not the case. It goes to the fundamental understanding of electricity. If one cannot light a light bulb with a battery and wire, then everything built upon those basic ideas has problems. We've always assumed that if teachers teach students will learn.” (One of the students was able to do it by the way.)

Jim Carter, Physics Teacher from Saugus, MA states: “You can't assume what is obvious to you and has always been obvious to you is going to be that way to somebody else, especially a kid. And that's where you have to stop, regroup and say wait a second, is this really self-evident as you would like to think it is. Sometimes the simplest problems in science defy intuition and the most basic technology is surprisingly difficult to grasp. Is it because we weren't taught? Or is it because of something deeper? Something about the way we think?”

Grassroots Engineering

Grassroots engineering refers to a collective of independent, do-it-yourself weekend garage tinkerers, self-starting engineers, mechanics and technology enthusiasts. They are the men and women who live next door to you that know how to fix things and build stuff with their hands. They may or may not have a formal education, one thing they all do have is an irrefutable passion for building and experimenting

with electronics and machinery.

Not all engineering in today's world takes place in a large company. With the ability to order parts from websites like eBay, and shop around at home improvement stores, grassroots engineering has taken off in the private garages and workshops of people all over the world.

Opensourcing

If ever there was a solution to the patent trap the answer would be through opensourcing. To opensource something simply means to release it into the public domain and allow other people to recreate it and make improvements on it. Opensourcing inventions is actually quite a new concept, and it has only been in recent years that the first few opensourced technology projects started appearing. This perhaps was a natural response to the suppression experienced from the system.

One of the best ways to understand the benefits of opensourcing is to study its effects in the industry where this concept first appeared; software. Companies like Linux, Oracle and Wordpress are all

opensource software projects that have become very successful. This is because the quality of their products is superior to those under patents. For example, Wordpress is one of the best software programs for building websites today because so many intelligent minds have the freedom to develop new features for it, so it is continuously evolving and improving.

A common misconception about opensourcing is that just because the rights to it are made free to the public, this means that the developers will not make any money off of their invention. This is not true. The companies listed above have grown healthy profitable businesses from opensourced products through alternative income generating activities, such as service contracts.

In the case of an opensourced technology device, there are plenty of opportunities to create healthy profitable business structures through manufacturing, servicing and training.

Co-development

To co-develop something means to develop it jointly with others. A co-development business model occurs when a group of people working on a project have development partnerships with other groups working on a common or same project. When an intellectual property (IP) is opensourced and several different groups and individuals then work on the same IP to contribute innovations and improvements to it in a collaborative manner, this is considered co-development. An example of this are the numerous designers that develop plugins for use with Wordpress. Each is contributing their own skillset and innovations towards a common project while still maintaining their own independence.

Opensourcing and co-developing hardware inventions is still new. The favored method is to have independent labs and workshops that share information is shared across a common connecting platform, such as a website.

Cyberlabs

Cyberlabs are video conferencing platforms where two or more independent workshops/labs communicate and demonstrate their technology together via the internet in video conferencing meetings.

Hackerspaces (also known as maker spaces) are physical locations where different developers can go to use shared equipment to develop their technology. They either are open to the public or in some cases,

require membership fees. Hackerspaces are common in technological industrial hubs like China, but are also growing in popularity in parts of the western world.

We are in a transition within our whole society in the way we do business, the way we create new devices, and machines. This is a big transition, and we're getting away from corporate control. Local, smaller grassroots movements around technology will play a major role in the devices and quality of life for future generations.

Energy Industry Suppression

Energy Industry Coverup

Why, oh why would anyone want to cover up cheap energy sources? How can it be covered up? Surely it's just a tinfoil-hat-crazy-nutty crazy whack-job conspiracy theory? Right?

To understand the bigger picture let's take a look at the energy industry as a whole. Defined by mainstream standards, the energy industry is the totality of all of the industries involved in the production and sale of energy, including fuel extraction, manufacturing, refining and distribution. Our society consumes large amounts of fuel, and the energy industry is a crucial part of the infrastructure and maintenance of society in almost all countries.

Energy Industry Segments

The energy industry is broken up into the following segments:

Petroleum: oil companies, refiners, fuel transport and end-user sales at gas stations

Gas: natural gas extraction, coal gas manufacturing, distribution and sales.

Electrical power: electricity generation, distribution and sales

Coal

Nuclear power

Renewable energy: alternative energy, sustainable energy companies, hydroelectric, wind and solar power, and the manufacturing and sale of alternative fuels.



Fossil Fuel Refinery

All of these companies represent a 600 trillion dollar piggy bank that is controlled by the world's elite, above every other industry on the planet. Oil, gas, coal mining, and prospecting are huge, expensive operations that bring huge profit. So the vested interests are enormous.

Everyone needs energy, even the governments of the world. Even medium to large scale use of more conventional technology, such as the basic electric car running on conventional battery technology, seems to have been terminated as early as possible. They came out with the electric car and then they killed it because it was going to threaten the economy and the energy industry. Then then the Tesla car came out along with a battery for your house, which is innovative but they've made the pricing prohibitive so that they would not disrupt the energy industry. Plus, the batteries in those cars need to be changed due to planned obsolescence every few years at a price of \$8,000 per battery.

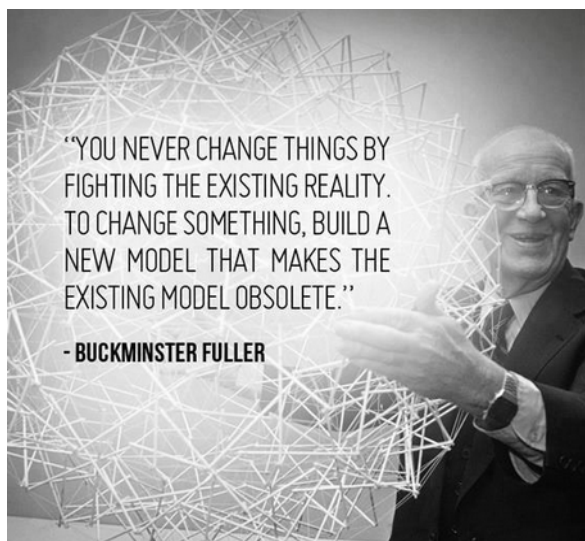


Tesla Battery Powered Cars

The amount of money that the oil industry brings in means that anything that might have a chance or a possibility of a threatening that income is considered a serious threat and is dealt with.

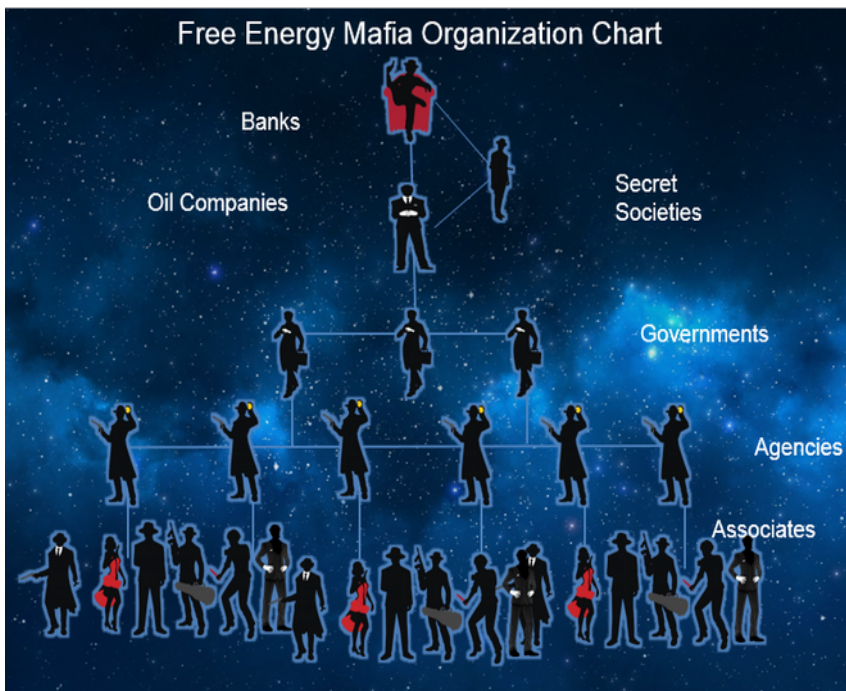
80 percent of every dollar is spent on energy

In addition to this, the price of fuel makes up the price structure of every product and service we consume. When calculating this cost, the price of energy makes up 80% of every dollar we spend. Energy prices underpin the entire structure of a society's economy. If suddenly individual people had free power and got back 80% of their income required for energy costs, it would change the paradigm of the world we live in, and in many ways could collapse our society if it happened too quickly. For this reason, new innovations are planned to roll out slowly to help ease the shock. This is a long time battle that has been raging for decades, that will hopefully come to an end one day as the old systems are made obsolete.



Energy Mafia

Free energy technology has been around for a long time. While it does exist, it's had to stay hidden because it has been under a system of 'organized control' by an energy mafia. The purpose of this mafia is to keep new technologies from disrupting the power structure of the standing energy industry. Over the years inventors have been murdered, stolen from and harassed on a level that is dirty and highly illegal. A pattern has emerged over the last few decades that we will attempt to illustrate here in this free energy mafia organization chart.

At the very top is the bank or the banking families, that control the oil companies, and the major energy industries. In between are the secret societies that can act like liaisons to bridge the world of finance and energy. Below them are the governments who control all the agencies that enforce all the different laws of regulations in order to keep this structure in place.

Then there are all those people down at the bottom of the chart, these would be the associates. These are the ones doing the dirty work. They stop devices by throwing a wrench in the machine and a fly in the ointment, interfering with some of these projects.

Lots of different tactics are used, all part of the psychological warfare state segments of our society have become (which we'll go into in much more detail later in this book).

Energy Suppression Tactics

There are patterns of the tactics that are used to suppress energy alternatives, and we will divide them out here in what we call 'Free Energy Archetypes.' These are just a few of the common personalities that an inventor might come up against in the free energy arena.



The “Touchy Feely’s” are self-appointed experts who want to come to your lab to touch and feel your device. If admission to your lab is denied they accuse it as being a scam. This is a problem because with most DIY inventors, their lab is their home. So you got these self-proclaimed ‘experts’, saying I want to come and touch and feel your device.



Unicorn Boys are wide eyed young rookies with an overly unrealistic optimistic attitude, and a gift for making speeches about changing the world. They make assumptions that this is somehow easy and that this is ‘already done.’ They are normally extremely charismatic.



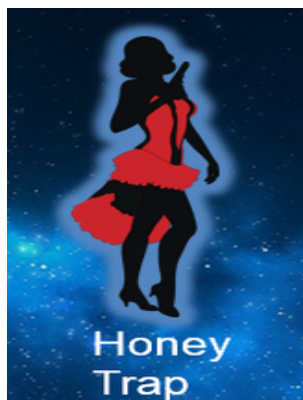
The Blunder Boys are clueless businessmen who capitalize on someone else's device, aggressively compete with the original inventor, only to come back to the inventor asking for help when they realize they lack the skills.



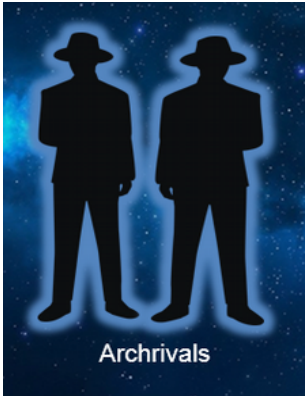
Dust Bunnies are wealthy people with fully equipped labs, and lots of devices that they choose to ignore, letting them collect dust. This is incredibly frustrating for inventors who are struggling to get what they need while dust bunnies have it all, but choose not utilize it.



The Agents of Omission, are people that omit known information that's needed to accurately complete a device to fulfill a personal agenda.



Honey Traps refer to using sexual advances and blackmail to manipulate the outcome of a free energy project. This happens very often, especially at energy gatherings and conferences.



Archrivals are two feuding public spokespersons in the field. They are usually bloggers or public figures. The purpose is to create a shredding mill that will obliterate any new invention by discrediting them in a chaotic sea of unnecessary, very public drama.

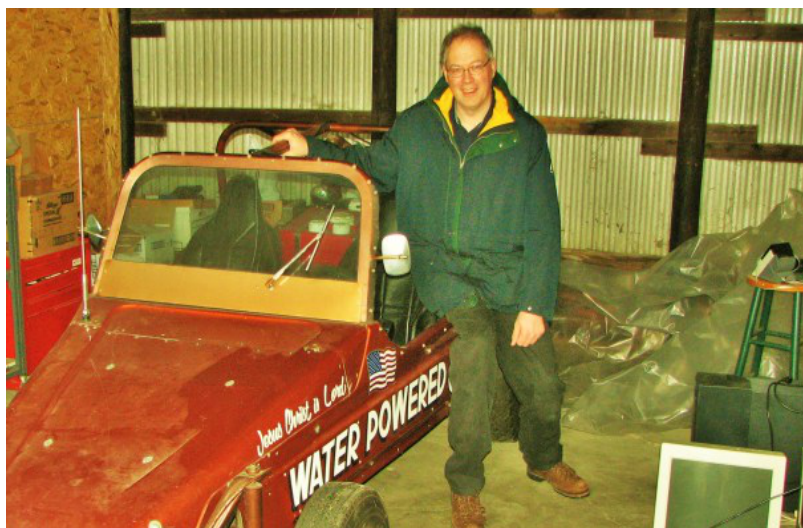
While these tactics can indeed be dangerous and harmful, the most dangerous outcome is the loss of one's life due to foul play. Below are some of the most prominent examples of inventors in the field who have left this world early and will be sorely missed.

Deaths Related to Free Energy Research

- Wilhelm Reich – Nov 3rd 1957 – Found dead in his prison cell
- Bruce De Palma – 1997 – death blamed on poor health and substance abuse
- Stan Meyer - March 21, 1998 - poisoned
- Dr Eugene Mallove - Murdered 17th May 2004 – apparently in a burglary which got discovered.
- James Black - On August 1, 2003 - (1988 Nobel Laureate for

Medicine). He attempted to sue US/Canadian Govt's over their actions against John Hutchison's research - was found on his bed in his apartment. The autopsy described it as a natural death, a 'possible heart attack.' At the time of his death, he was 51 years old (born November 25, 1951), in perfect health, and had never had any heart problems.

- Arie M. DeGeus - Nov. 11, 2007 - inventor of a revolutionary, self-powering battery, of AMDG Scientific Corp was found slumped in his car, totally unresponsive, in the long-term parking lot of the Charlotte Airport.
- Michael Zebuhr – March 19, 2006 – nephew of William Zebuhr who worked with Mallove.



Stanley Meyer and his water powered dune buggy

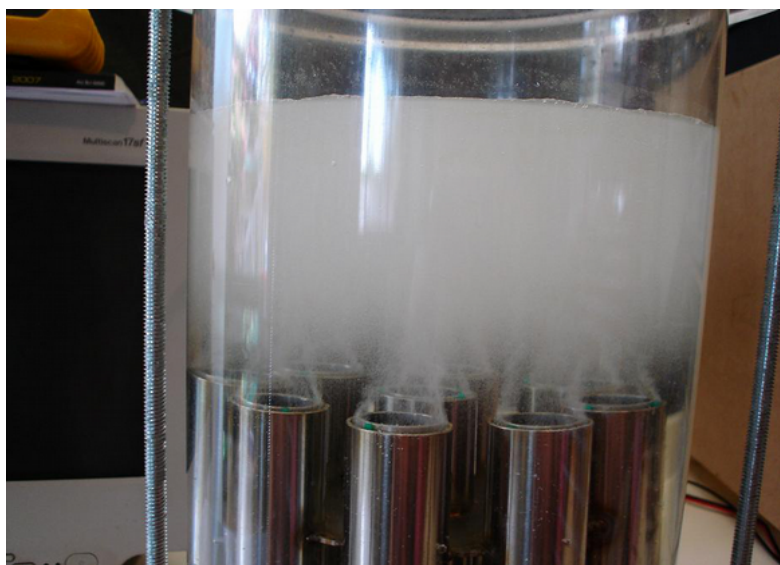
Stanley Meyer and Cars that Run on Water

Stanley Meyer was a former NASA employee and independent inventor who designed and built a motor that ran completely on water. He is pictured here with his dune buggy that ran on water. His technology would have ended our dependence on fossil fuels. His car was recorded many times on film and television, and Meyer was recognized by national and international organizations, and elected inventor of the year in *'Who's Who of America,'* 1993.

The military wanted to use his technology in tanks and jeeps. He was also offered a billion dollars from an Arab to stop his invention, but he declined the offer.

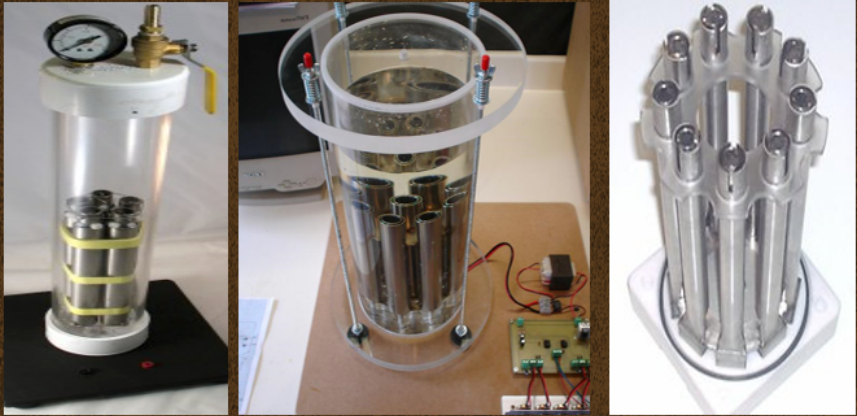
Water Fuel Cells

Meyers' fuel cell split water into its component elements, hydrogen and oxygen. The hydrogen gas was then burned to generate energy, a process that reconstituted the water molecules. The device required less energy to perform electrolysis than the minimum energy requirement predicted or measured by conventional science. The mechanism of action involved a mixture of oxyhydrogen with a ratio of 2:1, the same composition as liquid water which would then be mixed with ambient air. This process yields hydrogen which can then be burned to produce energy. The energy released in the burning of the hydrogen seems to be greater than that used to produce it, so something about Stanley Meyer's circuitry yielded an efficient way of creating electrolysis.

The hydrogen can be produced on demand, meaning that if you had a tank of water stored within your car, that's the safest way of storing hydrogen. This is not a giant tank full of compressed hydrogen to store, which can be dangerous. This water is ideal if you found an efficient way of turning that water into hydrogen and oxygen.

Here are some excerpts from a film '*It Runs on Water*' from 1997 where we hear Stanley Meyer talking about his invention:

Stan Meyer: Well it was during the oil embargo of the United States, it alarmed me that a little country over in the Far East could actually cripple the United States. And realizing that the entire industrial base of the United States and the world is based on this supply and

utilization of energy, it became imperative that we must try to bring in an alternative fuel source and do it very quickly. Of course, I thought originally with the right type of funding, that we could possibly get it in within six months but reality shows that 12 to 15 years was more correct in this projection.

Stan Meyer: Mostly... you have to be a loner. You have to be somewhat thick-skinned and don't rely on other people to support you because they will not. More times than not an invention is stolen from the inventor. Even in my development of high technology, I've had patents taken from me. I learned from the school of hard knocks to be very cautious.

Narrator: Meyer has always stood out against the crowd. He has no formal qualifications as a scientist because he didn't wait to graduate from high school. Leaving early to go straight into research at the Hyde Park Research Institute ... Now he works full time as a private inventor. He built a device with potentially revolutionary implications. There is nothing startling about a machine that can extract the hydrogen from water. What is highly unusual is that it should do so with ordinary tap water. The conventional method is called electrolysis. Meyer has turned that phrase on its head. Unlike electrolysis, his device doesn't use up large amounts of electric current. What it produced is an enormous waste of heat.

Narrator: For 20 years he has been refining a method to fraction water. It's produced vast amounts of hydrogen on demand. This is not his

latest apparatus. He was unwilling to let us point a camera at that. This is a simple device he used to convince the reluctant patent office that his revolutionary concept actually works. Alloy rods acting as electrodes housed in a ...container with water. Normal main voltages are fed in through a transformer critically the current consumed is less than $\frac{1}{2}$ an amp. The result is dramatic: hydrogen pours off with the flick of a switch. Meyer claims the key is his electronics where he pulses electricity rapidly across the rods up to 20,000 cycles per second. And though it is not readily apparent, this process transforms the equation, and as in conventional electrolysis where 3 times as much energy is consumed as is produced in the form of hydrogen fuel, in Meyer's operation the reverse is true. It appears to produce several hundred percent more energy than it consumes.

Paul Cysz: Stan has something that's characteristic of the people that sound like they have done something to tap zero point energy. He has high frequency, high voltage, and as a combination of the two, something occurs. With ... Russia, he has what he called a self-sustaining discharge. The tube would run by itself. When Stan gets this effect the amount of hydrogen and oxygen emitted off these electrodes is a step function - it almost boils the water. If I did this with standard electrical chemicals I need current, and the water should raise a degree every couple of seconds. With Stan's it would run for a half hour and the water temperature hasn't changed. Something's different.

Narrator: Meyer demonstrates this repeatedly without any difficulty.

And yet on the face of it, represents an extraordinary revolution. As Meyer over the years suggests 1700% greater efficiency than conventional electrolysis, and if he is to be believed, he is getting much better results from his latest still secret invention. But the hydrogen machine was only the first step towards Meyer's ultimate dream. If he gets it right, the application of this technology would change the 21st Century in the same way that the Wright Brothers and Carl Benz transform the 20th. He is currently modifying a beach buggy to run on nothing but water. Doesn't have a petro tank or even a hydrogen container. It has just a tank of water. He's invented a device called a water splitter to replace the spark plug. As the water is injected in the engine, Meyer claims that it's fractured into hydrogen and oxygen and then burned as fuel. Meyer is working on a kit to modify any engine. He hopes to demonstrate on this car within 12 months.

Stanley Meyer: And of course the blessing to the use of the water as a fuel source that on combustion the byproduct is water mist. So we're even solving the environment pollution problem at the same time that we are using water to maintain the industrial bases of the world.

The Murder of Stanley Meyer

After more than 20 years of research and tinkering, Stanley Allen Meyer, his brother and two Belgian investors raised glasses in the Grove City Cracker Barrel on March 20, 1998. Stephen Meyer recalls the events of that evening.

"Stanley took a sip of cranberry juice. Then he grabbed his neck,

bolted out the door, dropped to his knees and vomited violently."

"I ran outside and asked him, 'What's wrong?' " Stephen recalled.

"He said, 'They poisoned me.' That was his dying declaration."

People who knew him say his work drew worldwide attention: mysterious visitors from overseas, government spying and lucrative buyout offers. His death sparked a three-month investigation that consumed and fascinated Grove City police, but in the end, the coroner's report listed the cause of death as a brain aneurysm.

"Meyer's death was laced with all sorts of stories of conspiracy, cloak-and-dagger stories," said Grove City Police Lt. Steve Robinette, lead detective on the case.

If Stephen Meyer was shocked at his twin brother's collapse and death, he was equally amazed at the Belgians' response the next day. "I told them that Stan had died and they never said a word," he recalled, "absolutely nothing, no condolences, no questions. I never, ever had a trust of those two men ever again."

Quote from YouTuber: "With Stanley Meyer and many others it's a similar story. The Pentagon wants to see your idea and tell you how they would like to use your invention. You demonstrate your device proving to them that it works, then they block all of your efforts and end up killing you.

Many now feel that the only way to get a free energy device out to the public is to forget about patents, distribute underground, sell it to enthusiasts with the plans, and encourage them to travel around and created a non-interlinked underground distribution system that will spread to the general populous. When this is done, then it will spread like wild fire and it will be un-stoppable.

Bruce De Palma's N Machine

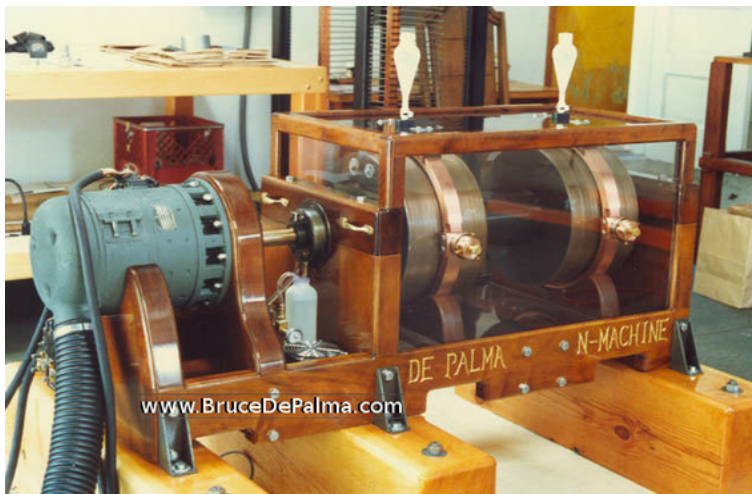
Bruce De Palma studied electrical engineering at Harvard (1958), and taught physics at MIT for fifteen years. He worked under Harold Eugene Edgerton and was employed by Edwin H. Land of Polaroid. He is also the brother of the Hollywood film director "Brian De Palma."

In his study of inertia, he developed a kind of 'Rotating Magnetized Gyroscope' called the N-Machine. In 1977 he made the first prototype of the N Machine, an electrical generator which used rotating magnets

to generate up to five times more power than it takes to drive it. Depalma's device is believed to be a derivation of the Faraday disc (see the section on Faraday and the Homopolar Generator).

The N-Machine is essentially a low voltage, very high amperage dynamo, and has two repelling disc magnets co-rotating with the conductive rotor in between them. This configuration does not suffer from the effects of back EMF.

Depalma's configuration of the magnets are slightly different from the Faraday disc, however. They are facing each other to repel in the middle where the discs and the magnets are spinning.

Depalma quoted, “The perpetual motion N-Machine is only supposed to run itself. It could never put out five times more power than is put into it. Perpetual motion schemes used conventional energy sources, whereas the N-Machine is a new way of extracting energy from space.” So basically he is saying it’s not creating energy to power itself but rather its drawing energy from the environment. It’s an open system.

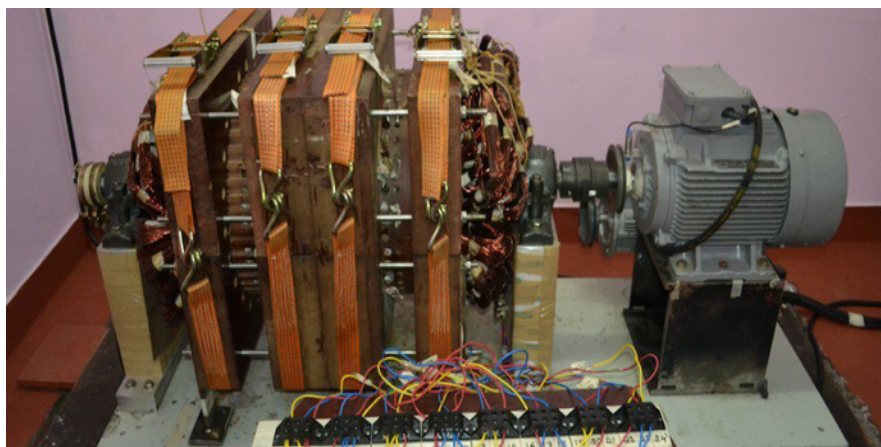
Paramahamsa Tewari

Depalma also worked with Indian physicist Paramahamsa Tewari, who was the director of the nuclear power division that operates all the nuclear power plants in India. The two of them worked together to help Tewari develop his own N-machine.

Tewari has since tested De Palma's device which he calls the Space Power Generator (SPG). He has made several different replications, one of which has 5 kilowatts total power input, and was reported to yield 30 kilowatts output. While the results were deemed to be impressive, there was suspicion among government officials and the power consortiums that backed the project. Tewari was forced to abandon the project completely.



Tewari's replication of the N-Machine

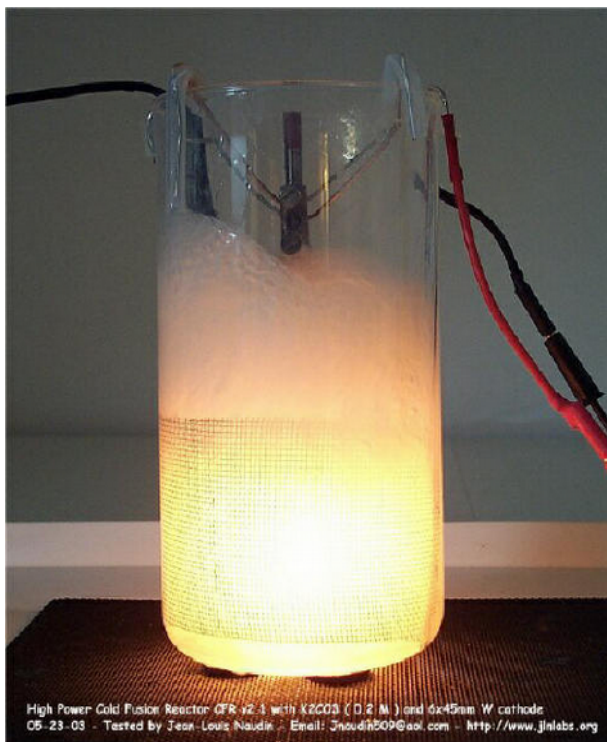
In a documentary film, Bruce Depalma states:

“Right now we have monopolies and cartels. We have OPEC and the Seven Sisters Company that control all the oil and energy. What you need to understand is that the people who run the energy business in this world, which is the biggest business on the planet ... it's bigger than drugs, it's bigger than defense, they control the newspapers, they control the media. These companies are so big that they control the government and the people that are supposed to regulate them.”

Depalma also had a disturbing encounter with Astronaut Edgar J. Mitchell (who recently died and is celebrated as a great American hero). Mitchell founded an institute in southern California that was supposed to develop alternative energy systems by attracting inventors from all over the country. Mitchell made De Palma a paltry offer to buy out the N-Machine invention. When Depalma wouldn't sell it, Mitchell said to him "if Depalma ever tried anything on his own in California, he would get his head blown off." Depalma states "I was scared to death."

The Death of Bruce Depalma

The official statement is that Bruce Depalma died of poor health due to alcohol and substance abuse in 1997. He was in New Zealand working on his most ambitious free energy project ever at the time. While it's uncertain if there was foul play involved, one thing is certain. His death put an end to his most promising work. He was only weeks away from the official testing of a device constructed during 6 months in an Auckland workshop. After his death, the testing commenced and was attended by the project's financial backer Bruce Bornholdt, a prominent Wellington barrister, and the pioneering developer of the Adams motor, Robert Adams (now deceased), who observed the operation of, and measured electrical output from, the N-machine. The claim was that the test demonstrated no over-unity potential of the N-machine (most of the output energy was lost as heat) and the project was abandoned.

Cold Fusion

Cold fusion has become so controversial that we've decided to give several different definitions, both unbiased and biased.

Cold Fusion unbiased definition:

- a hypothetical form of nuclear fusion postulated to occur at relatively low temperatures and pressures, as at room temperature and at one atmosphere.

- a hypothetical method for achieving nuclear fusion at low temperature (i.e. room temperature) –Merriam -Webster Dictionary

Cold Fusion biased definition:

Nuclear fusion occurring at or close to room temperature. Claims for its discovery in 1989 are generally held to have been mistaken.

An example of a biased definition that you might run into if you're trying to do this kind of research is nuclear fusion occurring at or close to room temperature. And then it's followed by claims for its discovery in 1989 which are generally held to have been mistakes. We consider this to be a biased definition because as we are about to discover, this research has continued since 1989 by some very large organizations. It's just been dismissed and kept out of the mainstream.

Stanley Pons and Martin Fleischmann

Stanley Pons and Martin Fleischmann were well-regarded Chemists at the University of Utah. They had worked for 5 years to develop a process which seemed to yield too much energy to be a simple chemical reaction. They stated they had observed evidence of nuclear reactions such as neutron emissions, transmutation, and excess heat. They had a palladium cell with a metallic element, and when they pumped it up full of hydrogen and put it through a circuit, it created excess heat. In 1989 they opted to announced their findings at a press conference. They were criticized for this as they would normally have announced their research in a paper which would be peer reviewed and published in a scientific journal. Called 'cold fusion', it was a somewhat inaccurate description that was coined by a Dr. Steven E 'Thermite' Jones (named because of his thermite hypothesis for why the buildings came down on 911). Cold Fusion should more correctly be called 'Low Energy Nuclear Reactions' (LENR)

Prior to the 1989 announcement, Steven E. Jones, physics professor at Brigham Young University, learned of Pons and Fleischmann through an informant of the Department of Energy. In a flagrant example of shameless opportunism, Jones insisted on going public quickly with his comparatively less clear result. Disparaging the excess heat claim of Fleischmann and Pons, Jones' announcement would have effectively prevented the two scientists from patenting their process. A process they had developed on their own over long years of research. On the advice of university attorneys, Pons and Fleischmann felt their

backs were to the wall, and reluctantly delivered their work to public scrutiny.

There's also quite a bit about Steve Jones in (the late) Dr. Eugene Mallove's book about the Cold Fusion cover up, '*Fire From Ice*.' In the year 2000, a documentary called '*Heavy Watergate*' (which is available on Google Video) also mentions Steve Jones. His job seemed to have been to claim that the heat generated from this process could not produce useful work, at least in the field of energy production.

Science by Vote

It was in this moment in 1989 at a Science Press Conference, what is now referred to as 'science by vote,' which voted cold fusion out of existence and destroyed the careers of Pons & Fleischman.

From Stephen E. Jones at the Science Press Conference:

"I don't want to disappoint anyone, I think I'll put my "read my lips" answer here and then I think that will become clear why I am saying that. Can you read my lips back in the back? It says no. Energy is a long way off that's why I say no. This is our result, its way off. I think a door is open to us, but really a door on physics more than on energy. Geophysics in particular could be an interesting area."

Then he calls for a vote and he holds up his hands pressuring the others on the committee to vote with him.

Cold Fusion Today

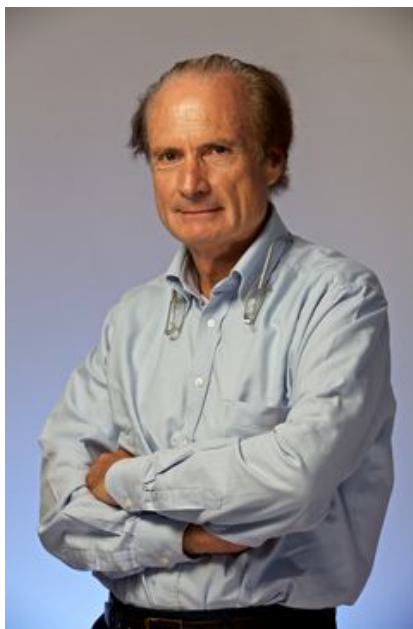
Pons and Fleischmann did move on to do other things, but all the interest in cold fusion publically died off because of what Steven E. Jones did. When you look at the events that happened in 1989 clearly, it seems that the whole affair was managed from start to finish. The goal was to trash and debunk the science, and it seems a whole array of sceptics and debunkers came out to stomp out the fire. It was the first time the phrase ‘pathological science’ was brought into general use. People you would speak to about this topic would say something like “the results have never been reproduced!” which you will find is totally untrue if you do more research.

In these cases, it was difficult to reliably reproduce the conditions under which the reaction will take place, including the research of Toyota and the research in the Navy labs. When they did this research and published their findings, they could only get it three out of five times, but they couldn't get it 100% of the time.

Today the technology has really advanced. Different reproductions have yielded different results. They are identifying common things like excess heat and evidence of a nuclear process, meaning neutrons or tritium is detected. The most important and key factor (and also something that seemed to have appeared on 9/11) is the transmutation of elements. Meaning, they are finding elements on their rods and cathodes after a reaction that were not there before they started.

There is evidence of this type of process taking place during the destruction of the World Trade Center on 9/11.

In summary, cold fusion (LENR) was discovered in the 1980's, then silenced by Steven E. Jones, and has re-emerged under the radar in multiple successful experiments around the world. The most prominent recent example is that of Andrea Rossi and his E-cat technology.



Andrea Rossi

Andrea Rossi

Andrea Rossi was born June 3rd, 1950 in Milan, Italy. He was the CEO of Leonardo Corporation and the founder of Petrol Dragon in the 1970s that processed organic waste into oil. He had legal battles with government and was sued after claims of mismanagement of waste, which forced the closure of Petrol Dragon. This is a complicated part of his story. If you go online and research Rossi you'll find a lot of skeptics and trolls who dig up his past and use that as the hammer for why you shouldn't look into this technology or research.

E-CAT LENR

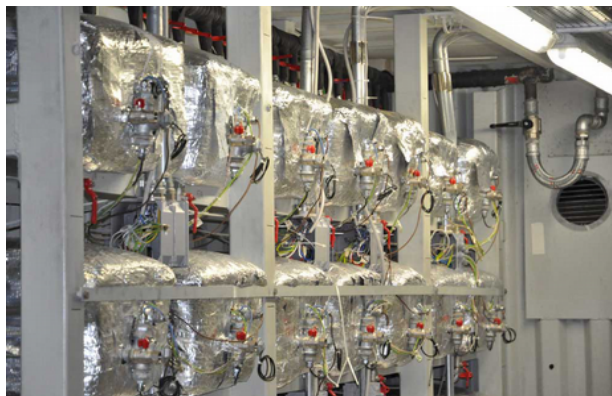
Rossi invented the E-CAT and the 'Rossi Effect' which is technology based on the thermal energy production reactions of Lithium Nickel Hydrogen. This is from research Rossi did working with Sergio Focardi to build a Low Energy Nuclear Reactions (LENR) device.

The E-CAT and the Pons and Fleischmann Palladium Cells are examples of this new class of energy production from hydrogen. They are characterized as a small metallic, glass or ceramic vessel that contains semi-precious nano powders that absorb hydrogen, and that's where you start getting the metal hydrides and excess in energy in the form of heat.

The powders tend to be precious metals such as palladium, silver and gold. Different mixtures by different companies are yielding similar results and they also had a thermal resistor to initiate the self-sustaining anomalous catalytic reaction. The excess thermal energy is then taken off by a steam cycle.

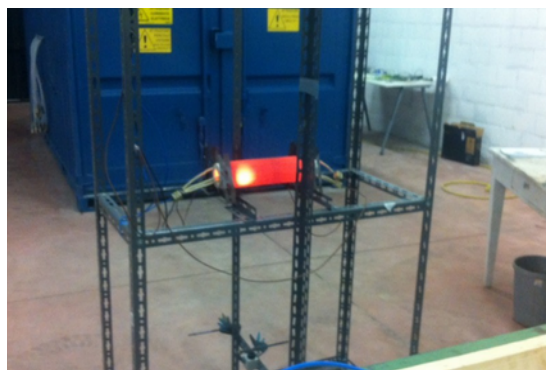
You run hot water over this hot device and it turns into steam which is then connected to a steam turbine. The term 'cold fusion' was first coined by the media in 1989 but has since been stigmatized as pathological science by skeptics in opposition to the compelling evidence! This compelling evidence consists of over 3,500 journal papers, news articles and books that show excess heat in LENR processes around the world by governmental organizations.

Companies such as NASA, Toyota and Boeing, are all currently working on this disruptive technology.



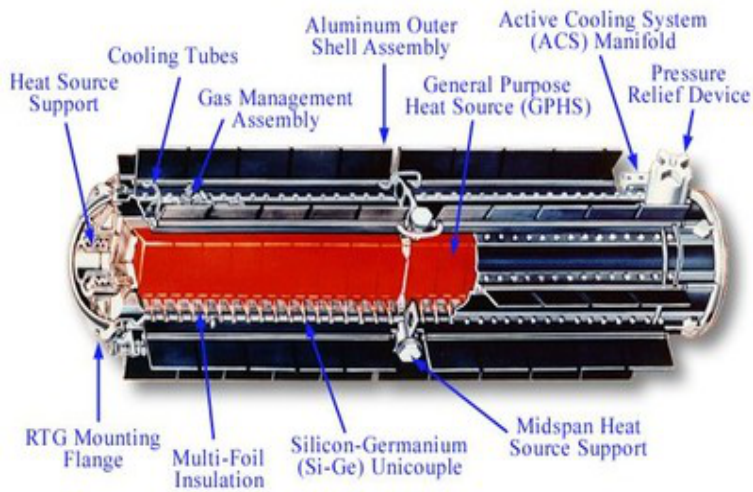

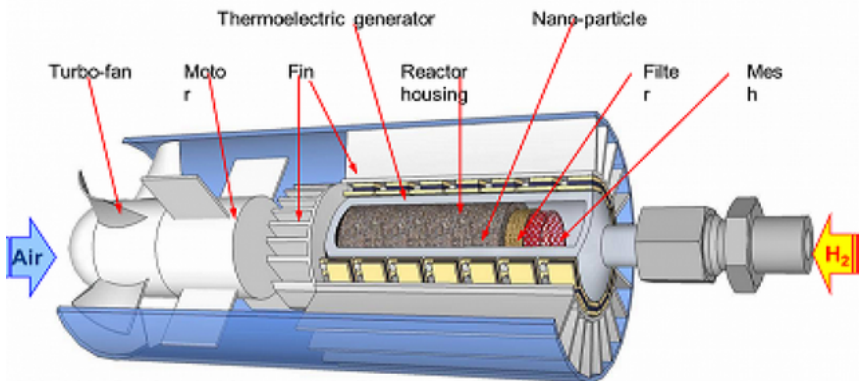

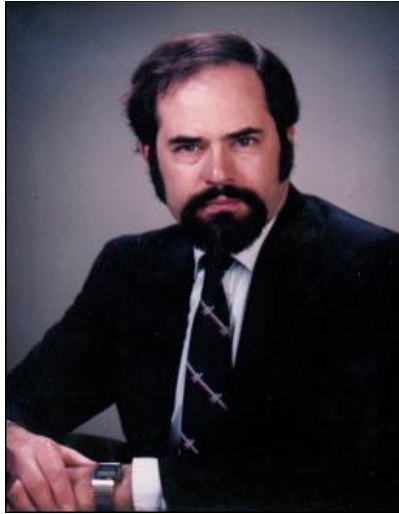


A Hydride Gas-Loaded Nanoparticle Electrode Cell

Dr. Eugene Mallove

Dr. Eugene Franklin Mallove was an American scientist, science writer, editor, and publisher of Infinite Energy magazine, and he was the founder of the non-profit organization New Energy Foundation. Since 1991 he worked as a consultant to U.S. corporations and investment firms doing planning and research and development in new energy. He was also the author of three science books, and wrote several science and technology articles for magazines and newspapers.

Mallove became very critical of the scientific establishment – what he termed the ‘Academic Government Complex.’ He saw it as more of a problem than the Military Industrial Complex. Something notable about Dr. Mallove was that he was an MIT scientist that came out against the mainstream, and was advocating for scientists that were on

the cutting edge of this research.

In an interview between Mallove and George Noory of Coast to Coast AM, Dr. Mallove describes in his own words the Academic Government Complex:

Dr. Mallove:

"I just believe that the scientific establishment was pretty much on the up and up and that they would have tried to address a new claim with justice and curiosity. They always claimed to be interested in new frontiers. But I found to my great dismay increasingly that they were not interested in new things really. They were interested primarily in getting rid of a new idea that quite radically upset their apple cart. The people that were most threatened by this did it in a negative and most egregious way. They were my former friends at MIT in the hot fusion program. MIT gets tens of millions of dollars every year to research how to make multi million, 200 million degrees temperatures to create the kind of fusion that they believe is going on in the core of the sun and to create helium. And that would indeed be an infinite supply of energy from water because the fuels are in water. But they haven't succeeded and they have spent in the United States alone an estimated 20 billion, not million, 20 billion dollars since the early 1950's and they are still going at it.

When Pons and Fleischmann came out with that astounding announcement 12 hours before the Exxon Valdesse ran aground ironically, they were shocked. Now, they didn't believe it and they

immediately assembled all the reasons to doubt it. First from a theoretical point of view and then they began to bring up all kinds of bogus, and in some cases quite bluntly fraudulent reasons against Pons and Fleischmann for throwing the whole thing into the trash can. The U.S. Department of Energy made the rush to judgment within six months. They had a negative report and that stamp of disapproval has lasted since then.

On March 23, 1989 in the afternoon in Salt Lake City the astounding announcement came from two world class chemists. Though no one has heard from them since, they are both still alive. Dr. Fleischmann in particular, a fellow that we were all deciding is one of the world's famous chemist, a brilliant man. And it was his driving force that brought the idea initially to the floor. We worked with Dr. Stanley Pons, then an American who was the head of the Chemistry department of the University of Utah.

Dr. Fleischmann attends regularly all the international meetings. He participates in the Italian program, a small official Italian program in this area, just several million dollars a year. And it's kind of mislabeled, it's not given the cold fusion or low energy reaction name, but it's there nonetheless. And Stanley Pons changed his citizenship but I do understand his feelings early in the 1990's. He was sick and tired of being called a fraud. So he moved to France with Dr. Fleischmann and worked under Japanese auspices, Minolta Toyota. One of the founders of Toyota funded them in a laboratory in the South of France in Nice for many years. And they had great success. And

their work was even published in peer review journals in 1993, and still that had no effect.

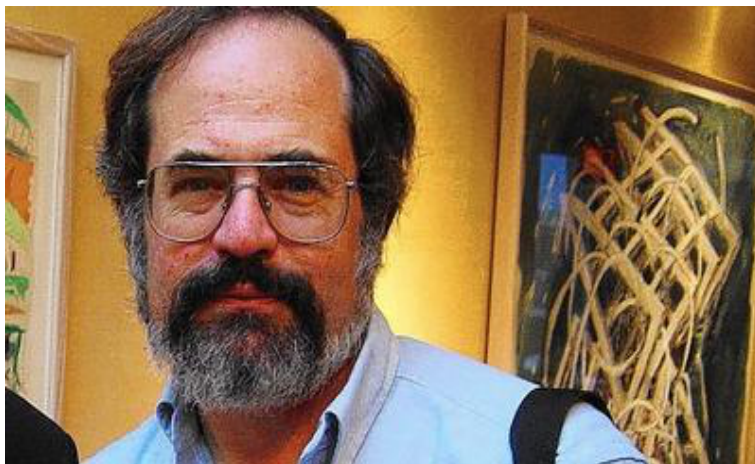
Getting back to our reginal issue here the Academic Government Complex, not the Military Industrial Complex as much as the Academic Government Complex, is against new scientific ideas that threaten the foundations of their work. And they, no matter how many papers are published, I don't care whether they are on the internet or not on the internet, or whether they are the establishment, The Academic Government Complex is brain dead.

It's remarkable almost 15 years now after that fateful day of March 23, 1989, I continue to evolve in my understanding of the well of emotional and the psychological and intellectual knowledge, to borrow a term from the famous Wilhelm Reich, that scientists have. It's astounding, one physicist at MIT whose name Dr. Herman Fischbach one of the world's foremost nuclear physics people, now he is deceased but at MIT as I was finishing up my time there as a senior person in the MIT news office as a science journalist he had played a role in getting rid of a major article of mine that was going to appear in the MIT magazine. A very influential magazine called Technology Review, it's on newsstands all over the place. He said to me "I've had 50 years of experience in nuclear physics and I know what's possible and what's not possible." And then that was it. That was his total statement, which I would cite forever as a statement, a kind of statement that should never come out of the mouth of any person who considers themselves a legitimate scientist. They are not a scientist if they say "based on previous knowledge and theory that I have, I know

for all time what is possible and what is not.” That’s obviously crazy.”

Mallove’s Murder

Mallove was found beaten to death on May 14, 2004 outside his childhood home on Salem Turnpike that he was renting to tenants Chad Schaffer and his parents. He had evicted the tenants after they had not paid rent and Chad Schaffer and his girlfriend Candace Foster and another accomplice Mozzelle Brown were convicted of his murder.

The two men beat Mallove until he was unconscious then left the scene while Mallove was still alive and returned later with Foster to make it look like a robbery. When they arrived, she saw a bloody

Mallove lying face down on the ground, but still breathing. They then continued to beat Mallove, at times with a piece of pipe and then put a bag over Mallove's head until he stopped breathing.

While his death occurred in 2004, it took police 10 years to bring his killers to justice. In 2012 Chad Schaffer, of Norwich, decided to accept an offer of 16 years in prison, pleading guilty to the lesser charge of first-degree manslaughter. Mozelle Brown was convicted of Mallove's murder in October 2014 and on January 6, 2015 was sentenced to 58 years in prison. Schaffer's girlfriend, Candace Foster, testified against Brown and Schaffer, and pleaded guilty to a charge of hindering prosecution and tampering with evidence.

The loss of Dr. Eugene Mallove has left a significant void in the new energy and cold fusion field that is very unique and difficult to overcome.

Christy Frazier, general manager of Mallove's foundation and the managing editor of his magazine, said of his death: "Gene was the voice of the new energy movement," she said. "He was a tireless advocate for new energy science and technology. His senseless murder affected not only his family and friends, but a world community of scientists and new energy enthusiasts."

Electric Motor

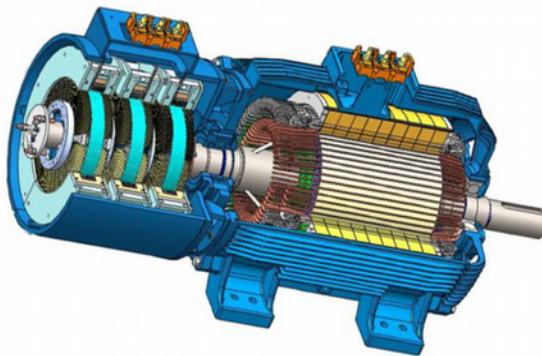
Electric Motors

An electric motor is an electrical machine that converts electrical energy into mechanical energy. Electric motors produce either linear or rotary force (torque), and are found in the following applications: industrial fans, pumps, machine tools, household appliances, power tools, and disk drives. They can be powered by either direct current sources (i.e., batteries, motor vehicles or rectifiers), or by alternating current sources (such as from the power grid, inverters or generators). General-purpose motors with highly standardized dimensions and characteristics provide convenient mechanical power for industrial use. The largest of electric motors are used for ship propulsion, pipeline compression and pump applications with ratings approaching 100

megawatts. Electric motors are classified by electric power source type, internal construction, application, type of motion output, and so on.

Electric Generators

Generators are motors operated in reverse, whereby it is an electrical machine that converts mechanical energy into electrical energy.

Switched Reluctance Machines (Motors and Generators)

The switched reluctance motor is a type of an electric motor that runs by reluctance torque. Unlike common DC motor types, power is delivered to windings in the stator rather than the rotor. This makes the mechanical design simpler (as power does not have to be delivered to a moving part), but complicates the electrical design in order to implement some sort of a switching system. Modern electronic devices make precisely timed switching easier than it was in the past.

This same mechanical design can alternatively be used as a generator when driven mechanically, and the load is switched to the coils in sequence to synchronize the current flow with the rotation. These types of generators can be run at much higher speeds than conventional types.



Switched Reluctance Machine

To understand the origin of the reluctance motor and generator, we must delve into the 125 year history of the reluctance motor, and why this technology is anticipated to still dominate the renewable energy market in the 21st century.

In the 1880s, many inventors were trying to develop workable AC motors because of AC's advantages in long distance high voltage transmission. In 1888, Nikola Tesla presented his paper 'A New System for Alternating Current Motors and Transformers' to the

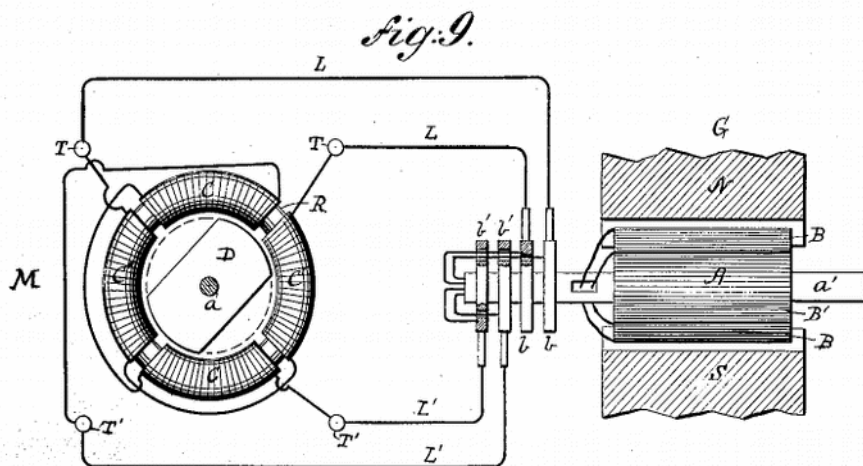
American Institute of Electrical Engineers (AIEE) and described three patented two-phase, four-stator-pole motor types: one with a four-pole rotor forming a non-self-starting reluctance motor, another with a wound rotor forming a self-starting induction motor, and a third truly synchronous motor with separately excited DC supply to rotor windings. Switched reluctance motors have a rotor that has no magnets or windings; it is a salient piece of iron. The salient stator has a simple construction.

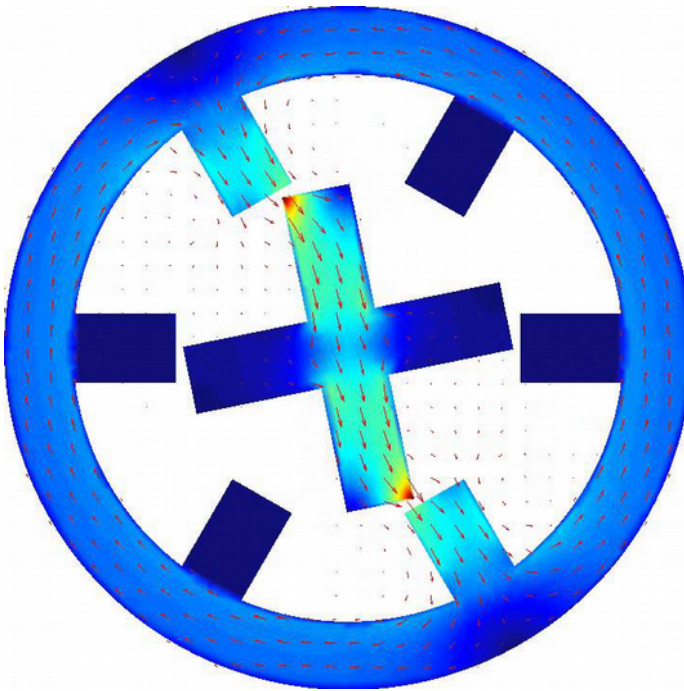

Tesla Motor Patent

The design for the reluctance motor was first cited in patent 381,968 May 1, 1888 by the inventor Nikola Tesla. He conceived of an embodiment of a variable inductance motor with no magnets, and where the iron rotor contained no windings. The modern day Switched

Reluctance Motor (SRM) remains true to Tesla's patent, as it contains no brushes or permanent magnets, and the rotor has no electric currents. Instead, torque comes from a slight misalignment of poles on the rotor with poles on the stator. The rotor aligns itself with the magnetic field of the stator, while the stator field and stator windings are sequentially energized to rotate the stator field.

The magnetic flux created by the field windings follows the path of least magnetic reluctance, meaning, the flux will flow through poles of the rotor that are closest to the energized poles of the stator, thereby magnetizing those poles of the rotor and creating torque. As the rotor

turns, different windings will be energized, keeping the rotor turning.

Clean technology is a contemporary issue, and the international community has accepted the environmental dangers of false economies and the toxification of the environment. Renewable energy is one of the hot topics when it comes to a viable solution, and both wind and solar generation are but a few of the renewable energy power sources that help.

In recent decades, reluctance machines have become an important alternative in various applications in both the industrial and domestic markets. They have good mechanical reliability, high torque-volume ratio, high efficiency, plus low cost. Although the technology is less evangelized as a generator, there are a few studies of its application in the aeronautical industry and in wind based energy applications.

Although the synchronous and induction machines dominate the market of wind energy applications, the reluctance machines are the subject of current investigation and are a valid alternative for this field. Compared with the classical solutions of machines integrated in wind applications, its simplified construction associated with permanent magnets or conductors in the rotor, results in lower manufacturing costs. In addition, both the machine and the power converter are robust. The low inertia of the rotor also allows the machine to respond to rapid variations in the load.

Associated with these characteristics, reluctance machines may now

employ electronic control systems that enable rapid changes in machine function, such that its performance is optimized (making them Switched Reluctance Machines or ‘SRM’). The structure of reluctance technology is not as stiff as their synchronous counterparts, and due to its flexible control system, is capable of absorbing transient conditions, thus supplying more resilience to the mechanical system.

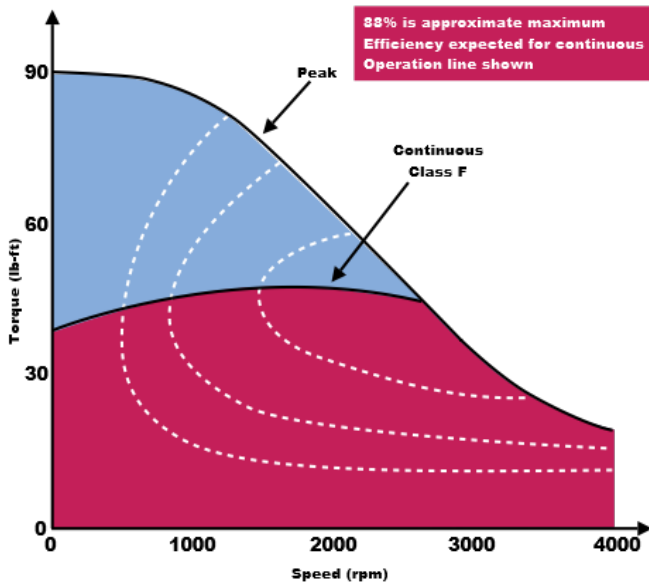
The machine has an inherent fault tolerance, especially when under an open-coil fault (in the windings) and in the power converter (external faults). Under normal operation, each phase of Switched Reluctance Generator (SRG) is electrically and magnetically independent from each other.

Reluctance technology is generally felt to be louder than conventional machines, but this can be remediated with adequate mechanical design, which can do a lot to improve these figures. In addition, all reluctance generators have the following advantages:

- simple construction, low manufacturing cost, and low inertia
- fault tolerance and the ability to operate in a high temperature environment
- present R&D for drives in power source applications that include hybrid electric vehicles, aerospace power systems, and wind engines.

The aerospace and automotive applications are characterized by high-speed operation. Constant mechanical power is provided over a wide speed range, while the wind energy applications are characterized by

low-speed and high-torque operation.

If 80% efficiency isn't enough, know that companies are embracing this technology to position themselves in the renewables sector. For example, HEVT has developed their switched reluctance motor technologies and are poised to empower the next generation of electric motors. They foresee making performance leaps with unmatched reliability and reduced cost volatility due to the use of zero rare earth minerals. They emphasize environmental benefits of having technologies that do not require the use of neodymium magnets in their statement:

“To date, most motors are manufactured in China because rare earth

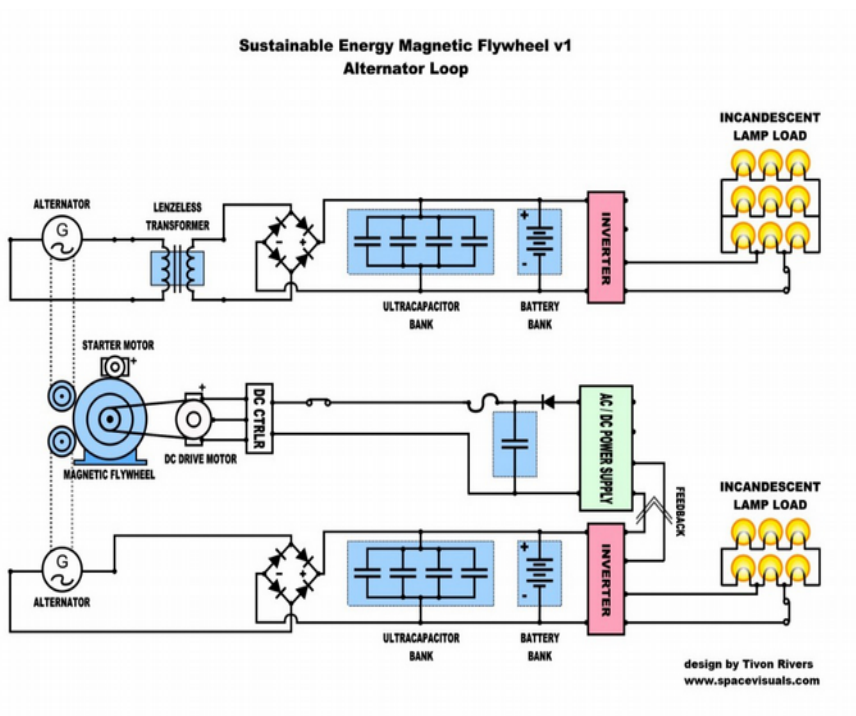
mining and refining capacity is concentrated in China. Mining and refining rare earth metals is a process that causes air, land and water pollution because these metals are typically located in bands of ore that include radioactive thorium. Not only do our technologies enable electric motors free of rare earth metals – thereby reducing environmental and public health impact – but the manufacturing process is disruptively elegant – we can scale production of our motors quickly and globally, creating local jobs in the process. Finally, our motors are highly reliable and efficient, high-performing and less costly: we reduce the initial and lifetime cost of ownership – a critical building block to enabling adoption of renewable energy, energy efficiency and sustainable transportation technologies in the U.S. and throughout the world.” – HEVT

There are generator builds that focus solely on the radiant techniques employed in countless Tesla patents, while others are using stored inertia in flywheels, gearing, and pendulums as an intermediary between the motor and generator as a self-contained energy regeneration system (i.e. patents US 20080143302 A1 and ES2119690).

QMoGens

QmoGen is a motor generator technology system that uses a driving electric motor as a prime mover connected to an electric generator that is able to augment the input power to garner more usable electric power than what was consumed in the system. Over a dozen different

videos from all over the world and at least a dozen separate patents filed, cite such technology with the addition of flywheels and or weights.

You can look up these terms on the internet and see all the various types of replications out there. The use of a driving electric motor as a prime mover to a generator that is able to augment the power to garner more useable electric power on the other side. There are replications from all over the world.

Notably, there is a list of patents that are basically QmoGen systems with flywheels. This was surprising to find as anyone with a patent

background would understand. This technology is known, and is in use, yet it is not publicized as free energy and is kept below the radar. In addition to this, this technology is clearly opensourced. People are building it and using it for their own solutions but there are also patents that go back to at least the late 1980's.

Here are all the patents citing technology where you have a motor on one end, flywheels, gears and generators on the other end. Some of these patents don't even try to hide this fact stating, "it's used to feed back into the original DC motor system in providing an output." So they are stating openly that it's an overunity system! You can look up these patents on google patents online and go through each one.

Despite the history of suppression, there have been people in the past several decades that have come up with different solutions on how to use an open system to turn into useful energy, and the devices are basically overunity systems. It is encouraging to know that people are working on all different sorts of energy concepts. Most of this out-of-the-box thinking can be used in many different applications and systems of mix and match off-grid living.

The Hatem Magnetic Flywheel

Leon Raoul Hatem is a French philosopher and inventor born in Paris in 1922. He is the author of philosophical and scientific books. From the age of thirteen he began to question Newtonian gravity and how it was supposed to govern planetary systems. In 1955, he discovered a phenomenon (which he calls degravitation) where he claims there is a release of the attraction poles of two magnets simultaneously away from each other by their own kinetic action.

His observations showed that under certain conditions, rotating, synchronized, magnetically attracted bodies begin to receive additional

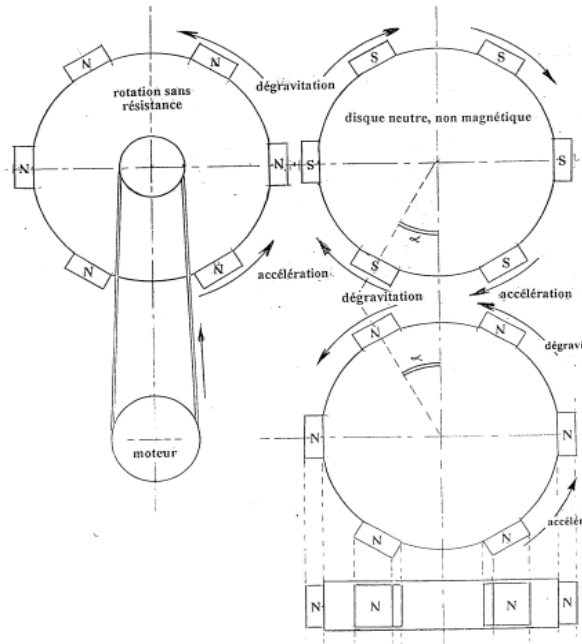
impulse from an external source when spun beyond a certain rpm (revolutions per minute). This led him to conclude that gravity was the result of magnetic functions and contends that this effect can be used to understand all movements and all planetary and atomic functions. Basically, only magnetism is required for operation of the universe and all other visible forces arising.

This sounds similar to the Electric Universe Theory, but magnetism in this case, plays a much larger role in our universe than what is being considered.

He had some devices that he developed and patented over decades of research to prove his novel idea. One such example that's been successfully replicated online is the Hatem Flywheel. If you type this in the Google search you are going to find all kinds of replications.

Some will claim unsuccessful replication and there are a few that seem successful. But it seems to be very thorough. I ran across a video clip of a Frenchman in the Alps who had one in demonstration in front of a TV camera. If you do your research into this technology you are going to run across some interesting links.

Hatem's two published patents describe implementation of his flywheel idea. There are two magnetically coupled flywheels that are put together and spun beyond a certain speed. You can have them coupled to a generator or an alternator and they start to generate more output power than what was taken to initially set them in motion. With this kind of technology, you'll find that these systems do require energy to get them started. But once it's set in motion, you're going to have an output that is much larger than the input required to keep the system running.

This is because of inertia. Once you get something in oscillation it has enough energy to keep it going. An analogy for this concept is the like the merry go round at a park. When you push it around initially, it takes quite a bit of force to get the whole thing turning, but once it's turning, all you need is a little tap with your fingers to keep it going. This is the same concept that keeps the earth spinning. Notice how the earth does not need to be plugged in to a cosmic wall socket hooked up to fossil fuels somewhere. There are other ways to create energy.

In doing this research there seems to be a lot of these mechanical devices that incorporate a flywheel. Some of these devices don't have the flywheel, instead they might have weighted wheels where a weight is swinging during the cycle. So, we're talking about using a combination of flywheels and that is kinetic energy. When you're talking about swinging weights, you're now talking about primary and, secondary oscillations.

But we see here in the photo above it's a flywheel embodiment. Not just a flywheel, but magnetic coupled flywheels. When you look at them, they also look like gears. So now you have this gearing function but more than that, it's the attraction of the magnets that help assist and give it the effect that we are talking about.

The blue motor is what's used to turn alternators which are connected inline through their magnetic coupling. The claim is, when you power up this DC motor with a magnetic flywheel, alternators turn but not at a loss in the system, you actually get a gain and the alternator is spinning with the same electrical output out as the alternator at the front. This is a way of running it in efficiency.

Here are pictures of two independent replications of this technology. On one of these replications they didn't even know who this French philosopher was. In his spare time he built a similar thing and got the same results.

Solar and Wind Power

Solar and wind power are among the few alternative renewable energy resources that have not been hidden from society. However they have been very carefully brought out with cumbersome business regulations to slow their expansion. So while they don't necessarily fall under the category of forbidden tech, we felt it important to include a short section on each of them here.

Solar Power

Solar power has really taken off in the last few decades and can provide a viable solution for some of our energy needs. However, like other 'disruptive' technologies, solar power can be prohibitively expensive for the average person to build. In the United States, the

average cost for putting solar panels on your house is about \$35,000. In some countries, the power company puts a heavy tax on citizens who have solar panels to make up for their loss in power revenues. Also, the panels do not always provide the amount of power that an average person consumes. So in many cases solar panels are only a supplement to an existing power system. If you're not careful the prohibitive cost in extra taxes and installation may not save you any money in the end.

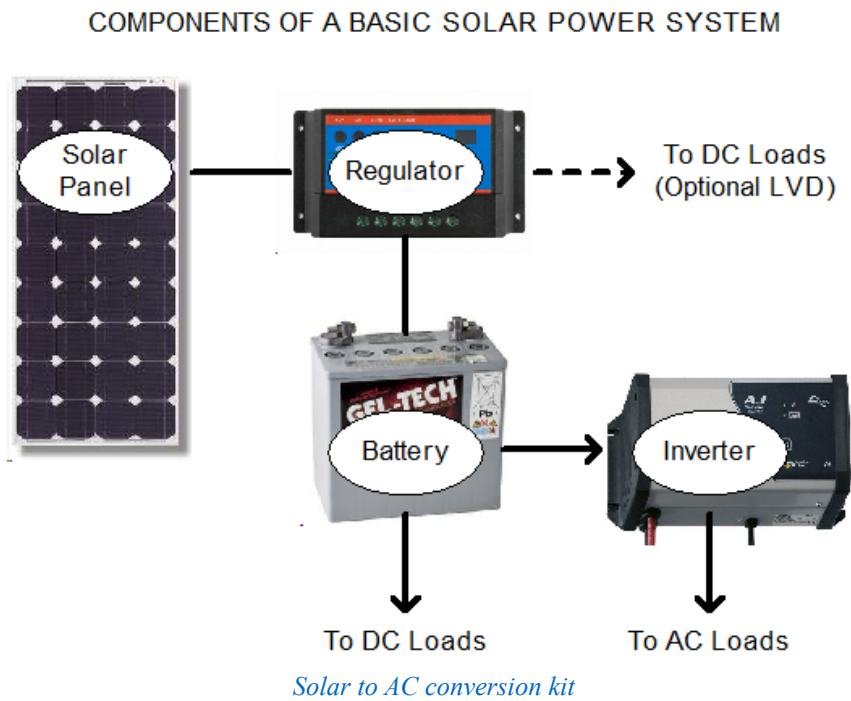


Ouarzazate Solar Power Station in Morocco

How Solar Power Systems Work

Silicon disks that are photovoltaic (meaning they produce electric current when exposed to light) convert sunlight into electricity. This electricity is then run through a regulator into a battery. The regulator is a solid state circuit that regulates the amount of charge in order to avoid the battery being overcharged. This is a direct current (DC) battery which you can power DC appliances off of. For Alternating

Current appliances you need an inverter that changes the current from DC to AC.

Wind Power

Another renewable energy resource that has been made available in recent decades is wind power. Giant wind turbines have been constructed across the world. Each turbine is as tall as a twenty story building and has three blades which are sixty meters long. They resemble giant propellers of airplanes mounted on a stick. The blades are spun by the wind, which transfers motion to a shaft connected to a generator which produces electricity.

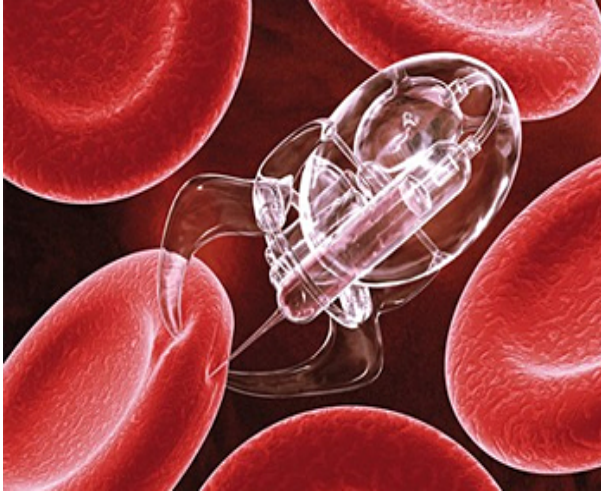
While these large scale wind solutions may seem promising, they do have several major problems. The biggest problem is planned obsolescence. In many cases, wind turbine farms cost millions to construct. The turbines are designed for a 25 year lifespan, at which time they break down and need to be decommissioned. In many cases, the planned obsolescence ensures that the wind turbine will not even last long enough to pay for itself. Surely this is something that can be improved on.

Smaller scale wind turbine innovations

Mini-wind turbines have been developing at a rate much faster than the wind energy industry. Small wind turbines tend to be located in areas where wind conditions are more unfavorable. The algorithms required for running efficient mini wind turbines are continuously being improved, and their designs have become more appealing to the eye.

Medical Nanotechnology

Nano Technology and Plasma

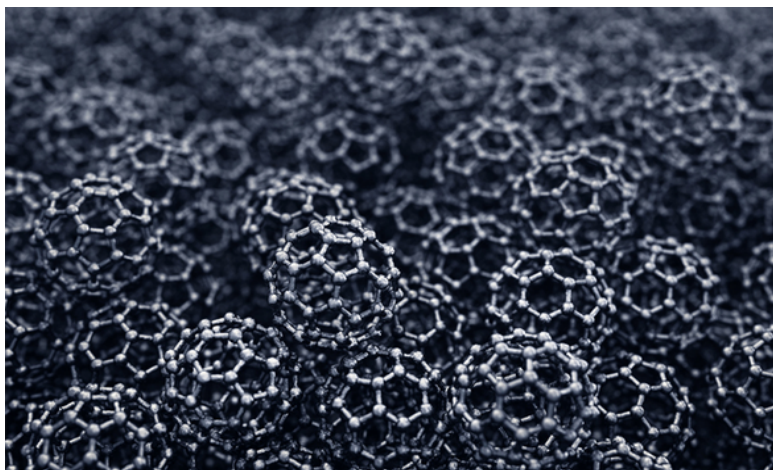
Nanotechnology is the study of matter at an incredibly small scale, generally between one and 100 nanometers. The nanoscale is so tiny that a sheet of paper is about 100,000 nanometers thick.

Uses for Nanotechnology include:

- Water purification methods by removing pollutants from groundwater and soil.
- Creating more efficient solar panels, stronger lighter weight wind turbines, lighter car parts and improved fuel efficiency.
- Medical uses in the body for detecting and treating conditions

-Weapons such as chemical and biological weapons, and also to create shielding against such weapons.

-Electronics that are faster smaller, more portable and can store larger amounts of energy and information.

Bucky balls are soccer ball shaped molecules composed entirely of carbon and measuring approximately a nanometer in diameter. They are one of the many nanomaterials that enable the innovations described here.

Nano-coating

Nano coating or nano sealing is the result of an application where nano structures build a consistent network of molecules on a surface of the

target object. This is a chemical process where the surface can be designed as:

hydrophobe/superhydrophobe

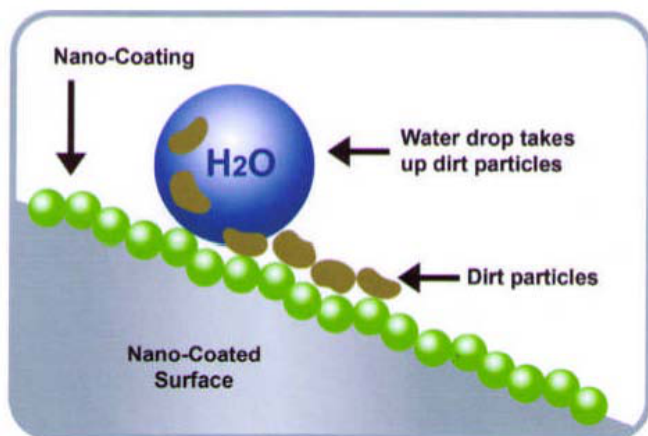
which means that liquids, which strike the surface are repelled and flow away immediately

Or

hydrophil/superhydrophil

which means that liquids, which strike the surface build a plain film on the surface and mostly flow away too.

With metals, nano-coating is a chemical process where sodium hydroxide acts on a metal to produce a hydroxide of this metal. In some cases it decomposes into a simple oxide.

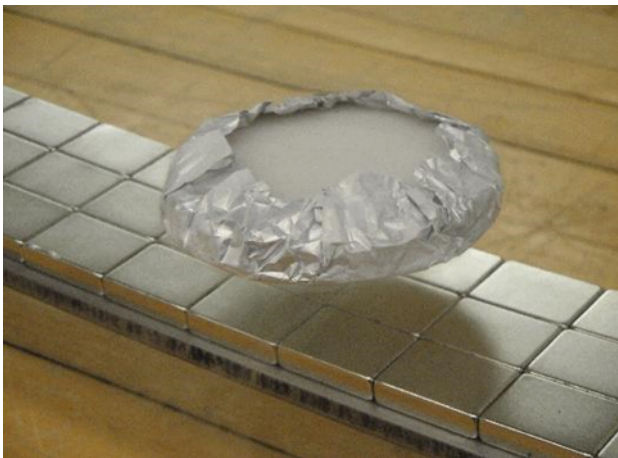


Nano-coating on surface

Superconductivity

In normal applications, superconductivity is the phenomenon of exactly zero electrical resistance, and the expulsion of magnetic field occurring in certain materials when cooled below a characteristic critical temperature. So, when you try to get the temperature down close to the vacuum of space as cold as you can possibly make it is when you normally would start to see this effect.

If you take a super-conductive ring and bring a magnet close to it, the magnet will induce an EMF in the ring. This EMF will in turn produce an infinite current to oppose the magnet's approach. Result: a magnet cannot approach a superconductive ring. You can make a magnet float on such a ring or make the ring float over the magnet.



Superconductivity experiment ring floating over magnet

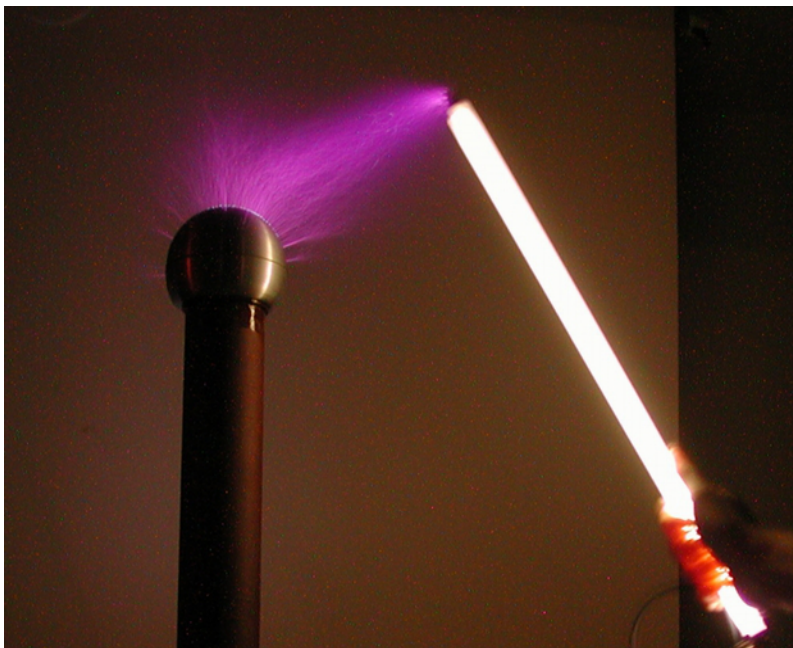
Plasma

Plasma is a gas in which the outer electrons are freed from any particular atom. Plasma is also the fourth state of matter along with your gas, solid, and liquid. The freed electrons can now move freely and thus create electrical conductivity. When electrons enter an atom, the atoms gain energy. And then releases energy in the form of photons or light.

Conducting plasma produces light. Plasma can be seen when :

- You contain the target gas in a low-pressure glass vacuum tube and apply high voltage to charge the gas, turning it into plasma and light.
- You charge the local atmosphere with a high enough voltage to see visible plasma streams emitted from a source of high voltage (potential), i.e., a Tesla coil top load.

By this point, many people have seen what a Tesla coil looks like when it's discharging arcs, and those arcs are plasma. As a result, there should be a visible faint glow in the darkened room and the distinct smell of ozone. There are real physical effects that occur in the presence of plasma.



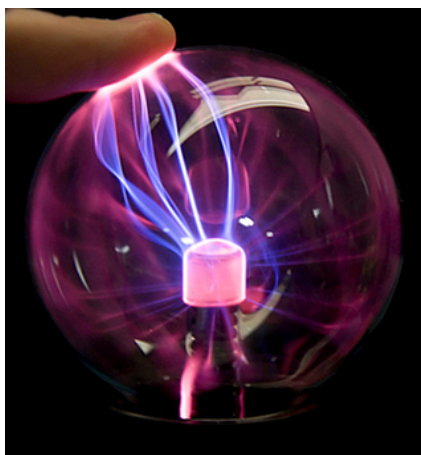
Tesla Coil Plasma Example

The following images are two examples of plasma. In the first application, the person is holding the tip of a plasma torch, and is not feeling any pain. How is this possible? Inside the torch is a piezo electric resonator that vibrates so much, that there is an air flow coming from the back of the pen to the tip. You see a black cable around the tip which charges the air as it's coming through that small tube. What you get is a glowing plasma stream emitted from the tip. In the next photograph you can actually see the plasma discharging onto the finger.

The next image is a glass plasma globe that a lot of us have seen in novelty stores. This is a classic example of low pressure plasma under a vacuum. The gasses contained within the glass container discharge when given a high voltage potential.

Radiant Energy, Tesla Hair Pin Circuit, Spark Gaps, EM field

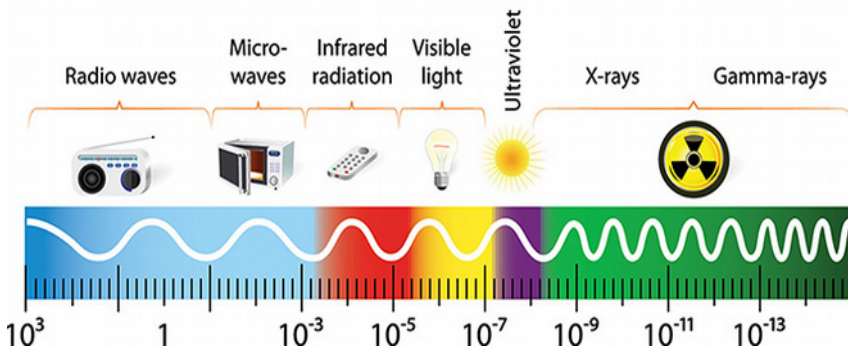
Radiant energy is a form of energy that is very different from your standard form of electricity. It is the energy of electromagnetic waves, a form of energy that can travel through space. This makes it very difficult to measure or meter, as it travels freely through the air.

Each time electric and magnetic forces come together they induce an electromagnetic field around them. An example of electric force is when you get a shock from touching a doorknob after walking across a carpet. Magnetic force is the pull that attracts metals to a magnet. When they combine they produce electromagnetic waves that travel through a vacuum. You cannot see the waves, but you can see their effects.

An electromagnetic field (also **EM field**) is a physical field produced by electrically charged objects. It is comprised of electrical and magnetic potentials, and affects the behavior of charged objects in the vicinity of the field. The electromagnetic field extends indefinitely throughout space and describes the electromagnetic interaction.

There are different kinds of electromagnetic waves and all of them have different wavelengths, properties, frequency and power. All of them interact with matter differently.

THE ELECTROMAGNETIC SPECTRUM

Radiant energy changes matter when it comes into contact with it, this is how microwaves cook food. Other ways of detecting radiant energy is through fluorescent light bulbs. Fluorescent light bulbs work by ionizing mercury vapor in a glass tube, causing electrons in the gas to emit photons at UV frequencies. When radiant energy comes in contact with a fluorescent light bulb it lights up.

Skin Effect

An interesting phenomenon that happens when electricity is at high frequencies (as is the case with radiant energy and also AC energy) is something called the skin effect. This is when high frequency currents have a tendency to flow near the outer surface of an electrical conductor, such as a metal wire. This also can be demonstrated on a human body, as Tesla was fond of doing in front of audiences of astounded onlookers.

Spark Gaps

A spark gap is a space between electrical terminals across which a transient discharge passes. Something unique about spark gaps is that when this discharge occurs, it is producing a wide range of different electromagnetic waves or frequencies at the same time. In rare instances and under the right conditions, spark gaps may generate green sparks, indicating that they are pulling in energy from the atmosphere. Tesla used spark gaps in a lot of his inventions as he was working with radiant energy. A spark gap transmitter is a radio transmitter circuit with a spark gap on it. They are illegal in a lot of countries because they are so effective that they interfere with radio transmissions.

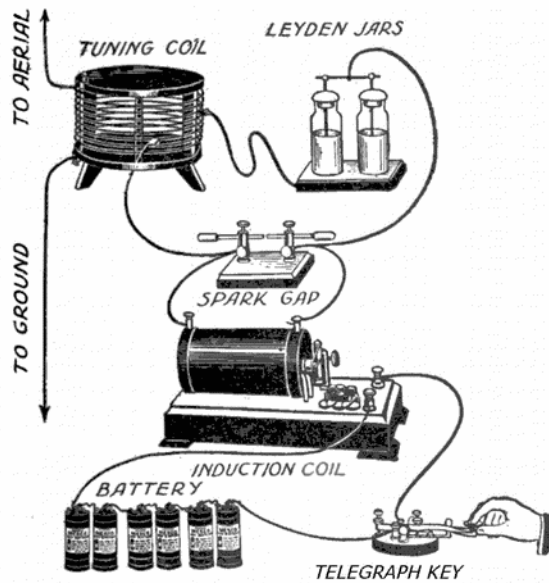


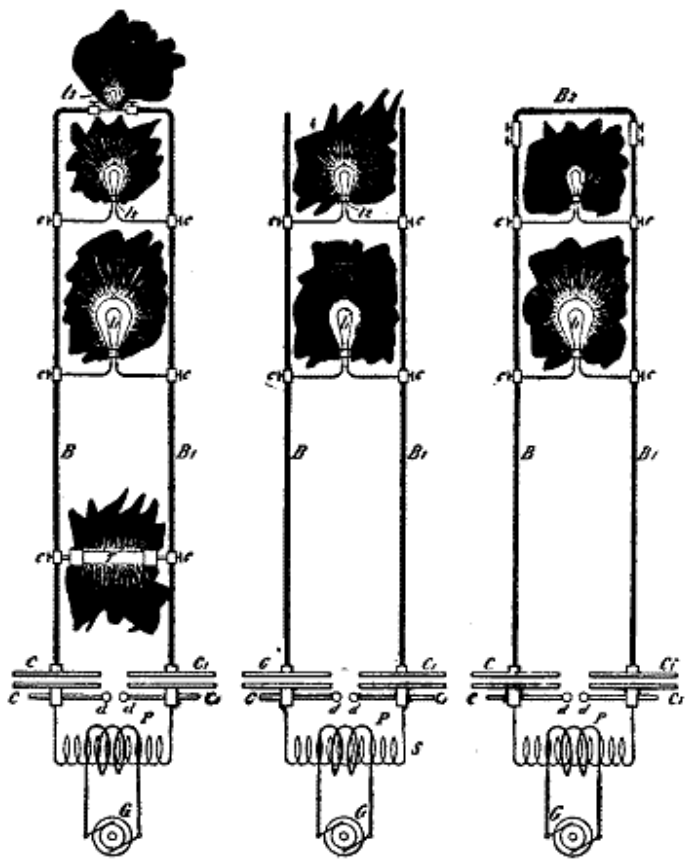
Diagram of a simple spark-gap transmitter showing examples of the early electronic components used

Tesla's Hairpin Circuit

Tesla studied radiant energy and built a simple circuit that would generate radiant energy so its effects could be easily demonstrated. This circuit goes against everything we've been taught about electricity.

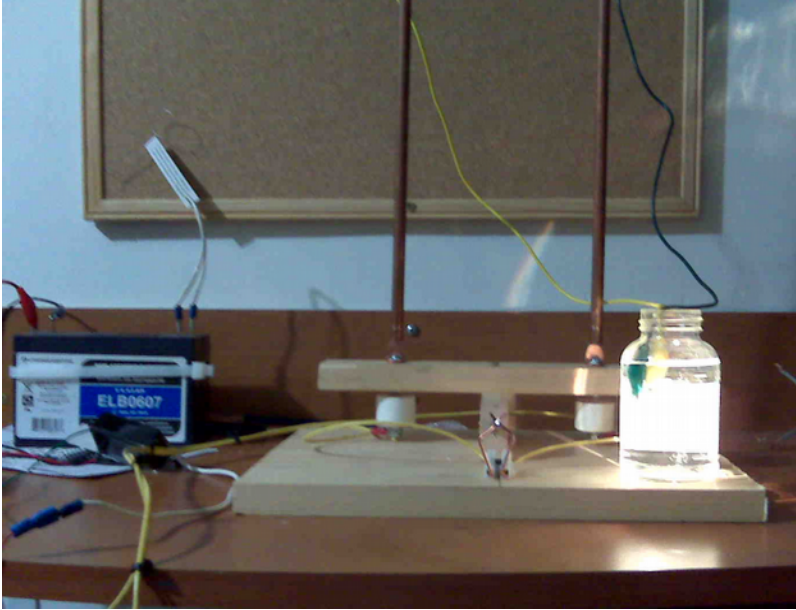
Also called 'Stout Copper Bars,' the device creates standing waves which separate the magnetic component and the dielectric component of electricity from each other. The dielectric nodes of electricity can then be used to light all manner of light bulbs in very unconventional

fashions, one of which includes lighting an incandescent bulb that can then be safely submerged in water (can't do that with standard electric current). This form of energy can open a whole new range of phenomena and technological applications.

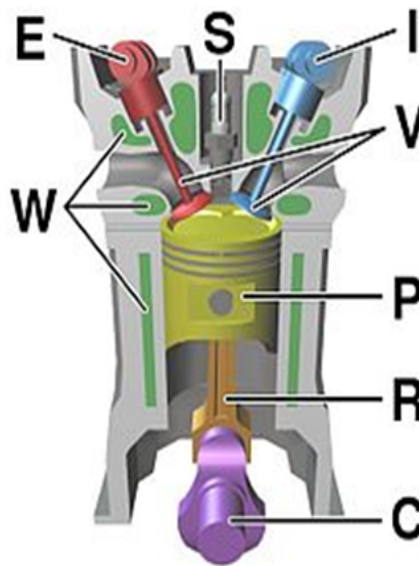
Tesla Hairpin Circuit

Combustion Engines and GEET

A combustion engine is an engine which generates mechanical power by combustion of a fuel. Combustion engines have two general types: the internal combustion engine, meaning the reaction that all these things take place like within an engine block, and external combustion engine where the fuel and all the reactions take place outside of the actual block.



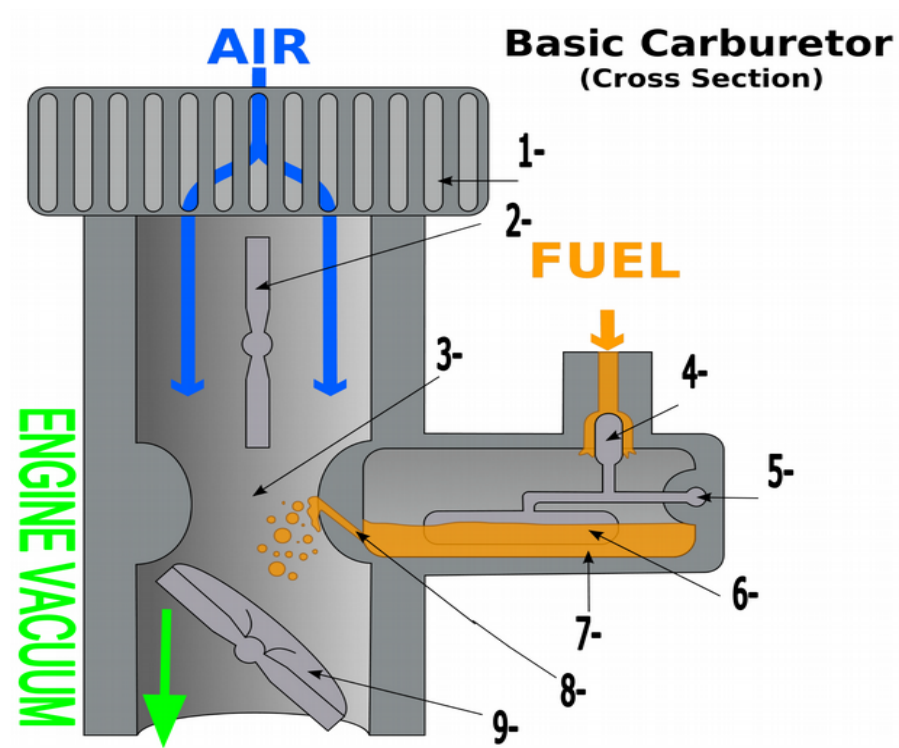
Internal Combustion Engine

An **Internal combustion engine (ICE)** is a heat engine where the combustion of a fuel occurs with an oxidizer (i.e. air) in a combustion chamber that is an integral part of the working fluid flow circuit. In an internal combustion engine the expansion of the high-temperature and high-pressure gases produced by the combustion apply direct force to

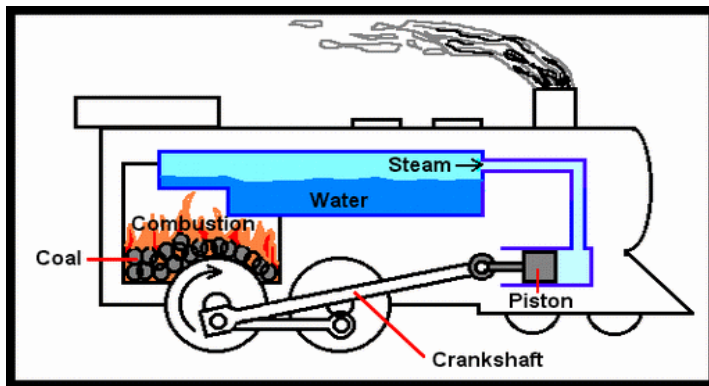
some component of the engine. The force is applied to pistons, turbine blades, and a rotor or a nozzle. If you opened up a lawn mower or you look at the inside of a car engine then you have probably seen these parts. This force moves the component over a distance, transforming that chemical energy into useful mechanical energy.

Carburetor

A carburetor is a device in an internal-combustion engine for mixing air with a fine spray of liquid fuel. That's all the part does.



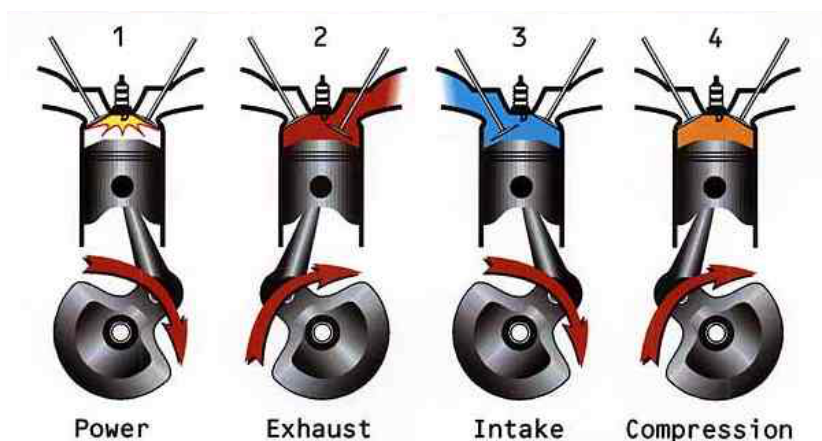
External combustion engines (ECE) are heat engines with a working fluid, contained internally, but heated by combustion in an external source, for example, heat from the sun or fire is from outside the actual device. Now through the engine wall or the heat exchanger, that's how the heat travels to start this reaction. The fluid then, by expanding and acting on the mechanism in the engine, produces motion and usable work. The fluid is then cooled, compressed and reused (closed cycle), or (less commonly) dumped, and cool fluid pulled in (open cycle air engine). Energy is delivered to a working fluid not consisting of, mixed with, or contaminated by combustible products. So the working fluids in an external combustion engine tend to be air, hot water, pressurized water, liquid sodium, these things are heated.



External Combustion Engine

One way of delineating between an internal combustion engine and an external combustion engine is the working medium that's used to transfer the energy from a chemical or thermal reaction to mechanical

motion. The Internal Combustion Engines tend to deal with fuels that leave some component of what we normally experience as pollution or contaminants. And the External Engines' working fluid tends to be things that are readily available in the environment: air, water, steam and so forth.



4 stroke Engine

How an Internal Combustion Engine Works

The internal combustion engine has four cycles to complete a particular stroke. These 4 cycles basically outline how air and fuel come in, is ignited and turns that chemical reaction into mechanical motion.

So the first phase is called intake, induction or suction: The intake valves are open as a result of the cam lobe pressing down on the valve stem. The piston moves downward increasing the volume of the

combustion chamber and allowing air to enter. Basically, when that happens the air is mixed with fuel and that's what you call charging. When you charge the case, you're filling it with that mixture.

Next is compression. In this stroke, both valves are closed and the piston moves upward reducing the combustion chamber volume which reaches its minimum when the piston goes up and down. When it touches down at the bottom is when it's at its maximum. As a result its pressure, temperature and density increase; an approximation to this behavior is provided by the ideal gas law.

The third step is power or working stroke. The pressure of the combustion gases pushes the piston downward, generating more work than it required to compress the charge. Complementary to the compression stroke, the combustion gases expand and as a result their temperature, pressure and density decreases. So this is the stage where it ignites. When the spark plugs fire, it ignites the gas. When that gas expands within a small volume, it tries to push that piston down, and that's what gives you mechanical motion.

The fourth phase is the Exhaust Phase. After the piston is pushed down, you have leftover gas and contaminants that is expelled.

GEET Technology

Paul Pantone is the inventor of GEET technology and lived from 1950 to 2015. Born in Detroit, Michigan, he was a dreamer and visionary whose family moved to southern California in 1959. In 1975 Paul met an unusual person who eventually entrusted him with the basic plans for GEET. He was commanded to give a portion of what he gains back to mankind and share the technology. In 1983 Paul built his first GEET engine.

Public disclosure of the technology in 1984 began a 25-year campaign of theft, death threats, frame ups and smear campaigns ensued from the establishment against him. This included forced hospitalization in a

psyche ward and jail time due to a series of unlawful rulings, in desperate acts to suppress his technology.

But despite all that, he did continue to persevere in the face of this open persecution. His friends and family were able to have Paul lawfully released and he continue teaching GEET technology to enthusiasts all over the world. Paul passed away from poor health in 2015. His family and students still carry on his technology today to eager students around the globe.

This is how Paul described his technology in brief.

"GEET is a fuel-delivery system that modifies liquid fuels to a vapor stage then takes it to a plasma stage, which is a higher energy form, feeding new fuel with fresh air into the engine, burning clean and cool. I shouldn't say 'burning' because it implodes; it doesn't explode; and therefore it takes heat out of the engine to run, making the engine run cold."

GEET stands for Global Environmental Energy Technology. It is a device that reduces emissions of combustion engines and improves mileage.

GEET replaces the carburetor and exhaust and combines them as one unit whereas one end of it acts as a miniature refinery allowing the engine to run on everything from battery acid and water mix, to crude oil right out of the ground. The exhaust coming down goes around and comes out at the far end. The center chamber draws some of the heat

from the exhaust. A tube takes some of the exhaust gasses up into the chamber and bubbles them down to the bottom. The bubbles as it comes to the fuel are brought up to the top of the chamber picked up through a tube and fed up the center of the exhaust pipe. While it is being fed up the exhaust pipe, its in a vacuum and there is a heat exchange which occurs. This process has been argued a few times to be either a plasma field, or an electric field. We do know that it does have slight radiation which is not alpha, beta, or gamma we do have x-rays to show that whatever is coming from the unit is affected by stainless steel.

When the temperature of the exhaust is the same as the air temperature going in from the air portion, normally 1 to 3% more oxygen is coming out of the tail pipe than the air we are breathing, and no carbon at all.



Paul Pantone Demonstrates GEET

The GEET patent basically describes a novel fuel pre-treater apparatus and method for pretreating an alternate fuel to render it usable as the fuel source for fuel burning equipment such as internal combustion engines, furnaces, boilers, and turbines, and includes a volatilization chamber into which the alternate fuel is received. An exhaust plenum may enclose the volatilization chamber so that thermal energy supplied by exhaust from the fuel burning equipment can be used to help volatilize the alternate fuel. A bypass stream of exhaust may be diverted through the alternate fuel in the volatilization chamber to help in volatilizing the alternate fuel and help carry the volatilized fuel through a heated reactor prior to its being introduced into the fuel burning equipment. So basically, there is an additional stage that the fuel and the exhaust pass through.

The reactor is preferably interposed in the exhaust conduit and is formed by a reactor tube having a reactor rod mounted coaxially therein in a spaced relationship. The exhaust passing through the exhaust conduit provides thermal energy to the reactor to pretreat the alternate fuel. The exhaust that goes through the conduit - the heat of that is taken out and is contributing back into this reactor stage.

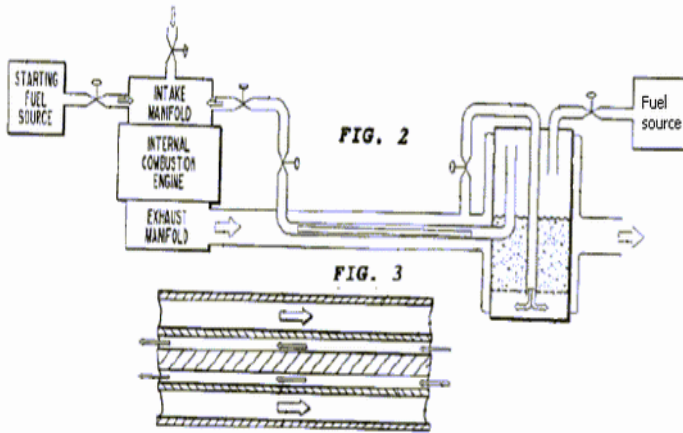


FIG. 3. an enlarged cross-sectional view of a schematic of the reactor portion of the fuel pretreater of FIG. 2.

For some people this explanation may be confusing. A simpler way to explain GEET is that it has a liquid fuel that you can cool, then convert into a vapor and then convert into a gas. It then goes into the reactor. When you use the contra flow of your hot exhaust or cold fuel gas to setup and electrical field, it also generates an electromagnetic field. Very unusual behaviour for what we recognize as fuel would you say? You are passing your fuel now as a very fine vapor /gas past a rod within that section of the reactor where you turn it into plasma and split it down into hydrogen. So GEET technology has the ability to take the fuel which is a liquid and not just turn it into vapor but another state of matter which is electrically charged plasma.

When you raise the energy of a liquid, and convert it into a plasma state it starts to become responsive to magnetic electrical fields. COINTELPRO

We're now going to cover a giant topic: COINTELPRO 2.0 and Electronic Harassment. His testimony can be heard on the Real Speaks.com website and the Real Speaks channel on YouTube.

Since the initial testimonial in the spring of 2015, and our subsequent video on 'Electronic Harassment,' we've received loads of positive

comments from very grateful people who too are experiencing this hideous form of torture and persecution. We believe that such power to utterly destroy a human life is too attractive for many large private interests, corporations, secret societies and governments to deny. Therefore, in the next few years there will be an epidemic within the blog and vlog spheres of people sharing their experiences with high-tech torture and persecution. We believe some of these incidents are allowed to occur to foment a social collapse under a cloud of plausible deniability. In other words: “It's not our fault (say the ruling elite) that everyone just went...well, crazy mysteriously.”

The fact is, we don't know how many millions of people worldwide are victims of covert war, government blacklists, and electronic torture. By sharing the information, we have researched, we hope to bring some sanity to many people that are suffering from these types of attacks yet don't know what 'it' is. So, without further ado, let's dive into the world of science-fiction become reality!

Let's imagine the following scenario:

Your name is Judy, self-employed and work from home. You leave your window ajar facing the sidewalk outside such that you can hear sounds coming from the neighborhood. One day you start to notice that some of the people who are walking by your house begin conversation in a loud audible way. You then catch a phrase like “Judy is a psychopath” in the conversation outside. You might dismiss it as you misheard the conversation taking place right outside your home.

Then somewhere a few days later, you are in a fine restaurant with a friend and you see a four-people come in and sit two tables away. Within 15 minutes someone in the group starts saying “Judy is a psychopath,” just within earshot. Hearing the phrase catches you off-guard then draws your attention away from your conversation and onto what the group at the other table is doing. You ask your friends at the table: “Did you hear that?” “Hear what?” they reply. What are you going to tell them?

Then that evening, at home in bed, at midnight someone starts making a lot of noise outside your window overlooking the main street into the neighborhood and shouts “Judy is a psychopath,” waking you right before you reach deep sleep. Are you just paranoid? How would you react?

Gangstalking is also known as Cause-Stalking, Organized Vigilante Stalking, Stalking by Proxy, Community Based Harassment, and Covert War. These are basically, harassment and discrediting campaigns waged against the victim, also known as the targeted individual, or 'TI' for short. The program is a modern embodiment of COINTELPRO Stasi-tactics that were used by the FBI in the United States during the 1950s and 60s, and is also known as COINTELPRO 2.0. Neighbors and co-workers are often recruited to participate. Other recruits tend to come from extremist groups, witch covens, secret societies, public servants and satanic cults. It is an operation comprised of rogue factions within society (Private Security Firms and/or

Organized Criminal Mafias) that have access to both private and government resources (official authorization or otherwise).

The purpose of such a program is to frame, isolate and destroy an individual financially, socially and professionally via slander, 'frame-ups' for non-existent criminal activities, online harassment, and following the target everywhere he/she goes. Targets are: whistle-blowers, good samaritans, minorities, artists, activists and any others from different groups of people who have been labeled as a domestic threat. The person under surveillance are followed and harassed by civilian groups who have been hired by private security companies, who either directly or under contract have classified security access within law enforcement / intelligence or ex-military intelligence. In addition, covert federal agencies are granted large budgets with unknown agendas.

HISTORY OF COINTELPRO

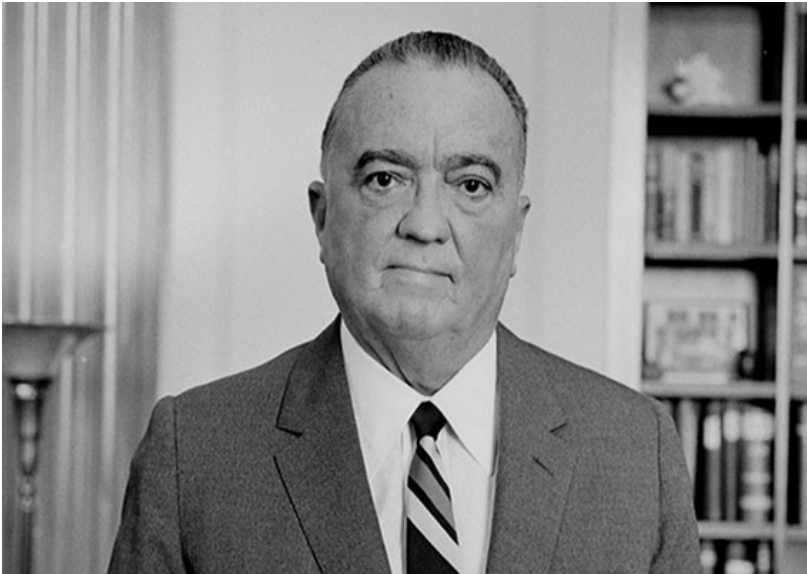
As mentioned earlier, the original COINTELPRO program started in the 1950's as an obscure branch of the CIA's MKULTRA mind control project group during the Cold War, a time when the United States and its allies were in conflict with Russia. COINTELPRO was a counter intelligence program. It was a series of covert (and at times) illegal projects conducted by the United States Federal Bureau of Investigation (FBI) which was aimed at surveilling, infiltrating, discrediting and disrupting domestic political organizations. One can immediately see these similarities to modern day gangstalking tactics.

To exemplify the similarities further, we will investigate the project case of Dr. Martin Luther King listed as a 'target of interest' by the FBI during the Cold War. We will then compare the actions of those organizations involved with the modern tactics employed today.

The FBI's own archives showed that COINTELPRO assets targeted groups and individuals that the FBI deemed as 'subversive.' Cold war paranoia and the fear of a Russian nuclear threat was the driving force for intelligence agencies within the U.S. government. They wanted to look at where communist parties were forming within its borders. On top of that, there was social reform taking place among the populace as the civil rights movement was building a large grass-roots base. These parties were also seen as a threat to the social fabric of the United States, and targeted. The FBI included the anti-Vietnam organizers, civil rights leaders, feminist organizations, and other perceived left-leaning organizations. Dossiers were created for 'targets of interest,' like the late Dr. Martin Luther King, Jr.

The COINTELPRO program was the brainchild of the Director of the FBI at the time J. Edgar Hoover. Its primary mission was to expose threat, misdirect, discredit, neutralize or otherwise eliminate the activities of these movements. The program was brought to the attention of Attorney General Robert F. Kennedy and although he had given approval, it was restricted. Historically, when such corrosive programs are first granted approval, it's for limited access or limited duration.

Initially, Robert Kennedy only authorized limited wiretapping of Dr. Martin Luther King's phones on a trial basis for a month or so. However, director J. Edgar Hoover gave his men more investigatory powers, and subjected the non-violent, human rights activist to full-blown surveillance of every aspect of his life. This exact phenomenon is observed today in gangstalking and electronic torture at the individual level. One of the primary missions of COINTELPRO in 1956 was to increase the factionalism within society, to basically divide and conquer and cause disruptions in these organizations. There were real, declared communists within the United States during that time, and the point was to win defections.

Some of the tactics FBI agents used included anonymous phone calls, and the creation of documents that would divide American communist organizations internally. In 1956 Hoover had to reclassify the FBI's ongoing surveillance of African-American leaders included within the COINTELPRO program. The official justification was that these groups were all infiltrated by communists. In other words, if you want to go into a group, and place it under the COINTELPRO program, you have to come up with a reason. At the time, that reason was to say (paraphrase) “they are all communists. We have to get rid of the communist threat.” I believe the excuse today might be because he or she is a potential terrorist, or any other excuse that one could imagine to disrupt someone else's life covertly.

Back then, there were civil rights leaders and entrepreneurs who had criticized the FBI for these tactics early on before it became publicly disclosed. Some of these leaders became targets themselves immediately, one of the more famous being Dr. (Reverend) Martin Luther King Jr. The FBI archives reveal that he was basically marked for the program and was considered a danger to national security. The FBI systematically bugged King's home and hotel rooms. They were aware of his movements at all times. At the same time he was also aware of his surveillance, had criticized the FBI for not giving sufficient attention to domestic terrorism committed by white supremacists KKK at the time. It's interesting to note that the greatest civil rights leader in recent American history was also considered a threat to national security.

In addition to aggressive spy tactics, the FBI had sent at least one anonymous letter to Dr. King encouraging him to commit suicide. It was recorded by historians as an account that King also received what was only called a suicide package sent by the FBI that contained audio recordings of King's sexual indiscretions combined with a letter telling him that there's only one way for you "out." So blackmail and extortion was used during Dr. King's 'investigations'.

During this time, other civil rights leaders were being scrutinized and co-opted. However, it was when some of the state FBI branches were under pressure by Washington DC (main FBI branch) to investigate some of these groups within their own state, was there a backlash. In response, some of these states said the only thing these civil rights

groups do is feed people on the street, as a lot of these groups came from the local churches.

All of these groups, the leftist groups, the civil right groups, the socialist worker party groups, during the 1950's and 60's were considered dissident groups.

There was frustration in these groups trying to expose the operations of the FBI. The source of the frustration was coming from the Supreme Court rulings. These rulings did nothing to limit the government's power. The groups that were targeted and sought justice tried to bring the issue out in the open into the public sphere. Eventually the rulings did come through after several official congressional committees in several court cases. It was concluded that the COINTELPRO operations against these groups did indeed exceed statutory limits on the FBI activity, and violated constitutional guarantees of freedom of speech and association. The program was kept secret until 1971.

Shortly afterward, a group of proactive citizens (known as the Citizens' Commission) broke into the FBI office in Pennsylvania and took several dossiers exposing the program and passed this material to several news agencies. History has shown that these covert programs are protected to some degree from litigation, and recruit people who are willing to do these deeds. The only effective weapon is to educate and expose the populace while collecting evidence over a longer period over time. I wonder what would it take for such a cover up to be

exposed today? At least we have the internet.

Although social reform groups provided exposés, and released the material of the dossiers to news agencies, many of these agencies initially didn't want, or refused to publish the information. But within that year the director of the FBI, J. Edgar Hoover, declared that the COINTELPRO operation was over. And that all future counter intelligence operations would be handled on a case by case basis. Basically, once something is exposed, the authors of these operations tend to try to change the narrative, or risk exposing themselves to some limited matter. Kind of like a controlled demolition. They don't want to blow the whole operation apart but instead try to close it down on their own terms and say: "Well...okay we're closing this operation down now."

These dossiers revealed the course of the separate lawsuits filed against the FBI by famous correspondents, members of socialist worker parties and other groups. It wasn't until 1976 that the Select Committee (to study governmental operations with respect to intelligence activities in the United States Senate, what's called the Church Committee) launched a major investigation of the FBI and COINTELPRO. The journalists and the historians speculated that the government had not released all of the dossiers and documents and indeed they had not and still held back on documents and dossiers that it collected on so many people and groups. There's a final report from the Select Committee that castigated the conduct of the intelligence

community and its documented operations including COINTELPRO.

What the Church Committee found was that the domestic activities of the intelligence community at times violated specific statutory prohibitions and infringed on the constitutional rights of American citizens. The legal questions involved in intelligence programs were not often considered. Otherwise, they were intentionally disregarded on the belief the program served national security, and the laws did not apply. In summary, if you're in a high level position within the military industrial complex, and run a program that you claim is for national security, you can do whatever you want. It was within such a work environment intelligence officers (on occasion) were encouraged

not to disclose to their internal review superiors the nature of the programs in which they were operating and knew were illegal!

The committee determined the most serious breaches were those of senior officials, meaning that the senior staff was themselves the ones who okayed these illegal programs. They were responsible for controlling intelligence activity and generally failed to assure compliance with the law.

Many of the techniques used would be intolerable in any democratic-republic society even if all the targets had been involved in violent activity. However, the COINTELPRO program went far beyond that. The bureau conducted sophisticated vigilante operations aimed squarely at preventing the exercise of the American First Amendment Rights regarding freedom of speech and association. If we analyze who was targeted in this program during the 1960s and 1970s decades, and compare to the range of targets placed under today's COINTELPRO 2.0, the selection process has not become more narrow. On the contrary, it has expanded to include any individuals who stand out. The program is more technocratic and logistically refined but is still COINTELPRO nonetheless.

It wasn't until the 1970's that the Church Committee determined the range of targets the FBI investigated in its conception of COINTELPRO were mainly members of the Communist Party. According to the Church Committee while the declared purpose of these programs was meant to protect national security or prevent

violence, FBI witnesses admit that many of the targets were nonviolent and most had no connections with a foreign power.

Going back to what the Church Committee found with the COINTELPRO program in the early 70's indeed confirmed that non-violent organizations and individuals were targeted because the bureau believed that they "represented a potential for violence." Non-violent citizens who were against the war in Vietnam were targets because they gave aid and comfort to violent demonstrators by lending respectability to their cause. So this program targeted people who aren't even violent and had demonstrated antiwar sentiment.

The imprecision of the targeting also demonstrated the inability of the bureau to define those subjected to their programs. It's also well known that at the height of the American civil rights movement, all types of groups including peaceful groups were labeled as hate groups. Furthermore, the actual targets were chosen from a far broader group than the title of FBI's covert program would imply. The program targeted not only the Communist Party members but also sponsors of the National Committee to Abolish the House on American Activities Committee. So there were other groups basically that were, let's say, probably 'left leaning' but not communists that were seeking civil rights. They just weren't considered sufficiently anticommunist before they too were targeted. The net later expanded to include Anti-war demonstrators and university minority student unions.

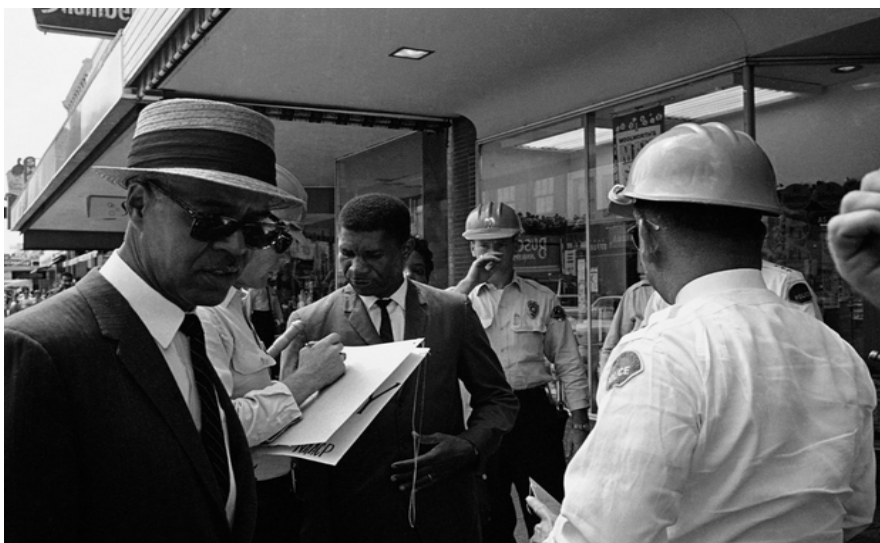
There are recent historic examples of covert surveillance that the Church Committee cited that was present in all administrations from FDR to Nixon, both legal and illegal. For example, President Roosevelt asked the FBI to put in its files names of citizens sending telegrams to the White House opposing his national defense policy that supported Colonel Charles Lindberg. Truman received inside information on former Roosevelt aids' efforts to influence his appointments, labor union negotiation plans, and journalists' publishing plans. President Eisenhower received reports on purely political and social contacts with foreign officials by Bernard Baruch, Elinor Roosevelt and Supreme Court Justice William O'Doul's.

The Kennedy administration had the FBI wiretap a congressional staff member, 3 executive officials, a lobbyist, a Washington Law Firm, and the U.S. Attorney General. Robert F. Kennedy received the fruits of a FBI wiretap on Martin Luther King Jr. and an electronic listening device targeting a congressman, both which yielded information of a political nature.

So basically, every president relied on the intelligence agencies to perform these duties both legal and illegally to gain information either due to the war or anti-war sentiment, or political activity of their rivals going back for several presidencies.

The Church Committee's concluded that communist and social organizations associated with the civil rights movements and also with the Southern Christian Leadership Conference, NAACP, and other

civil rights organizations, the American Indian Movement, White Supremacist Groups, the KKK, and the National States Rights Party were under investigation. COINTELPRO was used politically for the left and the right (and those non-aligned). All anti-war groups that protested the Vietnam War were a very big target. In short, it was a time that if you stood out politically and made it on a newspaper that was civil rights, anti-war, or left / right leaning groups, you were probably targeted for COINTELPRO.

The intent of these operations was to prevent and disrupt protests against the Vietnam War, and eliminate the Communist threat. Many techniques were used to accomplish this task which included; promoting splits among anti-war forces, baiting people into violent confrontations as an alternative to peaceful demonstrations, etc. The

main purpose was to discredit and disrupt. Their activity served to undermine the trust and scare off potential supporters. The FBI and police exploited this fear to smear genuine activists and leaders.

The next point cited by the Church Committee was the psychological warfare the FBI and police used. A myriad of dirty tricks were employed to undermine progressive movements. They planted false media stories, and published bogus leaflets in the name of individuals and groups targeted (this tactic is used today to silence online independent reporters and content providers). Back then, they forged correspondences, sent anonymous letters and made anonymous telephone calls. They spread misinformation about meetings and events by setting up pseudo movement groups run by government agents, and coerced parents, employers, landlords, school officials, and others to cause trouble for activists. It was also reported that gangs were hired which at times lead to lethal consequences. This actually happened! It's interesting that the Church Committee cited psychological warfare, damning evidence and how it led to legal consequences. People died under these programs that were on the receiving end because they were encouraged (or paid) to commit acts of violence against the citizenry.

Finally cited was harassment via the legal system. The FBI and police abused the legal system to harass dissidents and made them appear to be criminals. I think this is also facilitated if you're foreign and not a citizen of that country, especially if you don't have any strong ties. FBI

agents and officers of the law gave perjured testimony and presented fabricated evidence as a pretext for false arrest and wrongful imprisonment. In short, they made up stories that got people in jail. They discriminatorily enforced tax laws and used conspicuous surveillance, investigative interviews and grand jury subpoenas in an effort to intimidate activists and silence their supporters. The activist who really stood out became targets of basically, the entire law enforcement system. The FBI conspired with local police departments to threaten dissidents and conduct illegal break-ins, commit searches, vandalism, assaults, beatings and assassinations. The objective was to frighten or eliminate dissidents and disrupted the change that was happening socially.

Basically, the Church Committee concluded that all of these tactics eventually led to deaths of civil rights activists and leaders. Deaths occurred either while held in custody by law enforcement or during violent exchanges with police at rallies and gatherings. The FBI had conducted over two hundred warrantless suspicious entries against targeted groups and their members. It was also written in the report that the actions of the FBI led to the death of a civil rights worker in 1965 when spreading of disinformation encouraged a KKK member to murder a passenger who was an African American male. It turned out that the murder suspect wasn't just a clansman, but was also an acknowledged FBI informant. He used his official government position to commit murder while undercover.

Within the final report of this Church Committee, they also concluded that too many people had been spied on by too many government agencies. Too much information had been collected illegally. The government was committing more surveillance of citizens based on their political beliefs, even those beliefs that posed no threat of violence or illegal acts on the behalf of a hostile foreign power. Just by having beliefs that were counter to what the FBI deemed acceptable could have placed you in this program. The government operated primarily in secret through bought informants, but also used other intrusive techniques such as; wiretap, microphone bugs, surreptitious mail openings, break-ins, and swept vast amounts of information about the personal lives, views and associations of American citizens.

Investigations of groups deemed 'potentially dangerous,' even groups suspected by association, have continued for decades despite the fact that those groups did not engage in unlawful activities. So basically, it's gotten to the point where it became so broad in how you could end up in the intelligence 'surveillance grid' that it seemed not to matter what you did. You're just put on it, if not directly, by association. Groups and individuals were been physically assaulted, repressed, harassed, and lives disrupted because of their political views, social beliefs, and their lifestyle.

Investigations were based the vague standards whose wide breadth made excessive collections inevitable. Unsavory, harmful and vicious tactics were employed, including anonymous attempts to breakup

marriages, disrupt meetings, ostracize persons from their professions, and provoke targeted groups into altercations that might result in deaths. And these are things that we're seeing today among people who claim to be targeted individuals, and those who claim to be the victims of what seems to be a top-down covert COINTELPRO program across the world, not just the west. It's as if this rogue operation has gone international in its scope.

The government officials included in this report, it was concluded, those whose principal duty is to enforce the law, had not only violated or ignored the law over long periods of time, but also advocated and defended their right to break the law. The constitutional system of checks and balances had not adequately controlled intelligence activities. Until recently, the executive branch had neither delineated the scope of permissible activities nor established procedures for supervising intelligence agencies. Congress had failed to exercise sufficient oversight by seldom questioning, the use to which its appropriations were to be put to use. Most domestic intelligence issues had not reached the courts. And those cases which had reached the courts, the judiciary were reluctant to grapple with them. This was the final report from the Church Committee. Although the COINTELPRO program was officially terminated in 1971, there were a lot of critics afterwards that would say otherwise. Rather, it has continued but under different guises.

Gangstalking

How does COINTELPRO apply to gangstalking and those who are on multiple blacklists today? There is a historical record of this happening as a western phenomenon during the height of the Cold War as a means to covertly suppress the social change that was occurring in the height of the Vietnam War. Now we have a similar situation today, but it's a lot more dangerous I believe because we're in a post-911 world where for almost two decades it's been about the 'War on Terror'. We've seen an erosion of civil liberties and civil rights in the western world. We live in a time of technology, of internet hacking and surveillance tools that are far beyond what existed in the 50's, and certainly in the 70's.

And that's where we are today. Either it's the war on terror or the economic crisis, etc. It appears there is a program of distraction that must persist. And this is where we get into gangstalking.

Gangstalking is by its very nature COINTELPRO, with an electronic database that blacklisted the target (making it COINTELPRO 2.0).

Today if you research the origin of the word gangstalking there are some within the online community who will say it's not the proper term. Some researchers of this phenomenon suggest that it should be called covert war or something else. The reasoning is that the term 'gangstalking' has been co-opted and if anyone uses that term it's disinformation. I don't think so. What I know is that in 2014, I was put under surveillance and my electronic torture began. This was done

without my consent and I don't appreciate it. Gangstalking was the word I found online that described the system I was placed under, thus seems to be the word that everyone had been using up to that point.

I've read the testimonials of the persecuted who were placed in this program before me, and they used the word 'gangstalking'. So, I'm sticking with that. Like the COINTELPRO program of the past, it is meant to discredit the target and to also possibly recruit others to participate. Now as I mentioned earlier, targets can be whistleblowers, and good Samaritans. Maybe you're researching cancer cures, or engaged in an alternative energy project. Perhaps you fit in a couple of the following categories; minorities, artists, activists, and any other from a large group of people who have been labeled as a domestic threat and a deplorable.

Once someone is blacklisted and placed into this program, a covert investigation is then performed which may take months or years. Through covert or overt surveillance, everything about your life is black-holed. Your online social activities, sexual habits, employment, friendships, family ties and finances are all monitored, To make things worse, a corrupt psychological profile and false record is made that follows you everywhere you go. Could this be one of the main reasons some spy agencies eagerly want to collect too much data on everyone? The power of coercion and blackmail is too tempting to let go. It's well known that the very same agencies intentionally engineer 'backdoors' in electronic consumer products to covertly eavesdrop on

conversations and video feeds. The data collected could also be hijacked by criminal organizations using the same if not better remote hacking equipment than those government intelligence organizations that claim to be spying ‘for your safety. A savvy criminal cyber team could then take the data collected about you and use it as a tool for extortion and blackmail.

In addition, this black record is used to fabricate a script. Hired perpetrators (who've committed this script to memory) use it to create a smear campaign about you to your neighbors, your friends, your co-workers, etc. I can tell you first hand that it isn't very pleasant when a group of people spread rumors, slander and bare false witness against you. All the while, you're being tortured and harassed.

Imagine the following scenario: You've lived in a neighborhood for a few years, and for the most part, are comfortable with the environment. You also are an active anti-war protestor, and recently you were interviewed by a local television station about the latest scandal pertaining to the government war budget. A few weeks later, you notice that there's a shift. Random people start giving you strange stares for no reason at all. You notice when you're walking down the street, scenarios seemed to be setup in front of you in order to illicit a response in public.

Someone might act out in front of you and start a fight or a similar situation that you want to take no part in. Disengage and avoid it. Friends that you knew for years all of a sudden stop communicating

with you. Or you might find yourself at work and the people in the environment distance themselves from you. Basically, the end result is a virtual isolation control grid that's created around you. For many people who are targeted, it might just stop there, however, it can go much farther for others. This requires some physical, trackable information about you in order for it to go into full blown electronic harassment.

It is possible some of these individuals are selected as an experiment to study the human psyche under constant duress. Perhaps in preparation for some future attempt to directly manipulate a large swathe of the population? In my opinion, however, it seems some of these people were made targets simply as a means of removing them from society without the perpetrators getting their hands dirty. It is indeed a very seductive social engineering tool.

As I mentioned previously, there is an intended outcome for one's gangstalking and covert harassment. Thankfully, there are solutions to this, and your life doesn't have to end according to any of their 'scripts.' Knowing the intended outcomes of this heinous program is the first step towards empowerment. As an empowered individual, you can then take the necessary steps to avoid the traps these monsters have laid. The name of their game is to utterly crush your free will while destroying you mind, body and spirit. Eventually, they want one or more of the intended outcomes:

- To create a violent reaction within the target, leading to a

criminal offense and imprisonment. This program in theory could be used to socially engineer an un-awakened populace, thus perpetuate the need for a police state in reaction to a growing 'domestic threat'. Later, we will discuss how technology is currently being deployed to try to remotely program individuals placed in this program, turning them into Manchurian Candidates.

- Repeat incarceration of the targeted person due to minor offenses, leading to professional and financial ruin. Most likely this person was psychologically triggered prior to committing the offense. Corrupt law enforcement officers may also be involved in the setup to the arrest.
- To force or coerce detention in a psych ward. A victim of Voice-to-Skull technology is encouraged to seek 'professional help' if they tell acquaintances, friends or family that they hear voices. They are often misdiagnosed as suffering from schizophrenia, even though there isn't any history of this mental illness in the family (very important consideration). In fact, you will soon discover why the medical profession is woefully inadequate to get to the root of the problem. The next subsection in this book gives a summary of the current state of electronic harassment and ways to dramatically weaken if not, completely eliminate the 'signal' response by the human body entirely.

- Induced Suicide. Physically, mentally and spiritually crushed, depression and financial ruin compels the victim to commit suicide (**WHICH IS THE PRIME MOTIVE OF THIS COINTELPRO 2.0 PROGRAM**). If the victim dies, this form of assassination is also called 'soft kill.' 'Directed Energy' may also have been used to weaken the body and trigger the heart muscle to beat irregularly. We must also ask if the person had a pace maker or electronic implant during the time of death.

If you are ever targeted and put in this program, remember the previous prescribed paths to destruction are only what these psychopaths wish of you. It doesn't mean it will manifest. In fact, ignore any and all negative suggestions that “you cannot win” or “you'll never get out of 'The Program.' ” You must understand it's important for the covert types to isolate you from your friends and family. This article entitled ‘How Covert Agents Infiltrate the Internet to Manipulate, Deceive, and Destroy Reputations’ shows detailed directions from manuals on how to discredit a person or company, and includes even more destructive practices like leaking information, emailing colleagues, neighbors and friends, and changing photos on the target’s social media.

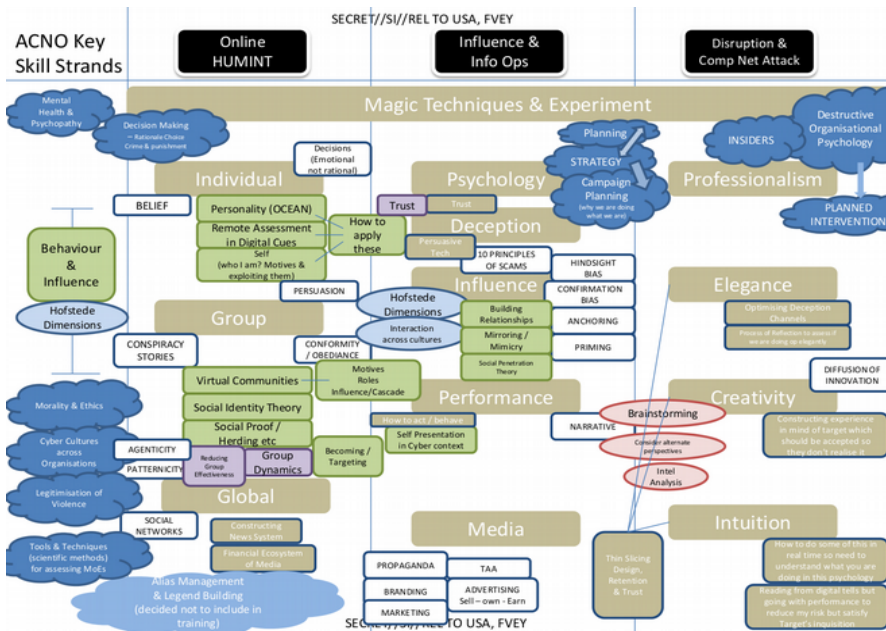

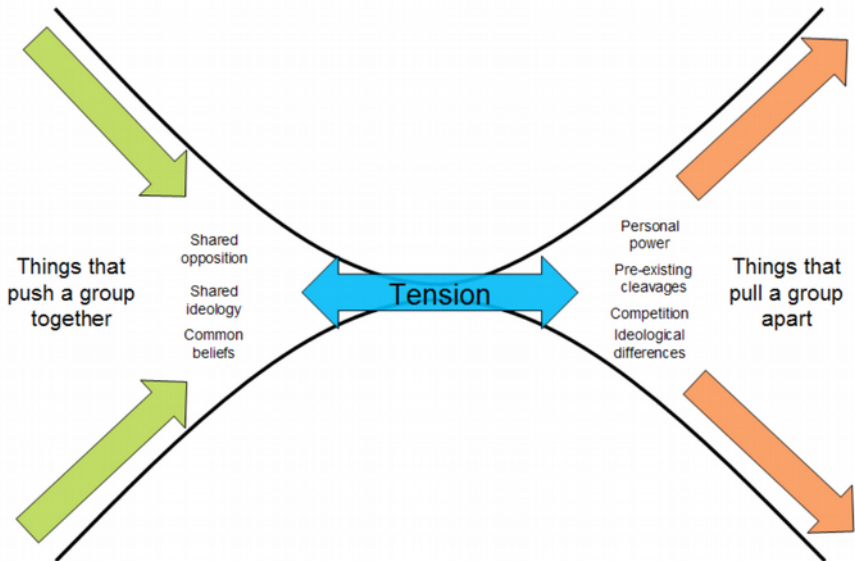

Now in the 21st century, the revelations of Edward Snowden reveal a vast global data collection program on citizens world-wide. The U.K. has a system of collecting a vast array of data on all its citizens. In the U.K. there are secret courts.

A spying court had an internal review of their operations over the past decade. The result of this review has led to a change to the law in the U.K. This means the U.K. agency GCHQ and other bodies are now free to build up data sets on citizens so long as they're more transparent about its surveillance. It has allowed GCHQ to break into internet cables and other communications, and use that data to build up a large database about people with no regulation or oversight. So we're seeing this pattern build again where it's just unregulated, black holing of data.

Before the passing of the Snoopers Charter, the spy court was found to have no code of practice or other rules to govern how the information was being used. The hearing showed how information was being abused. Cases cited included spies who; retrieved information on their friends, or public figures, and spied on family members for personal reasons, etc. But the spying will actually have to stop because basically they found a loophole that allowed the current bulk collection program to be made legal. Somehow they found a way that was illegal and made it legal. It's just amazing!

In the United Kingdom, GCHQ and other spying agencies have been given further investigatory powers by Parliament (The Independent,

2016). It's known as the Snoopers Charter law that gives 'Orwellian' powers to spying organizations and government agencies. Privacy International, which brought the case, said that the judgment showed spying powers were not being properly regulated or described to the public. It was also acknowledged in the article that British spying agencies were collecting everyone's data for well over a decade without oversight. It showed that these agencies were intruding on people's privacy and wasting government resources. Now it is my opinion that the article stopped short of any real solution to this crisis. It concluded that targeted surveillance should be for specific individuals suspected of wrong doing but this is giving legitimacy to organized targeted individuals without any formal recourse.

Energy Industry Motives for Internet Defamation Campaigns

The energy industry is a 600 trillion-dollar industry. Any new energy technology that would threaten this industry is taken very seriously. The energy industry, corporations and governments spare no expense to protect their geopolitical power structure. Human social behavior is studied, analyzed and used to create programs to manipulate people. These programs are then carried out by paid employees who are under non-disclosure agreements to protect the identity of the companies that employ them. The programs' psychological impact then influences other weak willed individuals to continue to carry out their objectives, even if they are not paid.

Free Energy Trolling

You may read a lot of blog posts about new energy technology and may see a series of detailed comments that seem to logically question the issue at hand. These comments are sometimes respectful but often demeaning, and frequently contain links to official articles and resources that counter the author's position. As a reader, you may begin to question the validity of what the author is writing.

The problem is, perhaps you are the one being duped into believing that this is a neutral commenter. In reality, this person may have been paid by a company or organization to 'take down' the author. Today, writers, commenters and truth seekers are being debated by paid internet trolls whose sole purpose is to destroy the reputation and credibility of those with opposing points of view.

Strategies used to destroy clean energy online

These Internet trolls use a number of different tactics to discourage free energy researchers and influence public opinion. Some of these tactics are:

- The most common strategy is labeling all free energy research and devices as a 'scam,' and all evidence supporting free energy as a 'conspiracy theory.'

- Spreading false or skewed information in online conversations, including social media and blog comments. Lies of omission are another popular technique here as well.

- Creating false accounts that appear to follow and support free energy devices and inventions, and then generally acting unhinged (acts crazy) as a follower of the author, in order to scare new followers away. This involves agreeing with the article while displaying unstable or outrageous behavior in the comments so that real readers and commenters are scared away from following him or her. *JTRIG Art of Deception Online Covert Operations Training Manual pg. 42 “Mirroring, Accommodation and Mimicry”*

- Creating multiple user profiles to make it look like there are more dissenters than there actually are. Usually, the same person or group creates them all. Someone who is very skilled will vary the ‘voice’ of the commenters so that they sound like different people who coincidentally just met and all agree. *JTRIG Art of Deception Online Covert Operations Training Manual pg. 48 “Identifying and Exploiting Fracture Points”*

- Organized, timed attacks to ruin a person’s livelihood or

reputation. These can be timed with the victim's own successes: such as a new breakthrough, a big announcement, release of new important information or schematics, a successful campaign, etc. *JTRIG Art of Deception Online Covert Operations Training Manual pg. 45 "Disruption and Computer Network Attack"*

- Posting comments that claim "I am a victim!" with details on how the author's point of view on a topic has destroyed their lives when, in fact, these are just made up stories. Example: "This is a scam, I fell for it and it ruined my life!" Many times, the commenter will look like your average person. *JTRIG Top Secret Conference Slides Leaked by Snowden titled "Discredit a Target"*
- The creation of entire baiting websites / blogs / forums used for data mining and monitoring the threat of free energy progress against the oil industry. Topics appear to start from a neutral point of view but then all forum threads become infiltrated with trolling comments that are not monitored. Mostly "debunking" or "discrediting" every free energy device theory that is presented. *JTRIG Top Secret Conference Slides Leaked by Snowden titled "Discredit a Company"*
- Full time professionals posing as 'experts,' both online and at speaking engagements. This is known as "controlled opposition", the concept being that the best way to control the

opposition is to lead it. *JTRIG Art of Deception Online Covert Operations Training Manual* pg. 42 “Mirroring, Accommodation and Mimicry”

How Much a Troll Is Paid

According to people who actually do this for a living, a low-level troll can make \$200 – \$300 per month for 2-3 hours of work a week once they develop a routine. Higher ups have been rumored to pull in over a \$1000 a month, and get perks ranging from paid vacations to event tickets. They are also required to sign confidentiality agreements, allowing the companies behind them to remain hidden.

Who is behind this and why?

Large-scale government organizations and corporations are some of the groups behind these Internet trolls. Here are their top three end goals:

- To publicly destroy the entire reputation of the person who is trying to educate the masses. This allows them to decree that person as a fraud and to shame anyone who follows or trusts him or her.
- To cast doubt among the followers and perhaps even turn some of those followers away from the truth. To make followers or readers to feel like they’ve been scammed and enrage them

enough to switch sides and become their own spokespersons, such as recruiting unwitting bloggers and inventors to support their agenda.

- To start an ‘anti’ movement, with its own momentum as former followers and uncertain doubters decree the lack of ‘truth’ in free energy research and development.

Trolling is a Serious Growing Problem and Needs to be Stopped

1) Baiting Websites Examples: OVERUNITY.COM - A free energy forum website with a red flag name to lure in new inventors and alert energy companies of the latest threats.

[REVOLUTION-GREEN.COM](http://www.revolution-green.com) - A blog created by corporate paid shills. Camouflaged as a free energy support website and peppered with occasional factual yet non-disruptive articles, its primary purpose is to serve as a platform for articles that claim all free energy devices will never work.

2) ‘Controlled Opposition Experts’ examples:

One troll gets paid to fly all around the world to ‘evaluate’ free energy devices and publicly state that none of them will ever work. He exhibits Machiavellian, psychopathic and narcissistic styles which degrades free energy researchers and inventors. When we declined his request to come to the Taiwan build he started his business with us. He told someone he wanted to give us his phone number so he could talk

to us about the bad write-ups he was giving us. When we contacted him on Skype for his phone number he said “ah, um, I’m getting my number changed and I’ll give you the new number when that happens.” Of course, he never did.

Another troll gets paid per click to create YouTube videos using tactics from the Joint Threat Intelligence Research Group Training Manual to harass and discredit free energy inventors. This one is one of the most active negative commenters on several blogs, forums and YouTube videos. His work has achieved a reward from the revolution green website where his ‘dark side’ is praised and celebrated.

How to Protect Yourself

- Avoid reading comments until you know how to spot a troll. If the comment uses one of the techniques outlined above, be wary of anything that person has to say. It takes a lot of experience as well as knowledge of who the leaders are in this community to sort the trolls from the honest comments.
- Know the sources you are reading. Who is the author? What is their background and education? Is their body of work consistent or are they fostering an agenda?
- What sort of research and testing have they done on this topic and does it make sense? If you’re not into science, this may be a challenge, but start looking for other sources that agree with the author and discover what is behind them. You’d be surprised how often a reputable university backs up or is the

source of research behind a controversial topic.

What about their personal experiences? Many authors who were on one side of the fence and now on the other (for example, those posing as free energy advocates but who discredit all free energy devices) are very credible, since they've seen up close and personal some of the research themselves.

If a comment uses any insulting language whatsoever, that should be a red flag. There is an objective right and wrong when it comes to the way things are posted. Moral relativism (thinking that nothing is right or wrong, it's all based on perspective) is part of the problem not part of the solution. Insults and name calling are NOT harmless. They are dangerous tactics used to control and manipulate people. If commenters wish to be taken seriously, they should put forth the effort required to intelligently express themselves without harming others, or they should not comment at all. Any commenters exhibiting this behavior should be immediately discredited along with all of their content.

It is Our Responsibility

Internet trolls are not just annoying people that are difficult to deal with. They can often be paid contractors or employees whose purpose is to unfairly shift the conversation to an organization's advantage. They are well funded, dangerous corporate shills who ruin lives,

careers and reputations based on falsehoods and half-truths. They are gaming your opinion to achieve their own profit motives at the expense of your right to know the truth. Most importantly, they are trying to get you to doubt your own knowledge, and brainwash you to give your consent to their control system over our lives.

In the case of clean energy, corporations who profit from old technology will never want to make themselves obsolete by allowing free energy to happen. They spend billions of dollars to manipulate the masses through covert online operations to discredit the existence of free energy.

It is up to the people to research and develop free energy, because the corporations will never do it. The inventors, engineers and researchers doing the work are doing so on shoestring, personally funded budgets under the duress of covert online operations that destroy their reputation and funded by a 600 trillion dollar industry.

Energy Weapons

Electronic Harassment

We're going to move into Electronic Harassment. Specifically, we will discuss the underlying infrastructure that enables this population-destroying platform to operate. It is important to understand that what we are dealing with is a de-centralized technological network that is covertly managed by both state and non-state entities - the genre of which is the result of both Nikola Tesla's technology, and Nazi and Cold War government research.

In the military industrial complex playing field, directed energy hardware and research and development is expensive, yet highly funded. Hence, buyers of the technology we are about to describe tend to be governments, corporations, well backed private foundations, and other secret organizations. In the black market, it's the platform of choice for despots, well-funded fascist movements, and contracted hit squads. In many countries, this has resulted in the rise of judicial-usurping criminal fascist mafias that roam throughout society,

removing and culling political opponents, whistle-blowers, and other lawful citizens.

The weapons deployed are silent and can be hidden away from the target (as are its operators). Unchecked, the opening of this seductive Pandora's box will lead to the collapse of nations and economies, create civil wars, and eventually global conflicts. So it's really all connected.

Directed Energy Weapons

First we'll start with a brief overview of what directed energy weapons are, and then go deeper into some of the technology. Although some of these technologies are very ingenious, you will also see the damage and destruction such devices are capable of causing.

Electronic Harassment is the use of electromagnetic devices to harass or kill another human being. These devices are also known as 'soft kill' weapons because they tend to be deployed on a target over a long period of time. The intended outcome is to make it difficult to prove cause and effect. Directed Energy platforms send pulsed signals to the brains of targeted individuals in mind control programs in order to remotely stimulate their brain then process the response in real time using a technique called Remote Neural Network Monitoring. This is a method of collecting data on the physical, psychological and electro-chemical processes of the target's brain (and nervous system) by the use of instruments that remotely transmit energy to the target and collect the returning energy for analysis. Applications for such technology include:

- erasing thoughts and memories resulting in short term memory loss
- implement Voice-to-Skull technologies to disrupt the human psyche
- broadcast negative (dark) Neural Linguistic Programming (NLP), using threatening abusive phrases to control thought patterns and behavior.
- disrupt sleeping patterns
- remotely hypnotize the subject

In recent years, the number of victims who claim they have been on the receiving end of such technology has risen to an estimated 3 million individuals worldwide. However, no one really knows the exact number. Some witness accounts also cite satanic or occult

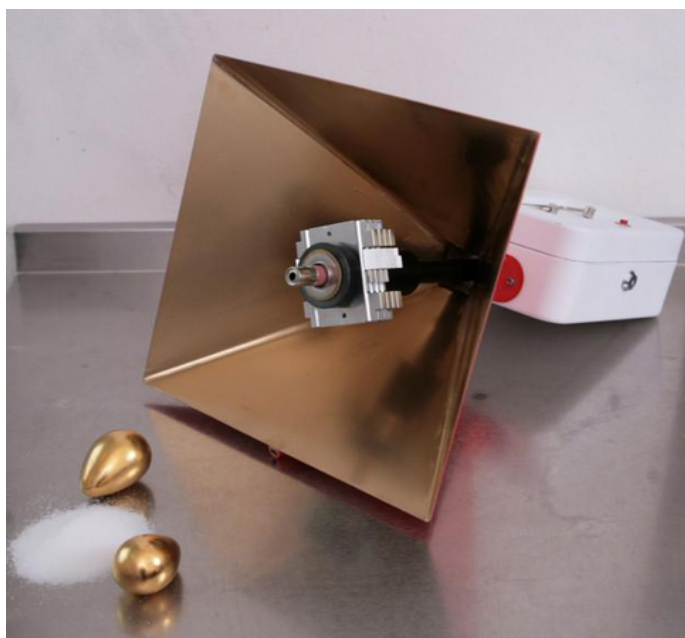
activity associated around their electronic harassment (receiving end of a demonic attack, night terrors, threatening 'voice' signals, etc.). In response, there are also a growing number of 'Targeted Individual' support groups and specialized investigation teams online.

Interestingly, there appears to be an occult angle to the topic of directed energy and broadcast signals, which would be consistent with findings from the testimony of trauma victims of both Psychological Warfare and Satanic Ritual Abuse (SRA).

On a practical level, we can understand the actual hardware that is deployed in this program. If you understand how a microwave works, then you have a good idea of what's being used against you if you become targeted. It's that simple, but just at a much lower energy density and longer period. People normally use microwave ovens to heat their food, coffee, etc. Think about what materials seem to be affected within the microwave oven. We have all heard that you should not put metal objects in microwave oven right? This is because the metal object will start to emit electrical discharges violently and catch fire, possibly destroying the microwave oven.

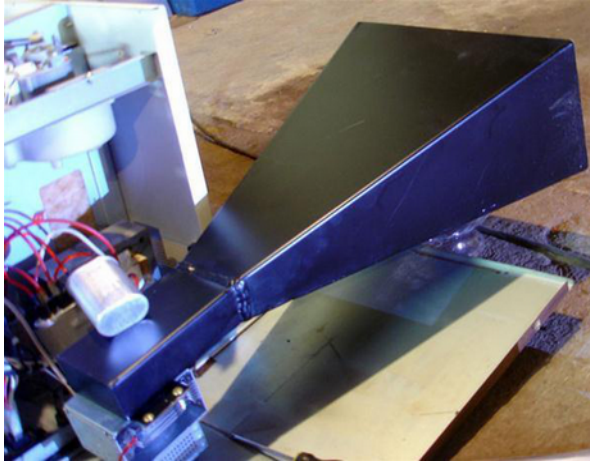
Now, we all have metals that have accumulated in our bodies during our lives from environmental factors. If you are exposed to microwave energy in small doses over a long period of time, what happens?

We are all living in a sea of microwave energy with our smartphones, wifi laptops and routers. Each electronic device generates microwatts or milliwatts of energy over its period of use. Throw in the cellphone towers that need to radiate enough power to be in contact with all these devices within a town or city and you have the recipe for an impending health crisis. This is also the technology that has been turned into a weaponized platform.

This is an example of a basic microwave gun. Note the gold trapezoidal cavity. This is called a horn. The open end of the horn is where the harmful directed energy is emitted. With such modification, your consumer microwave oven could be turned into a very dangerous and lethal weapon.

Did you know there are devices online you can actually buy as 'dispersion tools' to disperse or kill rodents, bugs and the like? These devices are actually acoustic (sound based technology) and are not electromagnetic in nature, but still focus energy to a spot or area. The parabolic dish is an example of an ultrasonic transmitter. Ultrasonic transmitters come in all shapes and sizes.

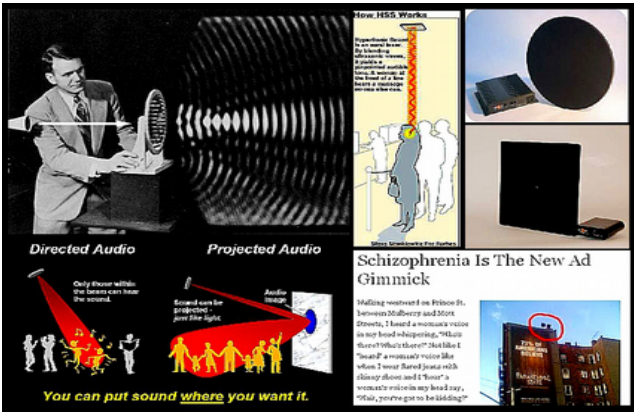


Acoustic device mounted on armored police vehicle

You've probably have seen flat rectangular panels mounted on the top of armored police vehicles for crowd control. These panels are basically high powered speakers that can emit extremely focused beams of acoustic energy onto a crowd to disorient the crowd and induce them to leave the area. Extremely effective, this and similar devices are classed as non-lethal weapons. However, if you research the case studies of its practical use in urban scenarios, you discover that people can, and have, suffered permanent deafness when exposed to such devices.

Voice to Skull Technology

We're now going to discuss what has been loosely called voice-to-skull technologies and how for over four decades of research and development has advanced the art to a science, allowing any skilled operator to place voices (intelligent) signals within proximity of the cranial cavity of a target. Again the mode of energy transmission of the devices can be either acoustic or electromagnetic.

This particular technology is an ultrasonic emitter that is able to focus a beam at one particular spot in the room so that when you step over that spot only you hear the transmitted noise. Pretty neat! However, the true state of directed energy technology has since advanced far beyond the use of acoustic technologies so that the same thing can be done with combining multiple electromagnetic fields. To make things more interesting, the beam or point of intersecting fields is no longer just confined to a spot on the floor, but can be put on a person of 'interest'. The image above however, shows the proof of concept that one can create localized effects in a specific area with directed energy and yet no one else experiences those effects.

Testimony of V2K technology victim

Okay, I will now share with you a testimonial from an individual that was very popular in the New Age circles. Greg Giles was a popular and long established New Age blogger. In 2015, he made a public statement that he would no longer take part in the New Age Movement. He said he was 'under the influence', and a victim of Electronic Harassment. He claimed that he was enduring gangstalking, and had suffered from electronic harassment where he claims to be getting 'voice' signals beamed into his head. His testimony was important because he was seen as a leader and guru among many in the New Age Movement. It also highlights the problem of following gurus, especially if they are led by external influences and they don't even realize it!

We are living in a time when being able to think for oneself can be life-saving. Of course, we all need discipline in our lives, whether it's spiritual, martial arts, etc., as it keeps us grounded and strong. Then you won't have to fall victim of being deceived by vulnerable individuals who too may be misguided.

There is a growing consensus by those who were deeply involved in the New Age Movement that it is and always was manufactured with a direct connection to the occult. And now we're finding evidence that groups closely connected to governments are projecting things into charismatic people's heads to make them spew disinformation to deceive their growing audience.

As you've just read, one of the New Age leaders that was doing channeled messages from the Ascended Masters and the like, came out and said that he was a victim of mind control through his electronic harassment. Basically, everything that was said was 'put in his head' , and was told to relay the message. At the time, he believed it was real. He thought he was hearing from higher dimensional beings. Now, I'm not saying that communication with The Creator doesn't happen, but I submit to you that it is just as plausible that the equipment we're describing is the culprit.

The next three transcripts are taken from three news clips. The first transcript describes the acoustic technology a research scientist (Dr. Pompey) designed that is able to beam sound to specific points within a library as an experiment. The second transcript describes a speech

recognition system that is so sensitive, it is able pick up the spoken word of the test subject simply by thinking of the word (mouth is still closed). In the final transcript Dr. Lin self-experiments inside a laboratory with a microwave emitter and verifies that intelligent signals pulsed by the microwave horn can be interpreted by the brain.

Beginning of Transcript 1

Narrator: This man Dr. Joseph Pompey he's got a thing about annoying people with sound.

Dr. Pompey: Hey you, mam, man, please wake up. They're sleeping in the library.

Narrator: Most people of his age don't know much about sound. The most anti-social they can get is turning their cars Hi-Fi up in a quiet neighborhood. Dr. Pompey has studied sound for so long he's got letters after his name and he came out with something a bit better.

Dr. Pompey: That's not a speaker system, now this, this is a speaker system.

Narrator: The whole idea of his sound spot light system is to make sure that only one person can hear him even though they are 20 meters away.

Dr. Pompey: Hey you there, you on the laptop, are you downloading illegal files through the library network? I hope not. Hey you there

studying, miss can you hear me? I think it's time for a break. Hey you looking at CD's we're watching. Ha-ha.

Narrator: Taking the mickey out of innocent readers might seem a bit childish but there's a reason why Dr. Pompey comes here to test his kit.

Dr. Pompey: A library is about the most sensitive area you can think of for background noise and generating sound that people don't want to hear. But with the audio spot light, we can deliver sound specifically directly to people within the library without bothering the other people that are reading quietly. One of the things we can bring in a couple of Latin dancers and send them some hot salsa music they can dance all they like in the middle of the library to all the music they want without bothering the other people nearby who want to sit read or work quietly.

Narrator: The system works like this: first your voice is transformed into high frequency ultrasound so high no one can hear it. Ultrasound is highly directional so like a torch it can be pointed at someone standing a long way away. Although they cannot hear the ultrasound it causes secondary vibrations in the air around them and it's that sound the person hears.

Dr. Pompey: So if you imagine you're in a room and I shine a flashlight at you it's very bright for you, but it's very dark for everybody else. Much the same way the audio spotlight creates a very

narrow beam of sound. You can shine at a listener, they hear it very clearly and it doesn't create noise that might bother other people in the same space.

Narrator: It's already being used in museums and soon Dr. Pompey hopes he'll have his system in TV sets so that only one person in the room can hear it. The others can get on with something much more boring. But whatever its practical use is it remains a great toy.

Dr. Pompey: Hey, excuse me miss, that's a really nice shirt you've got on.

Man: These are called electro myographic signals. The signals are picked up by electrodes planted on the skin.

Man: The electrodes basically look like this. They are tiny little pads much like you have in a doctor's office. So if she said "The future" out loud

Girl: The future.

Man: We have the signal that's corresponding to that muscular activity. But with sub vocal speech she doesn't have to move her mouth. She could say that word silently. So she would say "the

future” silently. Here, she said “the future” but she didn’t move her lips and you can see that there’s still the same signal being picked up by the electrodes underneath her throat.

Narrator: Once the electrodes capture the signal, they can be transmitted as if through a cell phone to someone with an ear piece receiver.

Man: So the newer sensors are the size of a dime and they will continue to get smaller in the not very distant future.

Narrator: In Chicago, Illinois, a world authority on microwave hearing shows how it could work.

Professor Lin: I’m hearing a micro pulse like a click. It sounds like a chirp with a tonal quality to it.

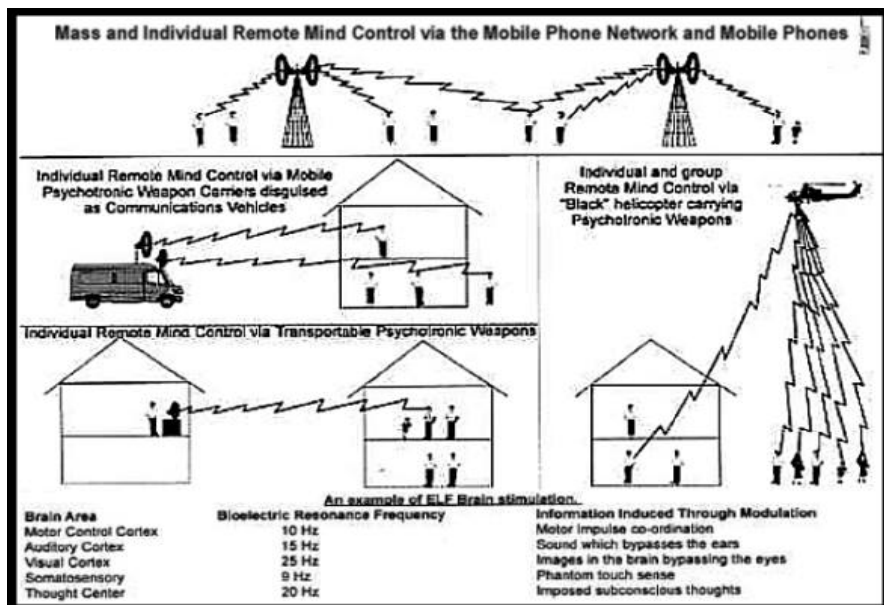
Narrator: Professor James Lin is hearing sounds that aren’t there but he’s not crazy. Pulses of microwave energy are being generated and fired at him from behind.

Professor Lin: Microwaves can be heard depending on the individual, depending on the hearing acuity of the individual. Individuals with say fairly normal hearing can hear microwaves at the quite a low level.

Narrator: The energy of the absorbed microwaves cause brain tissue to very slightly heat up and expand causing a pressure wave to be picked up the hearing mechanism in the inner ear. Professor Lin is far from hearing voices. But it could be possible to send coded signals to an agent this way.

Man: The brain is an electrical organ. It is susceptible to electrical signals. Since microwave is electrical therefore in principle one could embed or encode information in the microwave signal.

Modes of attack with directed energy

Mode of Attack for a Targeted Individual

We will now uncover the platform by which a victim of electronic harassment is targeted. What you see here is a diagram of the different modes of attack they experience or TIs complain of. One attack vector is when the victim is walking by (or lives near) a cell phone tower and they perceive the strength of the signals (voices) to be stronger. This is a good method to determine if you're experiencing V2K based harassment. Remember when I said different electromagnetic signals need to mix before your brain can perceive the signal? This mixing of signals is called heterodyning, and it has the ability to piggy back on all modes of transmission in the microwave band.

Microwave beams can travel through the walls of your house from outside your home. One possible source of such equipment can come from a vehicle or unmarked van parked across the street from your house. Brick and mortar walls are semi-permeable to a microwave beam, so the beam can travel through them. This form of attack is almost impossible to prove without electromagnetic measuring equipment.

Corrupt public workers enrolled in neighborhood watch or fusion center programs could use their job position to install such equipment around your property and tell the entire neighborhood that you're a criminal and under surveillance. Also, sometimes your neighbors may be part of the program; usually there is a financial incentive involved. A person assigned to monitor you may rent out an apartment across the street from you. In truth, there are many places to hide directed energy equipment, especially if the perpetrator feels protected by a cult or organization. Helicopters or aircrafts flying overhead can be used as well.

There was a case in the United States where a targeted woman won a court case. She was a targeted individual and she had to hire a technician that dealt with installing satellite dishes to basically do the investigation and found that a neighbor took their satellite dish, redirected it towards her house, and he was using that satellite dish as a mode of transmitting microwaves...over a long period of time. The hired technician triangulated the signal hitting her house and recorded

the signal for evidence. He then flew a drone in the direction of the signal and located the property that had the adjusted satellite dish. The evidence was enough to get the police to arrest the perpetrator in his home and win the court case. It was said in the interview that the guy looked like he'd just aged 100 years because he so scared that he was found out.

The last case illustrated how almost any microwave based technology can be hacked and made into a weapon in plain sight. Whether the attack comes from a re-directed satellite dish or a microwave oven with the door removed hidden in a parked car, these are common modes of attack because they can be placed in proximity to many homes during the day. If you're in your house for most of the day, you could be getting a good, lethal dose. Lookup SEE WINNING TI COURT CASE: KATHLEEN WATTERSON for the interview online.

Considering what you just read, I'd like to ask you a question. Suppose a technician has an energy weapon that is being beamed at you while you're in the discomfort of your home. Is there anything you can do? The answer is that there are many things you can do. There are instruments that you can use to measure the environment around you and determine where the signals are coming from (called Direction Finding). There are wearable items that you can put on your body. There's a whole bunch of stuff you can do to physically create areas around your body, your person and your home in order to defend against these things. So it's good that you know there are tools that

you can get and use in order to figure out where the signals are coming from so you can protect yourself and your family. The only limitation is one's budget and knowledge level. In most cases, a hired technician or forensics team could be of use in this regard.

Physical Side Effects of Electronic Harassment

There are numerous side effects from being exposed to electromagnetic radiation. Those who claim to be victims of directed energy testing and experimentation have suffered from the following symptoms:

- Heated body, feeling sick like having the flu
- Headaches that come and suddenly disappear
- Stinging sensations like a fly or mosquito
- Blurred vision
- Irresistible coughing
- Very serious diarrhea
- Heart attack/cramps

There's a long list of all these different effects that we have but the damage to the body in the image below goes far beyond that.

Victim of Microwave weapons used in Iraq War

Veterans returned from the first Gulf War in 1991. Nearly a decade afterwards (with a maturing internet audience) they began to give testimony of what they witnessed and experienced. Images like the one above were smuggled out of the war zone. There were soldiers who were experimenting with exotic weaponry and the charred remains is a case of someone who was hit with one of these weapons. It was a microwave weapon that seem to only char the flesh but clothes and surrounding material was left basically intact, unburned.

I thought this was important to illustrate because electromagnetic weaponry have unique effects and they seemed to be very similar to the things that were happening on 911, as Dr. Judy Wood so eloquently described in her book *Where did the towers go?* The illustration is there to show people that it's very unique and an extreme case. But what we're talking about today are weapons that (at least for the

moment) kill you slowly over time so as to avoid any direct proof that you've been killed in such a manner.



John Hutchison

The Hutchison Effect

John Hutchison is a Canadian inventor who in 1979 discovered 'The Hutchison Effect.' When John's Tesla coils, electrostatic generator, and other equipment created a complex electromagnetic field, heavy pieces of metal levitated and shot toward the ceiling, and some pieces shredded. Upon analysis and thorough investigation, the Canadian government dubbed this phenomenon the Hutchison-Effect.

The Hutchison-Effect happens when complex high voltage electromagnetic and electrostatic fields combine in a region space as to create anomalous effects on materials within. Effects observed include: inertial levitation, transmutation, jellyfication and embrittlement of metals.

While the effects of Hutchison's experiments are intriguing, it is unsure if anyone has been able to successfully replicate them. One of the only things that come close to replicating some of these effects are the effects on the steel from the World Trade Center on 9/11. Dr. Judy Wood's book fully explains the exotic nature of this phenomenon.

The authors of the book feel that it is important to mention that a dramatic change has been witnessed in the demeanor of Mr. Hutchinson. We suspect that perhaps someone ‘got to him’ which is all we can think of to explain his bizarre behavior. Barrie Trower Royal Navy

Royal Navy ex MI5 Agent Testifies about Energy Weapons

The next transcript is Barrie Trower, an ex MI5 agent. He also served in the Royal Navy as a specialist in microwave technology during the Cold War era and basically, he gives his account on the current state of

the technology that he is aware of. He gives disclosure to the general population on the advancement of this technology because he is clearly concerned and is trying to let people know what's really going on.

2010 is when the clip was made, so you'll recognize there's been advancement since then. He discloses what they're using on the human population. All of this is not known, but we are putting together the pieces as this is not covered on main stream, obviously. And a lot of it, if not all of it, completely violates all kinds of treaties.

Beginning of Transcript

November 13, 2010, Interview with Barrie Trower: The Dangers of Microwave Technology

Narrator: Barrie thank you for joining us.

Barrie: Yes. It's my pleasure. It really is my pleasure.

Narrator: I understand you have wealth of experience with microwaves. Can you begin by explaining to us how you began your career in microwave technology?

Barrie: Of course. In 1960 I was in the Royal Navy and I worked partly with the underwater bomb disposal unit, partly with microwave warfare and some of the other time with radar. Microwaves were involved in all of those three different areas. So whilst I was in the Royal Navy, I trained in all aspects of microwave technology and as

anybody will tell you that's been in the forces, the training you receive is second to none. You practice, you talk about it all day, and you sleep it. And so since 1960 I have been involved in all aspects of microwave technology. After that a part of my job, because I had microwave expertise, was to question captured spies during the Cold War when Russia and America were within seconds of global nuclear war. And microwaves by then were really sophisticated stealth weapons. And a part of my job was to find out from any spies who had been captured what the current knowledge was in that part of the world.

Narrator: This technology is truly frightening. Really frightening.

Barrie: This is why its microwave weapons were introduced from the 1950s, 60s, 70s to present day. And this is another level of proof. They are so effective if you're not in a hurry to get rid of somebody they are so effective as a stealth weapon to beam somebody, and this has been done many times. And it's reported. You can beam people you don't like as a government to give them cancer, breast cancers, neurological illnesses, you can choose what you want them to get.

Narrator: You can choose?

Barrie: Oh you can choose. You can choose which pulse frequency you want to affect the brain with. You can choose the level of microwave radiation and the speed that you want them to become ill. It's really is a perfect stealth weapon. And all you need to do is rent a

house opposite someone you want to get rid of or a group of people you want to get rid of and just beam them. The most famous case during the Cold War was the Moscow Embassy Siege where in Moscow they beamed the entire American Embassy and gave them cancer.

Narrator: Did they cause cancers in all the staff or in a lot of the staff?

Barrie: Most of the staff, the children, most of the children got leukemia. The women developed breast cancer. The gentlemen developed cancers. I think after about 18 months, the entire staff was changed. And then a following 18 months the entire staff was changed again. And by that time people realized what was going on and they found that they were being irradiated by microwaves and rather than say oh isn't this disgusting what have we sunk to? They thought isn't this wonderful! Let's develop this for ourselves. And governments today are still perfecting microwave warfare.

Narrator: Still to this day, they are working on the weaponry.

Barrie: Still to this day, 2010 they are still perfecting the pulse frequencies. It's gotten very very sophisticated. And the pulse frequencies, how long they can transmit, whether it can be one country to another. Bouncing the microwaves off the ionosphere. So you don't even have to be in the same country.

Narrator: Bouncing the microwaves off the ionosphere. A lot of

people wouldn't have heard of this technology. They are talking about the HAARP...

Barrie: If you have a super transmitter, the microwaves if you beam them, it's only simple basic trigonometry.

Narrator: Yea.

Barrie: But let's say I want to bring economic ruin to a country that grows all of the world's wheat. Okay, all I have to do is beam microwaves up to the ionosphere which is like an invisible ion cloud around the planet. The microwaves going up at a set angle will reflect down onto the country. And if I continuously beam the wheat in this field or the cattle or the sheep, I can harm, I can reduce the immune system of the plants so that they won't be healthy and they will die. And I can stunt their growth. And I can bring economic ruin to that country. I can harm all of the animals, the cows, and the sheep. It's so easy to do, you only have to push a button. And you can bring economic ruin to a country.

Narrator: Which countries have this technology already available? Is it all the countries in the world or just a couple of them?

Barrie: It may not be a wise thing say on a live broadcast but you can take my word for it that I know at least 2 super transmitters in the world that have this capability. And there are probably more in areas that I do not have access to. I cannot go to. But I know there are at

least 2.

Narrator: I would like to just go back just a bit.

Barrie: Of course.

Narrator: Back to your early days in the military, this technology was used by the British Government?

Barrie: Okay...

Narrator: It was used by the British Government against terrorist groups?

Barrie: We have 8,300 papers and I have knowledge of 2,300 myself. And what the governments found was that you could induce illness by changing the pulse frequency - like Morse code of the microwaves going into, and interfering with the brain. By specializing on the pulse frequency, you could induce psychiatric illnesses to the point where a psychiatrist could not tell if it is a genuine psychiatric illness or an induced psychiatric illness. So what you can do theoretically is you can target an individual's brain. They may have auditory hallucinations where they hear things which are actually quite common with microwaves, or show signs of schizophrenia. For instance 6.6 pulses a second can induce severe sexual aggression in men. So you could induce somebody to commit a really horrific sexual rape. Technically what you could do is have somebody committed to a psychiatric hospital or a jail for a crime just by

somebody saying that they had a psychiatric illness whereby they didn't.

Narrator: Yea.

Barrie: There is that. You can target other parts of people's bodies. You can target the heart and cause heart seizures. You can target the lungs and cause bleeding. You can target, if you're clever enough, some of the essential glands in the body that control all of the whole organ systems. So if you have dissidents or people that you don't like as a government, it's very very easy these days to irradiated them and either have them wind up in jail or in a psychiatric hospital. And of course there's no come back on you.

Narrator: Yea. Now these weapons that the governments are still using are they more powerful than for example, the Wi-Fi I have in my front room or my cordless phone or a mobile phone transmitter?

Barrie: No, in fact actually the power is slightly less.

Narrator: Less?

Barrie: The power is slightly less. The difference is the way you might use WiFi, you might go in after work and do a couple of hours and then leave and the WiFi is going out in all directions. Here they are targeting you probably with a beam. And it is on you all day. It can follow you everywhere you go and it can target you when you're asleep as well. So you're really getting a concentrated dose. It's a bit

like putting the light on in your house and sitting with the light or have somebody follow you with a search light and beaming the search light on you all the time. So, there is a difference between that. In fact the power can be less, it just takes longer.

One specific paper from the government that lists all of the illnesses you can get from microwave sickness includes severe neurological disorders. We have government documents that actually say this needs to be kept secret from the western governments because it will affect the efficiency of the military, the weapons industry, and it will also affect industrial profits.

Narrator: We have the government telling us...

Barrie: This is the United States Defense Intelligence Agency advising the western governments to keep this secret so that they can protect industrial profits and military functions.

Narrator: Kind of startling really, isn't it?

Barrie: It is so horrific that if it wasn't real, if somebody wrote a book on this, I would say this is stupid you could never make up a story like this. And it all goes back, it goes back to the 50s, 60s, and 70s when microwaves were found to be such a perfect weapon and so dangerous to the military that the United States Defense Intelligence Agency told the western governments to keep this quiet. And they did. And this is why we have this.

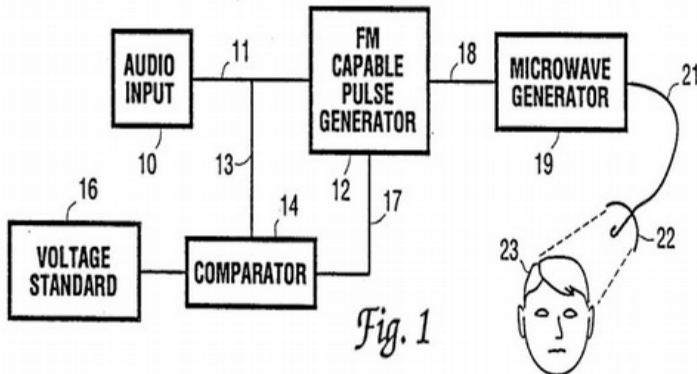

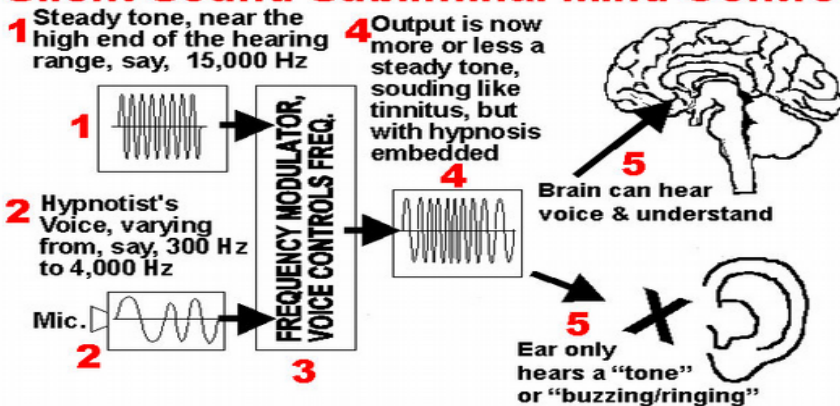

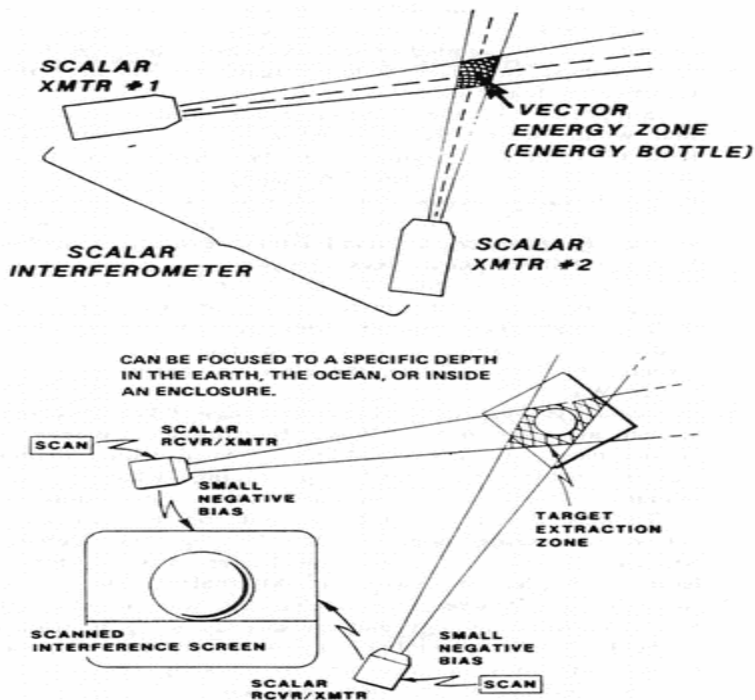

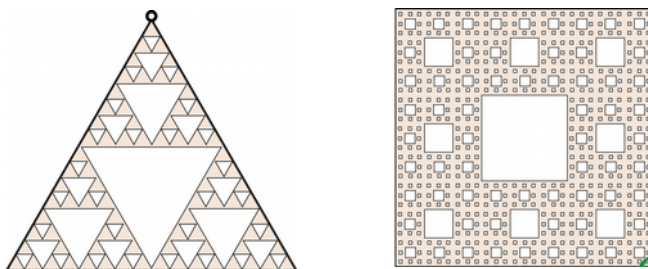

You can have all kinds of effects depending on what power and pairs of frequencies you apply. Now imagine that the transmitters 1 and 2 in this diagram are two different cell towers. If you had the means of controlling a signal from two or more such microwave sources, imagine what you can do with the technology. This is basically outlining the general idea behind that.

Fractal Antennas

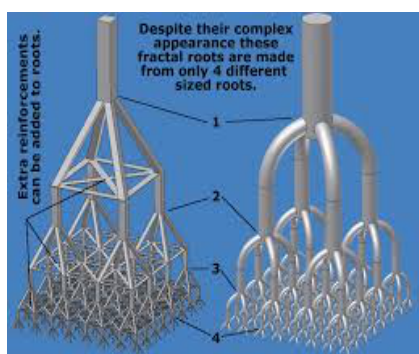
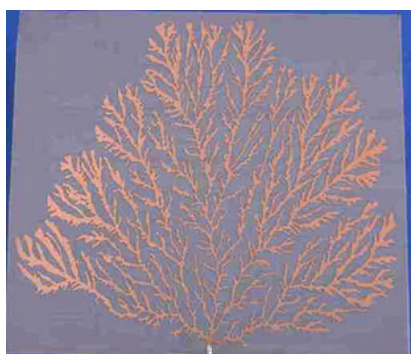
We will now talk about tracking technologies, starting with antennas. You have antennas that you hang on your house (about a meter long) that are used to pick up terrestrial signals of a certain size.

New types of antennas are on the market and in development that are truly amazing! These fractal antennas are much smaller and can fit in the palm of your hand with even better bandwidth. These little tiny antennas have a performance like much larger antenna arrays, so it's very powerful!

As you can see, the patterns repeat over and over again. That's the secret! In general, the idea is to make similar patterns with conductive material (the antenna) and nest them together in one continuous design to maximize the length, area or volume of the structure receiving the signal. The material can receive or transmit electromagnetic radiation within a given total surface area or volume. This particular antenna is on a PCB (circuit board). The copper traces are shaped like a tree:

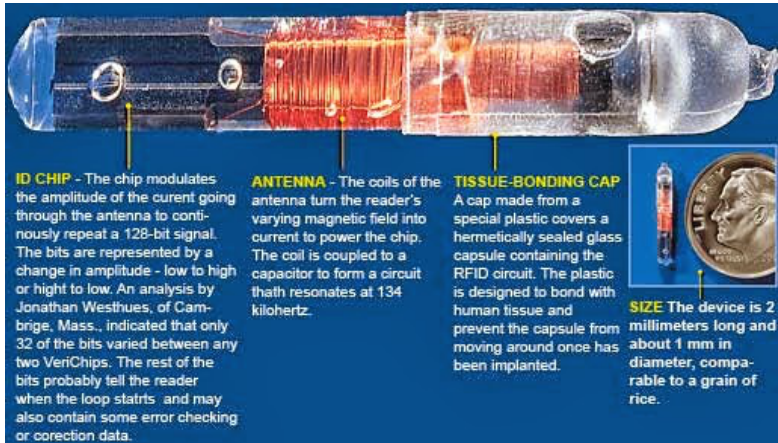


Examples of 'organic' looking fractal antennas

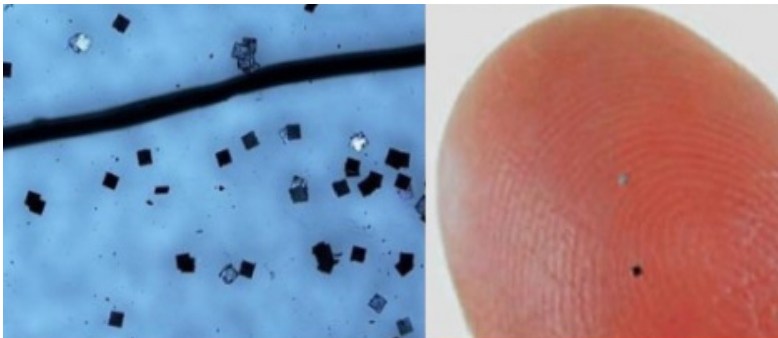
On the second illustration it's like a theoretical 3D antenna made of metal that looks like a root structure or 'natural looking' tree branches. Indeed, repeating patterns are ideal antenna structures and now you're going to see why this is useful.

RFID Chips

You're about to see how far this technology has really progressed. Although many of us have already seen the tracking antennas the size of a grain of rice that can be injected with a syringe, the size of these delivery systems have since advanced beyond this stage.



Rice sized RFID microchip





Tracking Technologies Microchip Dust

This one really creeps me out. Okay, the size – it's microchip dust! So the image on the left is a chip called a 'Mu' chip by Hitachi. They're really proud of these chips. A similar technology is called a smart chip. The smart chip relays certain Radio Frequency Identification information. It is publicly stated that the smart chips are used as sensors. So that if you spray them in the ocean or in the clouds you can get a virtual 3D representation of the environment.

What you're seeing is leading technology. What happens if you take a powerful microwave emitter and a billion trackable Smart Dust particles that receive and transmit data, while it free-floats in the environment, possibly being inhaled and/or even consumed? And here's the thing, an antenna is no longer 'the thing' you have to adjust on the top of your TV or move back and forth or on your radio. Antennas have become unrecognizable from our past experiences.

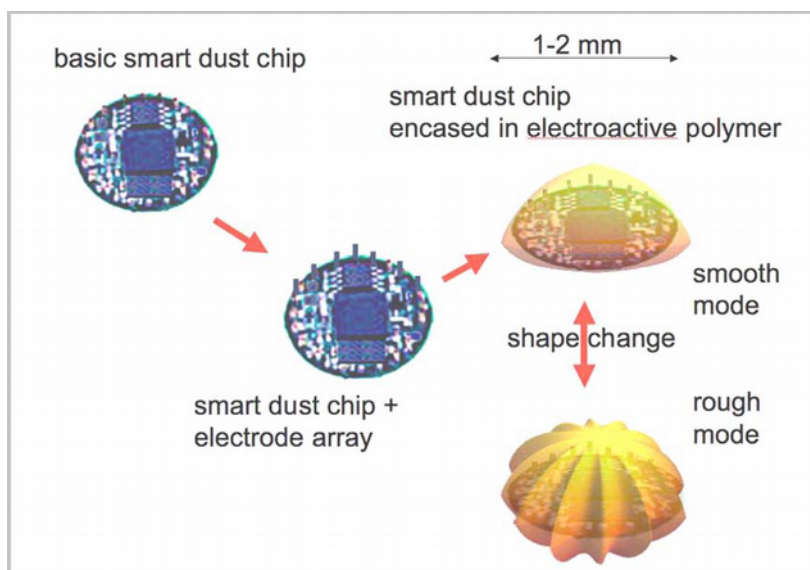

Billions of Smart Dust antennas can act as one antenna. These microchips are programmable and can perform many basic tasks. If we were to expand our thinking a tiny bit, just like as the 'rice' chip is used to track pets and animals, it's conceivable that Smart Dust floating in the air (and water) could find its way inside of us, thus turning the population into trackable bio-antennas. We haven't even touched on the bio-accumulation of metals we all have inside of us!

As can be seen in the previous images, many of these chips are floating in a vial of fluid. This is at the microscale (objects whose length can be measured in millionths of a meter). It can easily be dismissed as sediment in the ocean, stream, or at the bottom of a beverage bottle. So now we get down to another level. Yes, it gets even smaller! Now enter the nano scale. The image (below) is of a diagram that was taken from a research paper.

One study details how these chips have a 'polymer-like' coating around the package so that the human body's defense system will not attack it. An important fact to remember about all nanoparticles (objects whose length is one billionth of a meter) is that its size enables it to pass through the blood-tissue barriers of living cells!

The picture above isn't just a nano-chip but nano metal particulates. There is a growing body of research about the effects of metallic nano particles in human beings. For example, in one study the doctors basically concluded that they had concerns about the effects of nano particles being accepted by the body's blood-brain barrier! Now, let's be honest, when doctors (a very conservative bunch) say such things, you can imagine the implications are probably two or three times worse.

In summary, metallic nano-particles absorbed through your skin (the largest organ in the body) not only can lead to unhealthy bio-accumulation levels of heavy metals, but can also turn you into a walking transceiver in the process. It's toxic to the body, and can be

used to turn you into an antenna so your enemies can point weapons at you. With this new perspective, we will now briefly move on to the subject of chemtrails.



Chemtrails

Chemtrails and HAARP

The topic of chemical spraying in the sky is now becoming a health, environmental and political issue globally. Since the late 1990's, there has been a growing push-back about aerosol spraying in the skies. Thousands of people have started noticing grids, parallel lines and crisscross patterns in our skies. Initially, governments and agencies dismissed the claims and evidence as contrails to an ever awakening public.

Contrails are composed mainly of water that freezes and condenses into ice crystals that form pencil-thin vapor trails. These trails

disappear in a matter of minutes at higher altitude. Chemical trails, however, can stay for hours in the sky, while spreading out to form large areas of sun-blocking cover. It's now known (based on extensive research available online) what the chemical composition is of these aerosols.

Chemtrails can contain any or all of the following: smart-dust, weaponized fungal spores, human blood, pathogens, metal oxides and other heavy metals including manganese, strontium, barium, and aluminum. The levels of these particulates are often hundreds if not thousands of times beyond the acceptable limit for being considered toxic. Fine toxic particulates in the air have also been linked to lung cancer, cardiopulmonary mortality, and chronic illness in children as cited from reports written by The Journal of the American Medical Association (1998).

Although theories continue to remain as to why these operations are occurring, many are now concluding that it involves dominance of the planet's biosphere and population control. There are several official documents that point to aerosol spraying as having applications in geo-engineering and atmospheric based weaponry.

'Global Warming and Ice Ages' was a government sponsored report that basically floated the idea around that spraying millions of tons of aluminum oxide particles into the atmosphere could create a 'sunscreen' for the planet to help curb global warming. A major U.S. Congressional study titled *'Policy Implications of Greenhouse*

Warming’ also supported this theory to mitigate global warming. Concerned scientists like Ken Caldera (from Lawrence Livermore National Laboratories) however, believed that this type of operation could damage the biosphere and cause serious health concerns. It's unfortunate that dissenting voices from highly credible professionals in the field are often ignored.

The United States has a long history of spraying chemicals on its citizenry. For example, through *'The Freedom of Information Act'*, the public were given access to find out who got sick from the spraying of biological agents over San Francisco in 1950. This is but one of many cases. The United States Air Force published a study called *'Air Force Study: Owning the Weather in 2025'*, that would essentially employ weather modification to destroy the enemy via drought, flooding or damage to crops and live-stock. The study said “one major advantage of using simulated weather to achieve a desired effect is that unlike other approaches, it makes what are otherwise the results of deliberate actions appear to be the consequences of natural weather phenomena.” The report also states that spraying certain chemicals in enemy air space can facilitate jamming radar and tele-communications systems. Interestingly, the report also claims these tactics have enormous psychological potential! Not many details were given but a picture is coming into view that these systems (both covert and private) are being deployed and tested on a massive global scale now!

There are also two good documentary films we recommend to help give you a solid foundation in this subject; *'What in the World are they Spraying'* and *'Why in the World are they spraying.'* This technology could literally skew the political, energy, and economic spheres of the planet to financially benefit those who wield it. The chemicals and smart chips in these aerosols have electromagnetic properties that are also advantageous to operations using ground-based 'super-emitters' like the HAARP research platform based in Alaska.

HAARP stands for 'High Frequency Active Auroral Research Program', and is a highly funded project focusing on altering and manipulating the atmosphere for weather and military dominance. We now also believe this technology is being used to experiment with

altering the psychological states of the population, and target their immune system. Another prime goal of this system is to establish a seamless computer link directly to our nervous systems and brains by first using chemtrails as the delivery system to get the nanoparticles into us which would transform our bodies into walking, living antennas. This sounded like science-fiction to us but from the mountain of patents, testimonies and research gathered, this clearly is the agenda. It's just a question of reliable tracking of large populations 24/7.

We will now discuss the discovery of biofilms on the skin of those who claim to have suffered from chemtrail spraying and electronic harassment.

Transhumanism: The Ascent of the New Man

According to Wikipedia: “Transhumanism is an international and intellectual movement that aims to transform the human condition by developing and making widely available sophisticated technologies to greatly enhance human intellectual, physical, and psychological capacities.”

You may or may not have heard the term transhumanism in the media lately. It has only surfaced in the last few years as the newest thing to get everyone’s attention. Transhumanism is the attempt to merge humankind with machine. The thought that somehow technology merged with our biological bodies can help us to improve and overcome limitations of our biology.

Its understandable that there are many who are are opposed to this strange movement. After all, it brings to mind scenes from Hollywood movies where artificial intelligence seeks to destroy humans. In the next section, we will be exploring just a couple of the more subtle phenomena that has been uncovered in recent years involving

circumstances where technology and biology should not be mixed.

Morgellons Disease

We round off the end of this section by showing evidence of a weaponized fungal infection that is appearing globally as an indirect effect of aerosol spraying, and the underlying trackable biofilm that is its cause. As mentioned previously, for the past twenty years many people have linked their illnesses directly with environmental factors, namely from aerosol spraying. It's interesting to note that the beginning of the modern aerosol campaign testing to stave off global warming started around the same time the internet was in its infancy. This would explain why complaints of some of these illnesses seem to be as old as the internet itself.

The sickness we will focus on in particular is infamously known as Morgellons Disease (MD). In professional circles, its considered taboo for a practicing doctor to even take the illness seriously (regardless of the endless images of infection uploaded to the internet daily). In fact, if you were to check yourself into a hospital and say you had Morgellons you would probably either be told to leave, or be given a placebo because the doctor had dismissed you as crazy. Nonetheless, due to the rising cases of this life changing illness a market has appeared in the online community, and there are independent certified health practitioners, doctors and scientists who run analyses on samples, and publish studies.

Interestingly, some of the symptoms of this disease also parallel (to a much lesser extent) those who claim to be electronically targeted with regards to physical changes on the skin, and joint and muscle pain. Likewise, the self-prescribed treatments of some who claim near complete recovery of this disease seem to also offer a new solution to those who are TIs.

Before we proceed with this subject however, it is important that you realize we are not registered doctors, nor do we claim to cure any cause, condition or disease. The Morgellons Link to Chemtrail Spraying

Morgellons disease is a dermopathy characterized by multicolored filaments that lie under, are embedded in, or project from the skin. The illness is unusual in that it contains infectious traits from seemingly different sources.

There are now independent studies of the different aspects of the infection. One study of the skin concluded something that is associated with a tick borne infection. The multicolored filaments, however, are composed of keratin and collagen that result from the production of collagen and keratin-making cells found in the skin. Spirochetes also

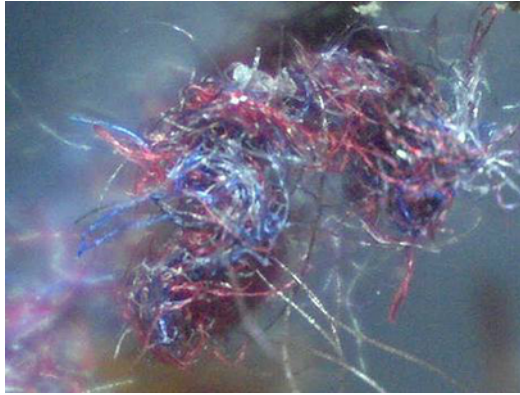
have been genetically identified as the infective agent in most of the Morgellons skin specimens.

Historically, it has been established that the Morgellons fibers and other phenomena contain structures that attach to the root sheath of hair follicles. The composition of the fibers or filaments however are not hair but rather 'biofilaments' composed of human cells, some resembling barbs that penetrate from the deeper layers of the skin. Some of these filaments grow inward from the epidermis creating structures and spreading infection.

Visible signs of skin infection include; 'frosting' of the hair follicles, open lesions with fibers and other objects of unknown origin coming out of them, and opportunistic fungal infections like Candida that seem to reappear in the long term after initial treatment. In other words, Morgellons is known to mask as other fungal and bacterial infections.

Red and blue fibers extracted from the skin of Morgellons sufferers

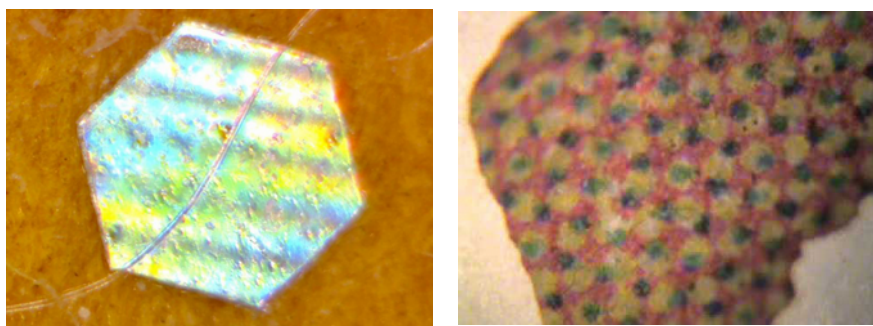

The severity of visible damage varies from person to person, and is partly attributed to the strength of one's immune system. Individuals afflicted with Morgellons have self-examined the affected tissues under microscope and shared the images in online forums and websites. The result is a searchable database of visual evidence of this

mysterious infection. If you Google Morgellons and use the image search option, you are greeted with a vast collection of research.

The most recent developments the Morgellons research community is presenting is evidence of nanotechnology being extracted from the scar tissue. In recent years, sufferers have shown what appear to be organized multi-colored RGB pixels or 'dots' on a silica base (bottom right). Also there's more evidence of Nano-structures being extracted from the skin (hexagonal crystal on the lower left).



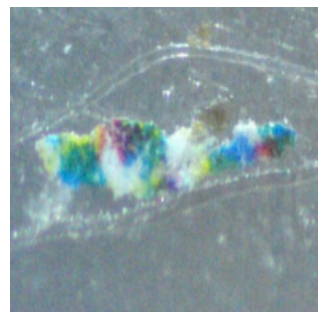
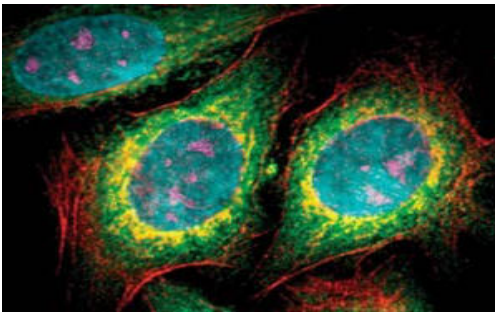
hexagonal crystal (left) and color 'pixels' (right)

What is disturbing about these images is the appearance of a manufactured-like foreign object coming from within the human body. Are these crystalline objects Smart Dust or other technology? Clearly, there exists a multi-faceted agenda behind scattering these structures throughout the ecosphere. The scale is only a few micro-meters across.

Quantum Dots

A quantum dot is a semiconductor whose use of electrical energy is confined in a crystalline form. Discovered by Loise E. Brus, who at the time worked at Bell Labs, it has properties that are between semiconductors and discrete molecules. Initially, its discovery was during research into transistors, solar cells and LEDs.

Quantum dots are currently being used as qubits (verses a binary bit) in quantum computing, and also as exotic biomarkers for medical imaging.

The research team at the University of Toronto studied the behavior of mice injected with various nanoparticles. The mice were injected with different concentrations of Nano-gold particles and quantum dots. The researchers found that they accumulate and can be observed through the skin in both the visible and UV spectrum. The quantum dot-treated mice fluoresce under UV light only. Finally the researchers noticed

that there was a direct correlation between the concentration of nanoparticles found in the skin and dose strength, and accumulations in other organs, like the liver and the spleen.

And now, Morgellons patients are finding these objects in their excreted cell tissues. Are we witnessing animal tracking technologies being tested on a global scale?

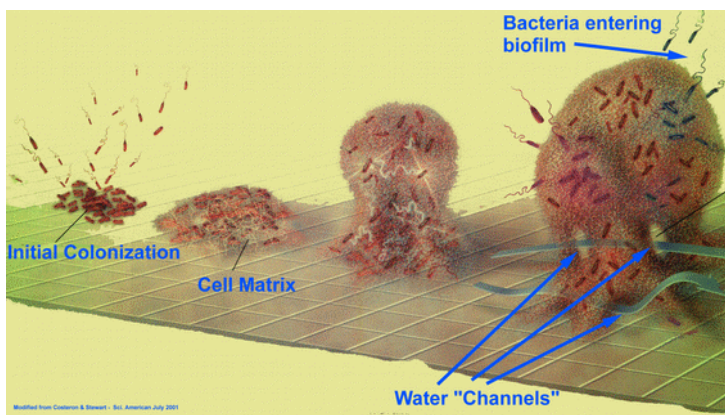
What is biofilm, has it been weaponized?

The biggest complaint among the victims afflicted with aerosol-related illnesses is the perceived 'resilience' of this 'bug' despite changes in diet, topical and internal treatments, and antibiotics. Sure, one can see that to this day, the spraying of chemicals in the air continues unabated and it's simply a problem of re-infection. Well this may be partly true but is it possible the culprit underlying the illness is invisible and more subtle than what was previously acknowledged?

Biofilms are composed of communities of microorganisms which adhere to surfaces and structures in the environment. The surfaces must contain sufficient moisture and adequate nutrients for the microorganisms to develop. The microorganisms in biofilms are usually encased in extracellular polysaccharides from starch that is processed and synthesized.

Biofilms can form:

- on soft tissue surfaces in living organisms
- at liquid air interfaces
- on solid substrates in contact with moisture

Biofilms are formed by bacteria first attaching to the surface to form a monolayer, thus changing the adhesive properties of the surface interface. This thin adhesive layer is like the base and anchor point of a

building for planktonic bacterial to form the cell matrix. This matrix grows in size and complexity, gathering more bacterium, pathogens, nanoparticles, quantum dots, etc. As the cell matrix continues to collect bacteria, other external organisms integrate into the community, creating a biofilm. It is within this environment rich with nutrients and water, the biofilm now starts to break off in 'streamers' to spread and repeat the cycle. Biofilms are also extremely adaptable to changes in environmental conditions.

Is it possible that we are witnessing infections brought from viruses, bacteria and other pathogens borne out of a fungal based biofilm that lurks virtually undetected?

Concern is growing that in fact, aerosol spraying has infected nearly the entire human population with some form of aerosol-related illness. The manifestation of physical illnesses like Morgellons perhaps is the extreme end of a broad spectrum. The populace who, for the most part, do not show such symptoms may still have the underlying biofilm laying dormant for a range of other genetic, dietary, and environmental reasons.

An individual who claimed to have been a target of electronic weaponry has recently posted his results online when taking a daily treatment of super-saturated potassium iodide over a 6 week period. He claims to have been targeted with 24/7 heavy electronic harassment, and after the treatment he has noticed the peeling of the epidermal layer of what he could only describe as a 'biofilm'. He also

noticed a dramatic reduction of most, if not all of his symptoms, including those associated with his electronic targeting.

Below you see four images of his calf (Note that before the treatment, the biofilm was barely discernable, even during baths or showers):



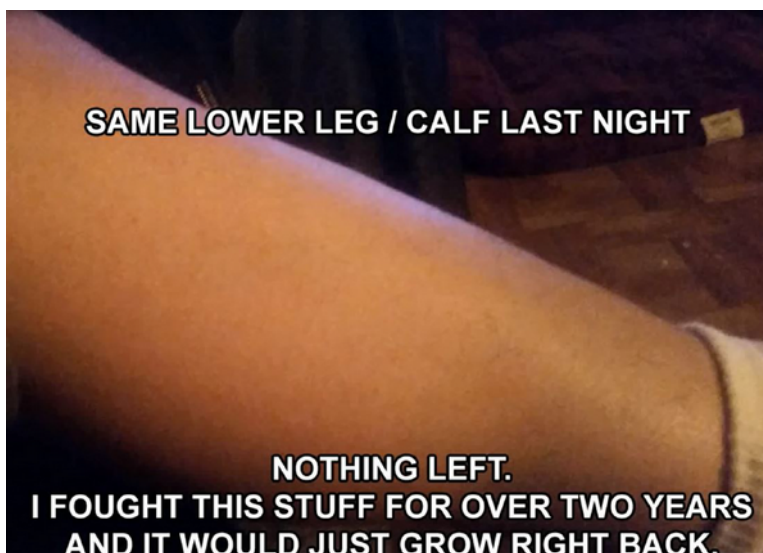
initial condition of skin before taking SSKI solution

The images (above left) show the scarring and lesions on the man's face that would flare up during his targeting. They look very similar to some of the open lesions Morgellons victims record. The image on the right is taken after his treatment. Admittedly, he claimed the treatment was aggressive and painful but it did rid him of his symptoms.

There have been other testimonials by Morgellons victims who also sought relief using super saturated solution of potassium iodide. Needless to say, in a sea of disinformation, only the burden of proof (photographic and video) evidence will bear out in the end. If it is indeed true that this solution is even part of a multifaceted remedy regimen, then this is a good thing.

In summary, left unchecked, a trackable biofilm furthers the following agendas:

- A trackable biofilm turns the individual in to a trackable asset on someone's portfolio, to be bought, sold, etc.
- Trackable biofilm technologies can in themselves be weaponized and currently sprayed to potentially decimate a population at will.
- As noted earlier, trackable biofilms can leave markers on targets that are only seen with infrared or UV tracking equipment. Conceivably these markers can then be seen from air or space-based platforms for surveillance and or aggression.

Tracking Patents

How can they get people to put a microchip in their body?

Readers of the New Testament recall a section out of Revelation citing 'the mark of the beast' where followers of Christ are commanded to refuse the mark in those final days. Ever asked yourself, how would a ruling body force everyone to take a physical mark against their will? We now live during a time of great political, financial and social

change. The populace is working to survive and sick of the scandals and corruption. Any attempt to overtly take what little the average person has risks all-out war for anyone who would get between them and their worldly needs.

The military powers that possess these technologies know that most people are like “oh heck no, don’t put that in me. I’m not going to get a microchip in my body.” So what would they do? Many who would enforce this are themselves struggling, in fact, law enforcement and other government agencies are fighting to keep their long promised government pensions during a time of global economic upheaval. metallic particles and find remedies that kill the organism from assembling inside our bodies.

Solutions

Whew! Thanks for hanging in there with us. It's a lot of really ugly stuff, but like I said in the beginning, there's real things you can do to protect yourself. As hinted in the previous chapter, those suffering from aerosol based illness and electronic harassment have a common enemy. They represent the tip of the spear of what will be a growing trend of afflictions and persecution thrust upon an awakening public. Fortunately, it's now being realized that there is indeed a common enemy to the human condition and life as a whole. We want to give you a high-level perspective of where things are headed, and know where, and how to look for answers. You don't have to be afraid of these things. They exist but we can beat them. So let's talk about some solutions.

A Word of Encouragement

To Targeted Individuals (TIs) & victims of Electronic Harassment

For those who are targeted with electronic harassment, ignore/dismiss 'inserted' threats, fears and negative thoughts. Anyone who's being electronically harassed understands that this is a daily battle. To be a victim of energy direct V2K is something that I'd never wish on anyone to experience. Threats and fear is meant to ultimately destroy you mentally and spiritually from the inside out. Dismiss them.

When you feel depressed, or are receiving what I call 'signals,' (technically they're not really voices, they're signals), understand that's all they are. They are suggestions that block your mind from engaging in things that you like to do in this world. If you feel that you're out in public and you have someone coming to you in a certain way to elicit a certain response, stop and recognize what that might be. Try not to give them too much attention but instead collect evidence and post on online. Tell your story, and reprove, rebuke, expose this fraud.

Remember, these are perverts for spying on you and invading your privacy. Take photos and videos of suspicious activities and build a case file. It's a lot of time and effort but worth it.

If you have the budget, you can also resort to surveillance equipment to record the citizen stalking. It can be expensive, but that's basically what people have had to resort to in order to prove their case. Continue to research ways of gathering more technical evidence of your

electronic harassment, and hire your own investigator. Join the research to find ways to attenuate the electromagnetic effects upon yourself and your family, and share with the online and local TI community.

Continue to do the things in your life that make you happy. You must make this a conscious decision daily to help reprogram your mind. And also the more you do this you're also learning how to cope with these negative suggestions, you will gain an internal strength you didn't realize was in you.

Daily remind yourself that you are a human being, wonderfully and fearfully made. If you are a TI, you probably also understand the power of prayer. If you're a victim of this stuff, there are times you feel like you're losing your mind. Regardless of what belief system or religious background you may come from, prayer in general is extremely effective to combat this kind of attack. We, too, have been through some tough times, where I'm with Tivon and he's been undergoing an attack of sorts and we stop and pray together and that stops the attacks. Just know that ultimately, God is your source.

There are also support groups out there (both brick 'n' mortar and online). Find one and join. Have a close friend or partner in your journey. That's really helpful because trying to tell others that you're being electromagnetically tortured, and they don't support you, is really hard to deal with. So try to find a good friend that gets it, and that you can talk to.

In truth, the operators who are in these programs tend to not do anything more than the occasional surveilling (the platform is Artificial Intelligence based), and will not overtly project themselves too much or else then the budget grows. Remember, there is always a budget! So, if you ever do become targeted, make sure you it very expensive for them. Tell others to do the same. Some consortium, foundation or government has put a lot of money in this program to find ways to break the human psyche and ruin people's lives. It is our goal to make sure that you are given knowledge and the tools to live a long and fruitful life, and that you **Choose Life**. Let's expose these criminals for what they are. Let's beat this leviathan together!

Detox Detox Detox

It's imperative to remove the accumulating metallic particles from the body since there is evidence that suggests these nano technologies (and biofilms) were genetically modified in a lab to self-assemble themselves inside our bodies, thus microchipping us from the inside.

The most powerful weapon we have to remove foreign invaders from the body is our immune system. We can do 'cleanses' and be sure to always have important vitamins, minerals and other health supplements on hand to counteract effects.

Aluminum, one of the chemicals being sprayed, is a neurotoxin meaning it is absorbed by nerve endings where it disrupts vital functions of the cell. The reason we are only discussing detoxing the

element/chemical aluminum is because of the high levels of this chemical being sprayed in chemtrails, and nowadays, found in most of the environment. Of course there are problems with other environmental heavy metals but these are beyond the scope of this book.

The best reason for removing aluminum from the body is the association between increased aluminum levels in the brains of Alzheimer's patients, and increased levels of environmental aluminum (from chemtrails?) over the past 20 years. Aerosolized aluminum passes very easily along the olfactory tract, goes directly into the brain (bypassing the blood brain barrier), and accumulates in the entorhinal cortex, the part of the brain responsible for memory and learning.

The basic protocol found below is specifically for heavy metal neurotoxins (aluminum, mercury, lead, etc.), and we make strengthening our immune system through diet and lifestyle top priority. Get the aluminum out!

- A high protein, mineral, fatty acid diet with lots of fluids is critical. Protein helps build the detox agents (coeruloplasmin, metallothioneine, glutathione and others). Branched chain-amino acids in cow and goat whey have important effects as well. Fatty acids must constantly be replenished because deficiency leaves the nervous system vulnerable to fat soluble metals. If the kidneys (detox organ) are contaminated they may not be efficiently filtrating toxins – flush with fluids!

- All metal detox attempts should begin by creating a healthy trace mineral and electrolyte base
- Optimize gut function by eating pre- and pro-biotic foods and taking powerful probiotic supplements. Half of the functioning of the immune system is centered in the gastrointestinal tract and the list of conditions that can be helped, and perhaps prevented, by having the right balance of intestinal bacteria, is remarkable.
- Cilantro – this herb moves metals out of the bones and central nervous system fast. Must be taken with an intestinal absorbing agent such as Chlorella

These steps will help you maximize your nutritional status and detoxification ability:

The research for Cilantro and Chlorella shows these nutrients can remove 80% of heavy metals from the body within 42 days. We also suggest researching the benefits of iodine and super-saturated potassium iodide. These are powerful broad spectrum anti-fungal agents. Research the benefits of drinking distilled water as it naturally pulls metals from the body.

There are all different kinds of protocols that go along with detox, and some of them are very effective in combating most of this type of warfare.

Magnetic Pulse Therapy

Another effective solution to use in parallel with a detox regimen that may be one of the most effective treatments in our research is the “Bob Beck Protocol – The Magnetic Pulser: Stage III Protocol.” The magnetic pulser sends high current pulses, to put back into circulation microbes which do not flow through the blood. The magnetic pulse penetrates deep into the body tissues, liquefies the lymph, and dislodges microbes from their hiding places. The field penetrates the skin and bones, and can reach hidden bugs anywhere in the body. Its range is about 23 to 30 centimeters, but is usually placed just above the skin. Microbes and nanoparticles hide in the lymph nodes, and other major organs in the body. This is a portable magnetic device, and can safely be pointed at any part of your body, with a few exceptions. (e.g., testicles or eyes, if you have had eye surgery). The pulse coil and long handle closely resemble a small ping-pong paddle. While the magnetic pulse itself is harmless to human cells, the coil can give a strong kick (that is why it has a plastic case around it).

Generally, the device is used for twenty minutes, then turned off for twenty minutes, then used again for twenty minutes. Different units however may have different overheating thresholds. Make sure you have covered every area of the body. There are four basic areas of the body you need to ensure are pulsed by the device.

There are several considerations when using the magnetic pulser:

- **Lymph nodes and organs.** The lymph nodes are near your spine, and also cover from the top of your head to your knees. It helps to have someone else handle the equipment while the lymph nodes are being pulsed because most of them are on your back, near your spine. While the magnetic pulse penetrates about 22 cm (meaning most people could pulse the lymph nodes from the front), the closer you can get to a target the better. The organs, especially the stomach, should also be pulsed.

- **Areas of the body where there is inflammation, swelling or congestion.** This is a very good anti-inflammatory device; and for a cancer patient, there are likely to be a lot of microbes and/or cancer cells in those areas.

- **Areas of known cancer cells** and especially areas where there are dense concentrations of cancer cells.

- **Liver.** The liver is the organ in the body most responsible for getting toxins out of the body. Many cancer patients die because their liver is overburdened. One thing a person should do who is on a strong cancer treatment is to point the magnetic pulser directly at their liver for a few minutes every day. This should be done to stimulate and protect the liver.

The schedule that is generally accepted is to use the pulser 5 minutes a

day, and build up by 5 minutes a day. Others will start at 10 minutes a day and build up by 10 minutes a day. The important thing is that your maximum daily treatment using this device will probably be between 40 and 60 minutes a day (not including cool down time). Every 20 minutes the device will probably need to be turned off (or it will turn itself off) because of heat buildup. It should be turned off for about 20 minutes.

The objective is to clean the lymph system, it would also be advisable to do as much exercise as is reasonable. Exercise (i.e. muscle movement) is the “pump” for the lymph system. If you cannot jog, then lift small weights (even books) to pump the lymph. You should take large amounts of water one hour before using the Magnetic Pulser and take additional water one-half hour after using the Magnetic Pulser. This is because the electrolytes in the water are what generates the current that disables the microbes. Drinking a lot of distilled water also helps detoxify the lymph system.

Do not point the device at any jewelry that is attracted to magnets (i.e., remove all jewelry that is attracted to magnets). You can wear your clothes, but not things that have metal on them, such as belt buckles. If you've had eye surgery, especially if there is an implant, do not point it directly at your eyes. Also, any man with prostate cancer (or any type of cancer) may feel serious burning if they point it directly at the testicles. Do not point it at open wounds.

The following schematics are for those who are able, or wish to have a pulser constructed as an alternative to buying one.

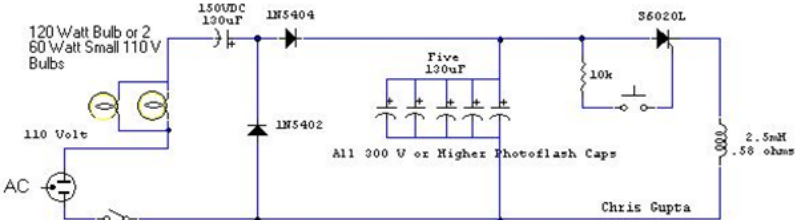


Fig. 1 Primary Circuit

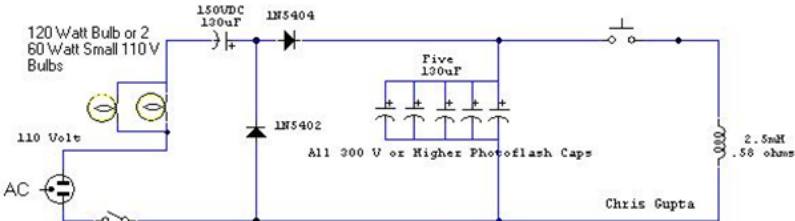


Fig. 2 Simplified Circuit

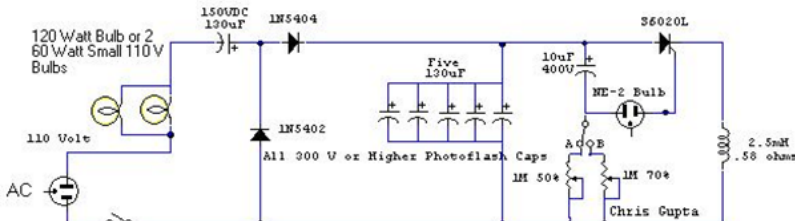


Fig. 3 Autopulse Circuit

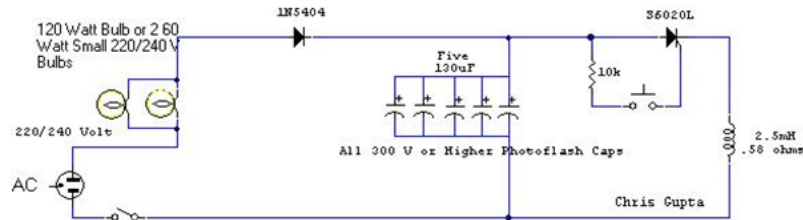
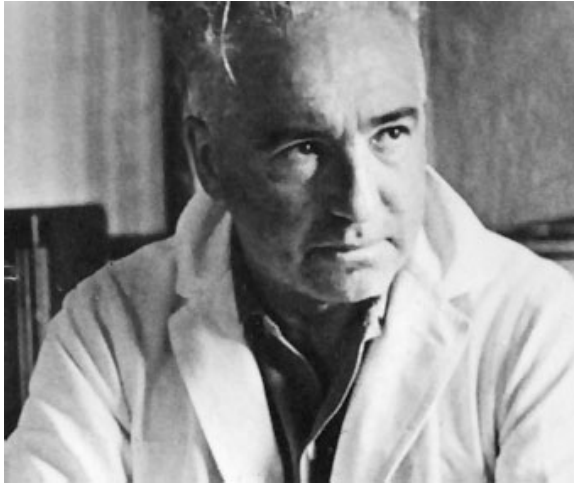


Fig. 4 220/240V AC Primary Circuit

Magnetic Pulser Schematics

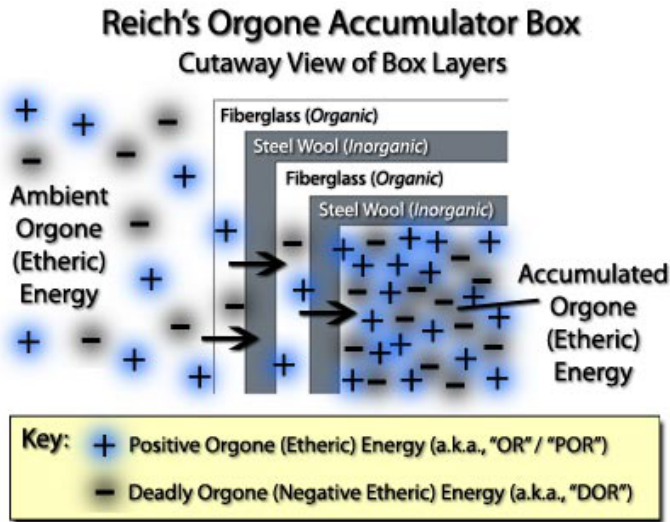


Dr. Wilhelm Reich

Orgone Energy

Wilhelm Reich was an Austrian psychoanalyst. Author of several influential books, most notably *Character Analysis*, *The Mass Psychology of Fascism* and *The Sexual Revolution*. Reich became known as one of the most radical practitioners of psychiatry. Reich's discovery also revealed the role of emotional-sexual energy in the psychosomatic process. What at first appeared to be only 'bioelectricity' was later clarified by Reich as a much more complex and powerful bioenergetic force, a form of life-energy at work within living organisms, expressing itself as emotion and sexuality, but also directly observable in the microscope as a bluish-glowing field around living blood cells and other substances.

This bluish-glowing energy, which he eventually called Orgone Energy (to preserve its relationship with living processes), is an observable physical phenomenon similar to the older ideas of ‘vital force’ and ‘cosmic ether’ combined.



During the course of Reich's investigations, he developed a special metal-lined enclosure which attracted a high charge of orgone energy inside itself, directly from the atmosphere. He called his device the orgone energy accumulator. The orgone accumulator (ORAC) was proven to charge seeds, increase garden plant growth, speed the healing of burns and cuts, and there are a number of physical experiments which demonstrate anomalous phenomena inside the accumulator. Reich observed that certain kinds of low-energy illness, such as cancer, would symptomatically yield to careful application of the orgone accumulator.

Reich's experiments in these directions led to even more controversy. He developed new methods for ending drought and greening deserts which led to the development of his cloudbuster, and new approaches to the problem of nuclear waste detoxification. The cloudbuster was a device with rows of 15-foot aluminum pipes mounted on a mobile platform, connected to cables that were inserted into water. He believed that it could unblock orgone energy in the atmosphere and cause rain.

The Dr. Wilhelm Reich Blood Test (RBT)

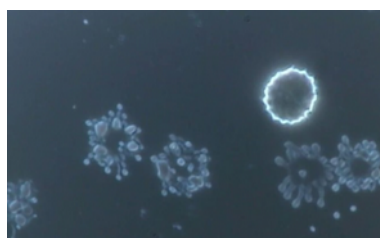
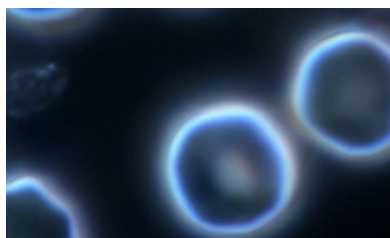
Orgone energy experiments can be readily replicated. We believe that Dr. Reich's theories deserve an unbiased, scientific investigation. One of the more famous of these experiments has to do with Dr. Reich's Orgone Accumulators (ORACs).

A recent experiment was conducted by Despina Malkotsi who is in charge of 'Heraclitus' Microscopic Research Laboratory. Under strict scientific procedures, the experiment calls for a laboratory examination to verify or refute the claim that ORACs energize a person's red blood cells, thus preserving their vital state longer than in

ambient conditions. The RBT can detect biopathic situations that are active in the organism without arriving to a specific diagnosis. The RBT is based on the direct observation of the blood immediately after its extraction from the body's vessels, and without biochemical processing.

According to Dr. Reich, as soon as the red blood cells leave the blood vessels, they begin disintegrating into cysts (the decay process begins). Reich called these cysts 'bions.' He observed that bions pulsed and were motile. Intriguingly, in healthy organisms they gave off an intense blue light. Classic Biology also describes bions as characteristic protrusions of the cell membrane. This phenomenon was called 'beebbling.'

Dr. Reich recognized a very primitive and undifferentiated stage of the living state in bions. This is described in detail in his book '*The Bion Experiments*.' Numerous such experiments were conducted in Oslo between 1936 and 1939, where he showed the disintegration of living and non-living matter, and the subsequent organization of bions in formations manifesting characteristics of living and functioning.

RBT Procedure

The most recent replication compared the disintegration of two blood samples taken simultaneously from the same person. One sample is placed in the ORAC device, while the other is placed in a simple box, made of only organic material. For the procedure they used:

- an orgone accumulator (ORAC), 3-layer per side, measuring 35 x 35 x 35 cm
- a 'control' box of similar dimensions, made of wood.
- A 3-layer orgone blanket
- a small metal box
- a laboratory microscope (Zeiss Axioskop 2)

They used a magnification of 1600x initially, but when there was a need for a more detailed observation of the sample, they increased the magnification to 4000x.

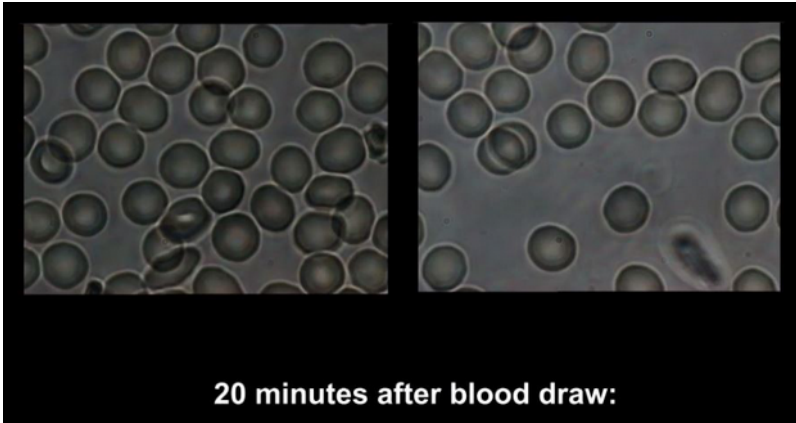
The blood used in the test was taken from the capillaries of the volunteer in sterile conditions. The blood was then mixed with saline solution at a ratio of 1:40, and then the team prepared two slides each containing the blood sample from the same person. The team's main concern was to obtain the red blood cells in their natural condition. If the red blood cells were destroyed, the samples were considered

unsuitable.

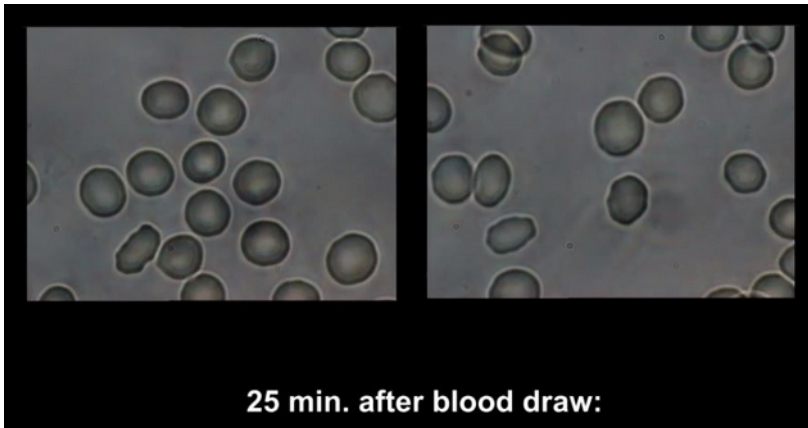
Next, one slide was placed in the ORAC for 15 minutes. It was first placed in the small metal box then wrapped in the orgone blanket that was inside the ORAC. The second blood sample was placed in the wooden control box. The two samples were then microscopically examined successively, at the same time. They observed the processes occurring in both samples during their death and ongoing decay (into cysts/bions).

Every 5 minutes the team observed and recorded the following characteristics of the red blood cells (erythrocytes): vigor, pulse and motility, width of energy field, rate of disintegration into bions, bion size and distribution in the inner part of the cell disk. The goal of the examination was to find differences in the two samples as regards to the erythrocytes' characteristics mentioned above. In this way, they determined the effects of the different conditions existing in the two boxes on the red blood cells. The two samples were thus checked successively at the same time and recorded.

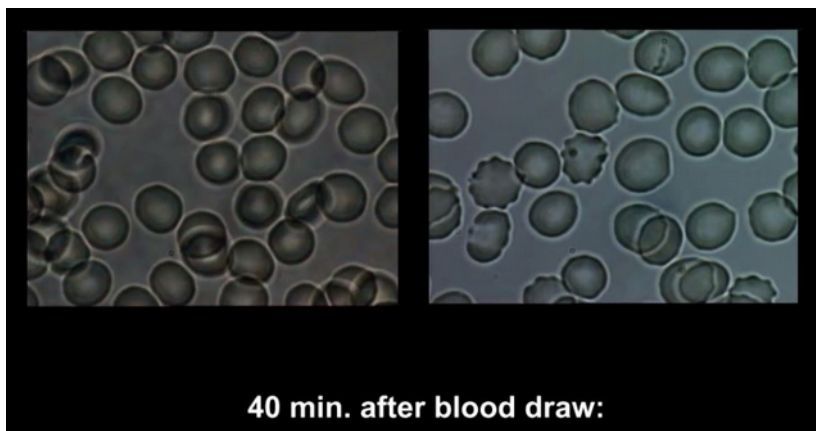
ORAC sample is on the left and the control is on the right



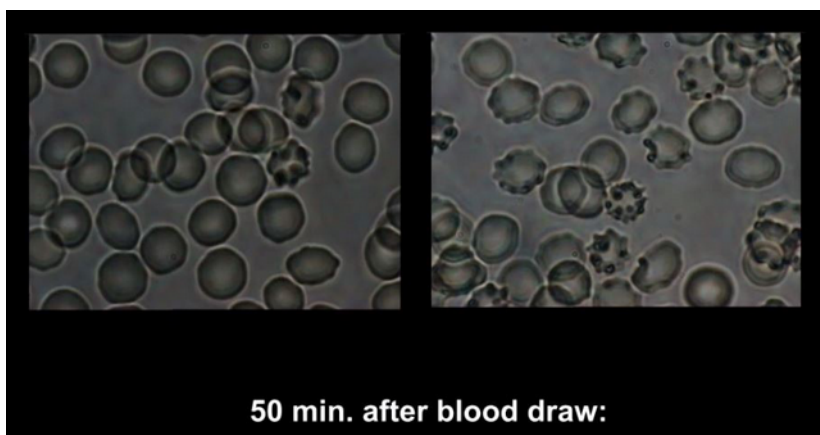
Both samples, the red blood cells show good mobility and pulse; the rate of disintegration was calculated at about 1%



Both samples still show motility and pulse. The red blood cells kept in the control box show loose membranes and amount of disintegration is 2-3%. The amount of disintegration for the red blood cells kept in the ORAC (left) is about 1%



The red blood cells kept in the control box (right) still show pulsation, but most of them are immobile and the percentage of disintegration is 2-8%. The red blood cells kept in the accumulator continue to show motility and pulsation, and thier disintegration is 2-3%



The differences between the two samples examined are even more obvious. The red blood cells kept in the control box (right) show a disintegration of 40-50%, while the ones in the ORAC (left) of only 5%!

Conclusion of RBT Replication

From the findings of the microscopic examination of the two samples, Dr. Despina's team observed the following:

- The red blood cells kept in the accumulator showed motility for longer time.
- Their disintegration into bions was slower.
- Their membrane tension was also preserved for a longer time.

The above findings as well as more data were collected during the examination. Blood cell samples of 10 individuals, for 4 times each, at different weather conditions were tested. The team also observed:

- The red blood cells kept in the accumulator showed more motility at a rate of about 60-70%.
- The rate of disintegration into bions/cysts was slower by 70% and the bions' size was larger at a rate of about 90%.
- It was also observed that when the humidity of the environment was high, the differences of the quality characteristics of the red blood cells in the two boxes were greatly smaller.

In summary they stated, **“In conclusion, we can say that the orgone accumulator has a clear biological effect on the blood examined with the method of the Reich Blood Test, improving the vigor of the red blood cells.”**

Orgonite

Orgonite was invented by Karl Hans Welz (Austrian). Orgonite is a mixture of catalyzed epoxy resin with metal shavings, particles or powders, poured into molds. It attracts Orgone energy similarly to Reich's accumulators. Some people also add quartz crystals to the mixture to enhance the performance of the orgonite.

How Orgonite Works

In recent years the new age movement and occultists have done a lot to discredit the science of orgonite. There have been wild outlandish claims that orgonite can do all manner of supernatural things from opening cosmic portals to communicating with little green men. We hope to clear up this confusion, by explaining the basic scientific effects that orgonite has and how you can use orgonite to clean the environment around you.

Orgonite converts positive charge (bad) into negative charge (good) in the form of negative ions (good for you). It acts as a passive ionizer for the environment. Orgonite emits soft electrons that can be detected with an ion counter. The resin in orgonite shrinks during the curing process, permanently squeezing the quartz crystal which creates a well-known piezoelectric effect inside the crystal, meaning its end-points become polarized electrically. This causes it to function more effectively as a positive energy generator. Although crystals improve the function of orgonite, they are not necessary for the orgonite to work. Orgonite also changes the pH of tap water, makes water more alkaline based, and structures the water by energizing it.

What this all means for the average person, is that Orgonite is an effective tool to help protect you from the harmful effect of electromagnetic frequencies, or EMFs. As we have covered in other sections of this book, several energy technologies in our world have deleterious effects on health. As a quick review here are some of the effects that many people suffer from caused by EMFs:

Powders for Making Orgonite

Some people use Orgonite to combat pollution and cell tower radiation. Others use it for clearing or purifying energies in their houses, or to enhance the growth of plants in their garden. Not all Orgonite is the same. The orgonite shown previously was made using powders instead of larger items inside the resin. The reason for this is that powders have more surface area, and the greater the surface area (once inside the resin) the more effective or powerful the orgone device will be. There are some Orgone devices that are aesthetically pleasing and very ornamental. However, they are nowhere near as effective when tested against powder-based orgone devices. Testing includes; using the ion meter, comparing crystalline structures in ice, and plant growth.
