

## **PRIVACY POLICY**

This is Forefront Golf Inc.'s ("Forefront") privacy policy. This document explains Forefront's policies for the collection, use and disclosure of personal information. Forefront abides by applicable privacy legislation. Forefront provides a service called ForeOrder for placing food and beverage orders on golf courses.

### **THE INFORMATION WE COLLECT**

Forefront collects information by various methods, mostly by information actively provided by its users.

The types of personal information we collect include name, address, email address, phone number, user name, password, birth date, gender, user's photo. The Service will track the location of the golfer and golf course employees while on the golf course. If the user leaves the application open while off the golf course, the Service may check the user's location from time to time to determine if they are on a golf course. The Service may also collect certain information from the user's cellphone, including the type of device, its unique identifier, IP address, service provider, and connection speed.

Forefront does not retain payment card information within its service. Forefront uses a third-party payment service to process payments, and does not itself see any payment card information.

### **HOW WE USE THIS INFORMATION**

This information is used to provide you with our service, including optimizing the service for each user and device, providing support, improving our services, prevention of fraud or misuse.

Forefront may use aggregate or anonymous information which will not be linked to identified individuals for various other uses for itself and third parties.

We may provide users with third party coupons or promotional offers from time to time based on criteria provided from those third parties, but without sharing your information with the third party.

### **WHO WE SHARE THIS INFORMATION WITH**

Forefront does not share personal information with any third parties except as disclosed in this policy. When a golfer places an order, the service sends the order, along with the golfer's name, cellphone number, photo, and location to the golf course. The golf course's use of that information is governed by the golf course's privacy policy, not ours.

Forefront may provide personal information to its consultants, subcontractors and professional advisers (which shall be bound by privacy obligations) to assist Forefront's uses disclosed herein.

If at any time we wish to collect, use, or share personal information beyond this policy, we will obtain your permission.

Notwithstanding the general terms of this policy, the collection, use, and disclosure of personal information may be made outside of the terms herein to the extent provided for in any applicable privacy or other legislation in effect from time to time, or pursuant to court orders.
