Transportation Waiver and Parental Release Form

Information in this document is protected by HIPAA privacy laws and should be handled accordingly. This form is only valid for participation, assistance and travel for the specific event(s) listed below.

Permission to Transport During the Activity

As the parent/guardian of the child named above, I give consent to the leadership of the activity to transport my child during the event through walking, vans, buses, airplane or other forms of transportation available to the activity. I understand that the activity will be following all International Church of the Foursquare Gospel (ICFG) transportation and youth protection policies during transportation of my child during the activity.

Parent/Legal Guardian Transport/Drop-Off/Pick-Up

As the parent/guardian of the child named above, I will transport, drop-off and pick-up my child throughout the activity listed above. If I am unable to do so, I grant permission to one of the people named below to transport, drop off or pick up my child. _____

The people listed are required to show photo identification to the designated activity personnel.

Permission to Arrive without Adult Supervision

As the parent/guardian of the child named above, I give consent to the leadership of the activity to allow my child to arrive and depart from the activity listed above without the supervision of a parent or guardian. Methods of transportation could include walking, bus, bike, taxi, public transit or flying. My child will arrive and depart the activity via: _____.

I give consent to allow my child to sign in and sign out during the activity named above as they will be traveling to the activity without a parent/guardian. I also give consent to allow my child to deliver or take any items related to signing in or signing out with the activity listed above. These items could include money, medication, signed documents and activity information. I understand my child does not have permission to leave prior to the conclusion of the activity for any reason, and they cannot depart in a fashion different than how they arrived, unless pre-approved by the parent/guardian and verbal or written notification given to the leadership of the activity.

Permission to Drive

As the parent/guardian of the minor named above, I give permission to my child to drive themselves and any younger siblings to the activity named above. I have discussed the rules listed below with my child, and my child agrees to abide by them. The following rules apply to minors who will be participating:

1. Minors must turn in their car keys to the leadership of the activity upon arrival.
2. Minors are not allowed to provide rides to other minors (other than younger siblings) unless specific permission is granted in writing by the parent/guardian of the individual who will be riding with the minor. The parent/guardian of the rider will release ICFG from any liability associated with this arrangement.
3. Minors may not leave the activity before the conclusion of the event unless notification has been provided verbally or in writing to the leadership of the activity.
4. All minors driving to and from the activity will be required to sign in and out with the leadership of the activity after arriving and before leaving.
5. Minors are responsible for any parking charges that may be incurred at the site of the activity.

Transportation Waiver and Parental Release Form

I give consent to allow my child to sign in and sign out themselves and any younger siblings during the activity named above as they will be traveling to the activity without a parent/guardian. I also give consent to allow my child to deliver or take any items related to signing in or signing out with the activity listed above. These items could include money, medication, signed documents and activity information. I understand my child does not have permission to leave prior to the conclusion of the activity for any reason, and they cannot transport anyone they did not bring to the event, unless pre-approved by the parent/guardian and verbal or written notification is given to the leadership of the activity.

In signing this form, I certify the information provided is true and accurate. I understand that it is my responsibility to reach out to the leadership of the activity in relationship to any questions I may have related to transportation. I also understand that it is my responsibility to update this information prior to, or during an event, if this information has changed. I hereby acknowledge and accept all risks individually and/or on behalf of my minor child, and I hereby release ICFG, its governing board, officers, employees, agents, volunteers and representatives from any and all liability to my child, my child's personal representatives, estate, heirs, next of kin and assigns for any and all illness or injury to my child's person, including his/her death, that may result from or occur during transporting my child before, during or after an activity with or without parental or guardian supervision, whether caused by negligence of ICFG, its governing board, officers, employees, or representatives, or otherwise. I further agree to indemnify and hold harmless ICFG and its governing board, officers, employees, and representatives from liability for the injury or death of any person(s) and damage to property that may result from my child's negligence or intentional act or omission.

ACKNOWLEDGEMENT OF INHERENT RISK/ WAIVER AND RELEASE

I ACKNOWLEDGE AND UNDERSTAND THERE ARE INHERENT RISKS ASSOCIATED WITH MANY EVENT ACTIVITIES. I WILL ASSUME THE RISK ASSOCIATED THEREWITH, WHETHER KNOWN OR UNKNOWN TO MYSELF AT THIS TIME. I RECOGNIZE THAT MY ATTENDANCE AT A FOURSQUARE CHURCH EVENT IS A PRIVILEGE, AND AS A CONSIDERATION FOR THIS PRIVILEGE, I RELEASE THE FOURSQUARE CHURCH, INCLUDING ITS EMPLOYEES, AGENTS REPRESENTATIVES AND VOLUNTEERS, FROM RESPONSIBILITY FOR MY ACCIDENTAL PHYSICAL INJURY, INCLUDING DEATH OR ILLNESS, AND LOSS OF PERSONAL PROPERTY WHILE AT THIS EVENT OR DURING FOURSQUARE CHURCH SPONSORED TRAVEL TO AND FROM THIS EVENT. THIS RELEASE IS ALSO INTENDED TO INCLUDE ALL CLAIMS MADE BY MINE AND MY FAMILY, ESTATE, HEIRS, PERSONAL REPRESENTATIVE OR ASSIGNS.

INDEMNIFICATION
