PONTOON BOAT RENTAL AGREEMENT

I, _____ have read and understand the pontoon boat rental policies and agree to the following provisions for the rental and use of the Brandermill Community Association (BCA) pontoon boat. ***I also understand that my reservation will only be honored if I am a Brandermill Resident in Good Standing.***

1. The Pontoon boat is for the use of the Brandermill residents, BCA Commercial residents and their guest.
2. Groups are limited to a maximum of 12 guests.
3. Pontoon rides are rented for a period of only two hours.
4. No alcoholic beverages can be served without a ABC License, a copy must be provided to the BCA prior to the event.
5. Residents and guests are expected to behave in a responsible manner. The pontoon captain is responsible for the operation of the boat and has the authority to terminate a rental for offensive conduct which threatens the safety of the passengers. ***Tiping the captain is always appreciated .***
6. The renters are responsible for maintaining the boat in the condition that it was received. Trash containers are located adjacent to the dock at Sunday Park. Dumping of trash of any kind in the Swift Creek Reservoir is prohibited.
7. Any violation of the rental policies may result in the forfeiture of the future rights for the pontoon boat rentals.
8. Children under 1 year of age are not permitted to ride on the pontoon boat without a specific, US Coast Guard-Approved personal floating device (PFD) provided by the renter and worn by that child at all times. Pontoons are equipped with life jackets for children older than one year of age and adults.
9. No swimming or fishing from the boat.
10. No use of grills on the pontoon. No smoking or fires on board. No pets allowed on the boat, service dogs only.
11. No Refunds. Should your cruise be cancelled due to weather conditions, please re-schedule before October 31st.
12. I/We, the undersigned, hereby agree to abide by these rules and to hold harmless the Brandermill Community Association, Inc. from injury, damage or loss of personal property or person in connection with the use of the BranderBelle Pontoons.

All Pontoon rides last two (2) hour.

Service charge is \$100 per ride with a maximum of 10 guests, additional guest is \$10 per person.

** Captain will establish contact with residents within 48 hours of cruise.*
