NORTH SHORE HEALTHCARE COMPLETES ACQUISITION OF 22 ATRIUM HEALTH & SENIOR LIVING-MIDWEST FACILITIES

[Glendale, WI, December 1, 2019] – North Shore Healthcare announces the completion of its acquisition of 21 Atrium Health & Senior Living - Midwest facilities in Wisconsin and one in Michigan. The 16 skilled nursing facilities and six assisted living communities went into receivership in September 2018 under court-appointed Receiver, Michael Polsky. Over the past several months North Shore Healthcare has worked closely with the Receiver and Health Dimensions Group, the operational and financial consultant appointed to the facilities during the receivership, to ensure a smooth transition for residents and staff.

This acquisition expands North Shore's footprint from 49 to 71 skilled nursing and rehabilitation centers and assisted living communities in Wisconsin, Michigan, Minnesota, and North Dakota. With the newly acquired centers, North Shore is the largest post-acute provider in the Upper Midwest.

"We are proud to welcome these new centers into our family. The passion that these teams put into the care and services they provide is exemplary," said David Mills, CEO of North Shore Healthcare. "With this acquisition we have the unique opportunity to serve residents in communities new to North Shore, as well as develop synergistic relationships between our new and existing locations.
