WHY PULMONARY REHABILITATION?

The RespiCare® Pulmonary Rehabilitation Program is designed to offer specialized care to residents and patients with acute chronic conditions or respiratory diseases.

UNDERSTANDING PULMONARY REHABILITATION

RespiCare® Pulmonary Rehabilitation is a program of exercise, education, and support to help you learn to breathe and function at the highest level possible.

With the RespiCare® Program at Birch Manor, you will work with a team of specialists who will help you improve your physical condition. You will also learn how to manage your condition, so that you can stay healthy and active long after you complete the program.

DO YOU KNOW YOUR PULMONARY DISEASE PROCESS CLASSIFICATION?

Class I (Mild):

No limitation of physical activity.

Ordinary activity does not cause fatigue, palpitation and/or shortness of breath.

Class II (Mild to Moderate):

Slight limitation of physical activity, comfortable at rest. Ordinary physical activity results in fatigue, palpitation and/or shortness of breath.

Class III (Moderate):

Marked limitation of physical activity with discomfort. Symptoms of cardiac and pulmonary insufficiency at rest. If any physical activity is undertaken, discomfort is increased.

Class IV: (Severe)

Unable to carry out any physical activity without discomfort. Symptoms of cardiac and pulmonary insufficiency at rest. If any physical activity is undertaken, discomfort is increased.

PROGRAM BENEFITS:

- The Pulmonary Physician will carefully provide oversight for your care needs.
- Our skilled Respiratory Therapist will spend up to 60 minutes with you per scheduled day.
- Daily care will be provided by specially trained nurses.
- You will receive education and training to help you manage your condition and to reduce symptoms.
- You will learn better management of anxiety and depression (a common result of respiratory illness).
- Increase ability to exercise, while decreasing symptoms.
- Overall improvement of daily life functions.
