

**The Score The Full Ride with Curb + Nasty Gal Sweepstakes Official Rules**

The Score The Full Ride with Curb + Nasty Gal Sweepstakes (the "Sweepstakes") is sponsored by Curb & Nasty Gal ("Sponsor") and is administered by Curb ("Administrator").

- 1. PROMOTION PERIOD:** The Sweepstakes consists of an Instant Win Game and a Sweepstakes that shall take place during the Sweepstakes Period. The Sweepstakes Period starts on August 14, 2014 at 12:00 P.M. Eastern Time ("ET") and ends on August 21, 2014 at 11:59:59 P.M. ET ("Sweepstakes Period"). Administrator's clock is the official clock for this Sweepstakes.
- 2. ELIGIBILITY:** The Sweepstakes is offered only to legal United States residents of Los Angeles, CA who are 21 years of age or older at the time of entry.   3. 3<sup>rd</sup> Prize: A pair of General Admission tickets to FYF Fest (\$129), Nasty Gal shopping spree (\$100), and Curb Credits (\$50).

  1. 1<sup>st</sup> Prize: \$579
  2. 2<sup>nd</sup> Prize: \$479
  3. 3<sup>rd</sup> Prize: \$279

**B. Odds of Winning:** The odds of winning a Prize depends on the total number of eligible entries received during the Sweepstakes Period.

**7. TOTAL ARV OF ALL PRIZES IN THIS PROMOTION IS \$1,337.**

**8. HOW TO CLAIM A SWEEPSTAKES PRIZE AND AN INSTANT PRIZE:** The potential Winner will be notified via e-mail within ten (10) business days of the random drawing. The Potential Winner must reply to Administrator within the time period indicated after notification or Sponsor may select an alternative Sweepstakes Prize Winner.
