4.1. Description of first aid measures

Symptoms/effects after skin contact : Causes (severe) skin burns. Prolonged absorption of bromides may produce skin rashes, running nose, headache, mucous membrane irritation, anemia, loss of weight and depression.

Symptoms/effects after eye contact : Causes serious eye damage.

Symptoms/effects after ingestion : No information available.

4.3. Immediate medical attention and special treatment, if necessary

Note to physician: Titanium tetrabromide reacts with water to form hydrobromic acid, consequently treatment for acid burns may be considered.

SECTION 5: Fire-fighting measures

5.1. Suitable (and unsuitable) extinguishing media

Suitable extinguishing media : None known.
Unsuitable extinguishing media : Water.

5.2. Specific hazards arising from the chemical

Fire hazard : Irritating fumes of hydrogen bromide and organic acid vapors may develop when material is exposed to water or open flame.

5.3. Special protective equipment and precautions for fire-fighters

Firefighting instructions : Note, since titanium bromide is not flammable, precautions refer to mixtures with flammable materials.).

Protection during firefighting : Do not enter fire area without proper protective equipment, including respiratory protection. Avoid contact with skin and eyes. Do not breathe dust.
