### 7.1. Precautions for safe handling

Containers must be properly grounded before beginning transfer. The related compound, hexamethyldisilazane, is known to have an exceptional tendency to accumulate static charge. The user must take extreme care to dissipate static charge by grounding of all equipment involved in liquid transfer. Take precautionary measures against static discharge. Use only non-sparking tools.
- Hygiene measures : Wash hands and other exposed areas with mild soap and water before eating, drinking or smoking and when leaving work. Wash contaminated clothing before reuse.
