SECTION 4: First-aid measures

4.1. Description of first aid measures

- Chronic symptoms : On contact with water this compound liberates methanol which is known to have a chronic effect on the central nervous system. Methanol may effect the central nervous system resulting in persistent or recurring headaches or impaired vision.

4.3. Immediate medical attention and special treatment, if necessary

NOTE TO PHYSICIAN: This product reacts with water in the acid contents of the stomach to form methanol. The combination of visual disturbances, metabolic acidosis and formic acid in urine is evidence of methanol poisoning. The therapeutic intravenous administration of ethanol (10 mls/hour) allows methanol to be preferentially oxidized and reduces production of methanol metabolites. Acidosis must be treated with intravenous administration of sodium bicarbonate and methanol elimination may be increased by hemodialysis, as indicated. Treatment should be based on blood methanol levels and acid-base balance.

SECTION 5: Fire-fighting measures

5.1. Suitable (and unsuitable) extinguishing media

- Suitable extinguishing media : Water spray. Foam. Carbon dioxide. Dry chemical.
- Unsuitable extinguishing media : Do not use straight streams.

5.2. Specific hazards arising from the chemical

- Fire hazard : Irritating fumes of hydrogen fluoride and organic acid vapors may develop when material is exposed to open flame.

5.3. Special protective equipment and precautions for fire-fighters
