4.1. Description of first aid measures

4.3. Indication of any immediate medical attention and special treatment needed

Note to physician- Eyes: If pain persists, repeat washing for 15 minutes or until pH of eye returns to normal. If great pain persists, place one (1) drop Benoxinate solution (0.4%) in the affected eye.

5.1. Extinguishing media

Suitable extinguishing media : Water spray. Foam. Carbon dioxide. Dry chemical.

5.2. Special hazards arising from the substance or mixture

Fire hazard : Combustible liquid. Irritating fumes of hydrogen chloride and organic acid vapors may develop when material is exposed to water or open flame.

5.3. Advice for firefighters

Firefighting instructions : Use water spray to cool exposed surfaces. Exercise caution when fighting any chemical fire.
Protection during firefighting : Do not enter fire area without proper protective equipment, including respiratory protection. Avoid all eye and skin contact and do not breathe vapour and mist.
