5.3. Advice for firefighters

- Firefighting instructions : Tetrachlorosilane is not flammable. The following information is provided to assist if tetrachlorosilane is present in a fire situation. Use only dry media to extinguish flames. Water spray or fog should only be used to knock down hydrogen chloride vapors in areas downwind from the fire. Exercise caution when fighting any chemical fire.
- Protection during firefighting : Do not enter fire area without proper protective equipment, including respiratory protection. Avoid all eye and skin contact and do not breathe vapour and mist.
