5.2. Special hazards arising from the substance or mixture

- Fire hazard : Highly flammable liquid and vapour. Irritating fumes of hydrogen iodide and organic acid vapors may develop when material is exposed to water or open flame.
- Explosion hazard : May form flammable/explosive vapour-air mixture.

5.3. Advice for firefighters
