4.1. Description of first aid measures

Fire hazard : Highly flammable liquid and vapor. Irritating fumes of hydrogen iodide and organic acid vapors may develop when material is exposed to water or open flame.

Ground/bond container and receiving equipment. Take precautionary measures against static discharge. Use only non-sparking tools.
