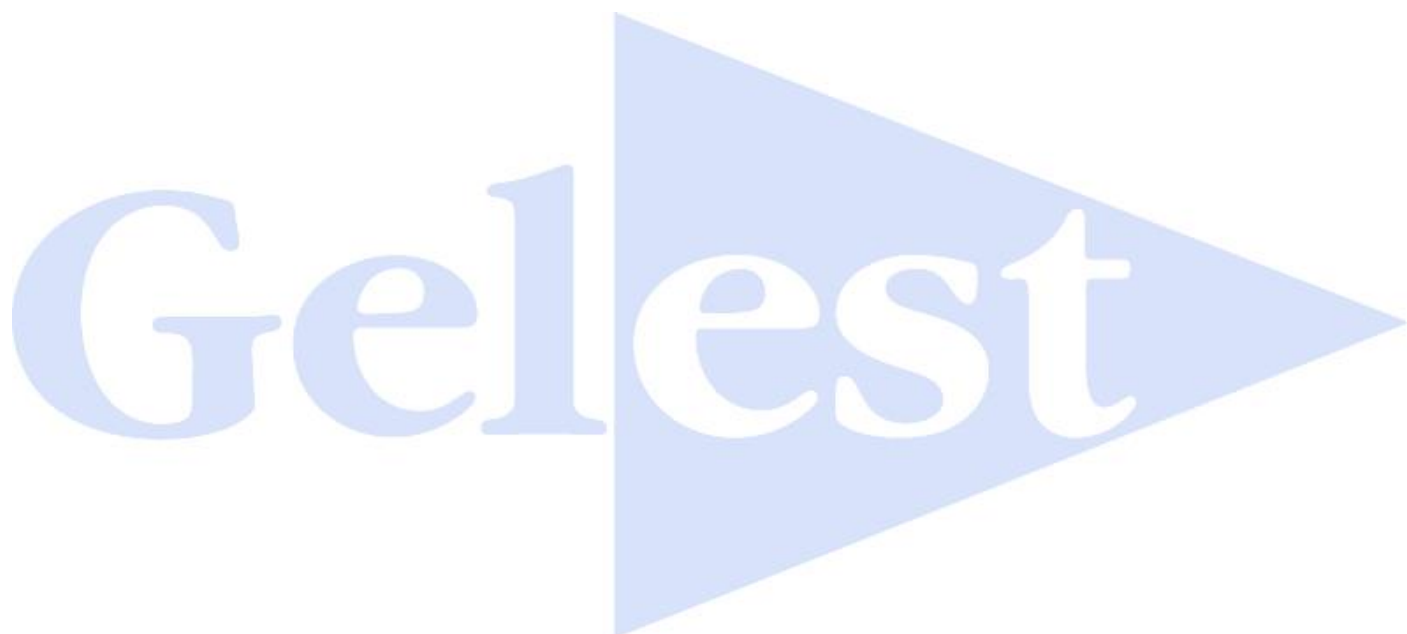

Dear Customer:
