SECTION 4: First-aid measures

4.1. Description of first aid measures

Symptoms/effects after eye contact : Causes serious eye damage.

Symptoms/effects after ingestion : May be harmful if swallowed. For ingestion, calcium gluconate intravenously and calcium lactate orally may be considered.

4.3. Immediate medical attention and special treatment, if necessary

NOTE TO PHYSICIAN: This product reacts with water and human tissues to form hydrofluoric acid . Massage a paste of 20% magnesium oxide in glycerol onto the burned areas. Inject 2-5 ccof 10% calcium gluconate beneath and around the burned areas. Gastric lavage, if swallowed, using 5% calcium chloride followed by saline catharsis.

SECTION 5: Fire-fighting measures

5.1. Suitable (and unsuitable) extinguishing media

Suitable extinguishing media : Carbon dioxide. Dry chemical. Alcohol-resistant foam.

Unsuitable extinguishing media : Do not use straight streams.

5.2. Specific hazards arising from the chemical

Fire hazard : Irritating fumes of hydrogen fluoride and organic acid vapors may develop when material is exposed to water or open flame.

5.3. Special protective equipment and precautions for fire-fighters
