Impact*Pollination workshops: Engage in discussions to bridge gaps between investment managers and asset owners. These workshops focus on removing barriers to deal flow sourcing and fundraising and developing product solutions to match market needs.

Thematic innovation hubs: Exchange with practitioners within the network to leverage solutions and resources in thematic areas like water and blended finance.

Acceleration series: Participate in strategic sessions focused on product development life cycles, scaling fund formation and distribution, and leveraging innovations and intermediations to support industry growth.

Corporate Impact Investing Initiative


The [corporate impact investing initiative](#) is a network for corporate impact investors to explore ways corporations can both make impact investments and leverage partnerships with impact investors to achieve sustainability goals.

Corporate network meetings: Meet with other corporate leaders to learn from peers and explore impact themes and corporate impact investing strategies.

Thematic workstreams: Join a group of companies focused on a specific sector, geography or theme to advance progress on specific needs, align activities using impact capital and catalyze new flows of funding for initiatives to generate real-world positive outcomes. Current and future offers include healthcare, corporate treasury and food systems.
