

## Terms & Conditions – Podcast Prize Draw

### Eligibility

The Prize Draw is open to residents of the United Kingdom and United States excluding (a) anyone connected in a professional capacity with the Prize Draw and that person's immediate family members, and (b) employees and contractors of GoodPractice and its affiliates. Entrants must be aged 18 years or older.

Entry implies acceptance of these terms and conditions, and any amendments to them, which are final and binding in all respects. ### Prize

### Opening/Closing Date and Time

Entry requires an email account, internet connection, Apple account and access to the iTunes software.

To enter, entrants must provide (or have previously provided) a comment on the 'Ratings and Reviews' page of the GoodPractice Podcast on iTunes (<https://itunes.apple.com/gb/podcast/goodpractice-podcast/id1114862726>). The entrant should take a screenshot of the comment and email that screenshot to [support@goodpractice.com](mailto:support@goodpractice.com) with their name, contact email address and telephone number to enter.

In the event of any dispute, all submitted entries will be deemed to have been submitted by person whose details are completed on the entry email. Entry to the Prize Draw is limited to one per person.

GoodPractice will only accept entries that are completed and submitted in the format designated. Incomplete entries may not be accepted. Duplicate entries are not permitted and will be disregarded.

### Winner Selection

GoodPractice will in its sole discretion, select the Prize winner at random.

The winners will be notified (i) by email using the contact details provided on the entry form within one (7) days of the end of the Prize Draw Period. The winner will have five (5) days from receipt of the Email Notification to respond to GoodPractice confirm acceptance of the Prize.

If a selected winner (or any substitute winner) is ineligible, cannot be reached, or fails to claim their Prize within five (5) days of receiving the Notification, that winner (or substitute

winner) will forfeit the Prize and it will be awarded to a substitute winner. If, having attempted to contact a winner and a substitute winner, GoodPractice is unable to award a Prize, GoodPractice Limited reserves the right to consider the Prize unclaimed.
