CELEBRATE THE SEASON WITH AN END-OF-THE-YEAR TAX WRITE-OFF

December 13, 2017 – Did the holiday season leave your wallet a bit lighter? You may be able to get a little money back from Uncle Sam next year by donating gently used clothing and other items to Goodwill Southern California (GSC) for an end-of-year tax deduction.

By cleaning out your closets and garages, you get more than a write-off. Goodwill Southern California uses the proceeds from your generous donations for its job training programs and employment services for individuals with disabilities, veterans, at-risk youth and anyone in the community facing challenges in finding employment.

“End the holiday season and start the New Year off right by making an investment in your local community,” said Patrick McClenahan, President and CEO of Goodwill Southern California. “Every donation to Goodwill Southern California will help make 2018 a better year for thousands of individuals who need job training, career services and other community-based employment programs.”

GSC accepts gently used clothing, household items and E-waste (anything with a cord or battery - working or not) – even those holiday gifts that weren’t quite right! Donations are collected in 82 retail stores and over 40 donation centers throughout Los Angeles (N. of Rosecrans), Riverside and San Bernardino Counties. To find the nearest Goodwill Southern California location, donors may visit www.goodwillsocal.org/donate/donation-center-locator.

Donations are tax deductible, to the extent the law permits. Donors interested in claiming tax deductions should keep itemized lists of their donations. Donors determine each item’s value. Generally, an item’s value should be based on fair market value – what the item would sell for in a thrift store. Goodwill provides either electronic or paper receipts to donors. Consult with your tax preparer for additional details.
