Valuations

If the value of the property you own is less than five years old from the date of manufacture at the time of loss or damage, it will be at the following:

- The cost to replace the lost or damaged property with other property; Of comparable material and quality; and Used for the same purpose.
- The cost of reasonably restoring the property to its condition immediately before loss or damage; or
- The actual amount you spend necessary to repair or replace the lost or damaged property.

If the value of the property you own is more than five years old from the date of manufacture at the time of loss or damage, it will be valued at the following:

- The Actual Cash Value of that property; But in the event of partial loss or damage, not exceeding 20% of the limit of insurance applicable to the covered property, no depreciation will be applied to the settlement of the claim;
- The cost of reasonably restoring that property to its condition immediately before loss or damage; or
- The cost of replacing the property with substantially identical property.
