For many years, the Minnesota State Fair has held firmly to a policy prohibiting firearms at the State Fairgrounds during the Minnesota State Fair. They believe that this prohibition includes permit holders carrying a firearm under MN 624.714.

We disagree with their interpretation of state law, as does the author of Minnesota's Permit to Carry law.
