Father Goran Jovicic is a Roman Catholic priest from Diocese of Subotica, the Autonomous Province Vojvodina in Northern Serbia, formerly part of the Austria-Hungarian Empire. He has a Doctor of Theology (a major in Canon Law and a minor in Dogmatic Theology). Before joining the faculty at STPSU in 2019, he was teaching at the School of the Catholic Theology, University of Erfurt and School of Theology in Würzburg/Erfurt, in Germany.

In 2017 Fr. Jovicic earned a licentiate (JCL) in Canon Law and on June 23, 2020 he completed successfully his JCD degree at the Pázmány Péter Catholic University in Budapest under dissertation mentorship of Prof. Schanda Balázs, the Supreme Justice at the Hungarian Constitutional Court.

His main fields of research are Canon Law, Dogmatic Theology (especially Ecclesiology, Sacraments, Ecumenism), International Law, Diplomacy of the Holy See, Roman Curia, State-Church Relations, and Prevention of Child Abuse.

Fr. Jovicic is teaching Ecclesiology, Catholic Doctrine, Sacramental Theology II: Holy Eucharist and Sacramental Theology I: Introduction as well some of those courses for the Deacon Formation of the Archdiocese of San Francisco.
