## 6 – Accidental Release Measures

**Personal Precautions, Protective Equipment and Emergency Procedures:** Wear appropriate protective clothing (see Section 8). Eliminate all sources of ignition and ventilate area.

## 7 – Handling and Storage

Keep away from heat, hot surfaces and open flames. Wash thoroughly with soap and water after handling. Keep containers closed when not in use. Keep out of the reach of children.
