BANQUET POLICIES

All parties will be charged an additional 8% PA sales tax and 20% service charge.

PAYMENT: 30% non-refundable deposit at time of booking. Final payment is due 24 hours prior to your event.

GUARANTEES: The final number of people attending your event must be confirmed at least seven (7) business days prior to your event. This number can never decrease after confirmation but it may increase up to two (2) days before your event as long as room is available. Guaranteed choices are the responsibility of the client at a minimum of seven (7) business days prior to your event. We reserve the right to substitute meals if the above is not provided.

CANCELLATION: Cancellation of your function with three (3) months notice or more will not result in any further charges, although your deposit will be retained. With less than three (3) months notice, your deposit is retained and a 25% service charge is billed based on expected revenue loss.

TIME FRAME: If the duration of your event surpasses the contracted time frame, additional charges may apply. We reserve the right not to extend alcohol service beyond your scheduled time frame.

SETUP: If extensive room setup is required, an additional charge may apply.
