#### About Eileen |



As you may know, my dear wife, Eileen, had a fall down the stairs on September 7, 2014 that has changed her life forever. After a life spent enjoying skiing, golf, gardening, cooking, and traveling, and splitting her time between Chicago and

Durango, she now faces a future with many obstacles due to the extent of the spinal cord injury she has sustained. Currently Eileen is paralyzed from the chest down. She has been attending 5-6 days of therapy every single week since her accident. She is a determined woman, however, and is working very hard to get back to a productive life with the support of myself, our three children, friends, and family.

Eileen continues to make progress and her determination is admirable but we are facing many years of care to continue to assist her in her recovery. After her accident, Eileen could not move her arms or legs. With her determination and your assistance, she can now move her legs, walk with a walker a very short distance and move her arms a little bit. She is still confined to her power chair and is starting to feed herself with the aid of an arm device that is attached to the chair.

Thankfully, we have health insurance, but now most of Eileen's medical expenses are not covered and we must pay a significant amount out of pocket. Costs for the home modifications, home health care, caregiving, medications, rehab, and doctors' visits are very high and in most cases are not covered by insurance. In addition, we continue to explore various cutting-edge facilities that specialize in spinal cord injury therapies. Total expenses for the first year were well over \$800,000 and we can expect to spend at least \$200,000 every year moving forward.

To help with the financial burden of Eileen's uninsured expenses, a fundraising campaign in her honor was established in 2014 with HelpHOPELive, a trusted nonprofit organization that has been providing community-based fundraising guidance to patients and their families for more than 30 years. All donations are tax-deductible, are held by HelpHOPELive in the North-Central Spinal Cord Injury Fund, and are administered by HelpHOPELive for injury-related expenses only.
