 - Chittenden Yes for Social Autopsy MOU

 - HUD has not opened up the HDX
 - We will be starting to go through the non HMIS data this month
 - We are still waiting for some PIT and HIC reports.

- User Violations
 - o UVH
 - Reached out to Bitfocus around ICA

 - Looking at a Case Management system

- HMIS Advisory Committee Governance

- Committee Concerns
 - Looker is not doing what they were told by vendor
 - If trying to create your own reports, this is something that ICA needs to know so we can get those reports created for you. We did let everyone know that creating reports is something that might not happen on the user level. Users would need extensive training

on how to use Looker and since we are in a shared system with NH we cannot allow for full visibility which would hinder the way reports are created on a user end.

- It is better to reach out to ICA for custom reporting, as there might already be a report built or we can work with your agency to get one created by out reporting team
- Agencies having to create report outside of HMIS
 - Kay mentioned she has been having to create reports outside of HMIS however she hasn't reached out for reporting support, so ICA did not know what reports her agency is/was in need of.
 - HOP the way HOP was structured was a large part of why reporting was a more complicated to get a Looker report built in Clarity
 - HOP data entry is structured a bit different currently so the things we were not able to do during migration we are more likely to be able to do.
 - In July 2022 migration was still happening, and we had only been in the system for 3 months. Creation of reports, especially very complex reports, takes time. The expectation that the report for HOP should have been created and perfect immediately is not realistic.
 - There was a training for the new HOP report that does have what is needed for the current HOP reporting
