

# **Process for Authenticating US Academic Degrees**

All newly hired U.S. faculty and staff must complete authentication of their academic degrees (bachelor's, master's, and doctorate) before arriving in Kuwait. **At minimum, authentication of the bachelor's degree is compulsory**. Proof of authentication must be secured prior to departure from the U.S., as it is required to obtain legal residency and a work permit in Kuwait. The steps outlined below may be completed by mail if necessary.

#### Section A – General

## **Step 1: Registrar and Notary**

- Obtain an official true copy of your diplomas from the university registrar (with university seal).
- Registrar executes an affidavit confirming authenticity before a notary public. ( see Enclosure 1)
- Apply for a verified certificate from the National Student Clearinghouse
- ( <u>www.studentclearinghouse.org</u> ). ( see Enclosure 2)
- Note: Notary public services are often available through the university's business office.

#### **Step 2: County Clerk Certification**

 On completion of Step 1, send the notarized document to the clerk of court of the county (where the notary is licensed) for a notarial certificate suitable for foreign use. ( see Enclosure 3)

#### **Step 3: State Authentication**

• Submit the documents from Steps 1 and 2 to the State Notary Public Administrator to obtain the official state seal. The Administrator will issue and affix a State Authentication Certificate. (see Enclosure 4)

#### **Step 4: US Department of State**

 Submit the authenticated documents from Steps 1 through 3 to the U.S. Department of State Authentications Office, following the instructions provided on their official website ( www.state.gov/m/a/auth/) to obtain the Federal Authentication Certificate.



## Step 5: Kuwait Embassy / Consulate

- To obtain authentication of the U.S. Department of State Seal at the Embassy or Consulate of the State of Kuwait, submit the following:
  - All documents obtained in Steps 1 through 4
  - Sealed transcripts and a photocopy of each
  - Copy of your passport
  - Verified Certificate from the National Student Clearinghouse
  - Self-addressed, postage-paid return envelope
  - Fee of \$25.00 per document, payable by money order (see Enclosure 6)

## Section B – Universities located in Washington DC

#### **Step 1: Registrar and Notary**

- Obtain an official true copy of your diplomas from the university registrar (with university seal).
- Registrar executes an affidavit confirming authenticity before a notary public. ( see Enclosure 1)
- Apply for a verified certificate from the National Student Clearinghouse
- ( <u>www.studentclearinghouse.org</u> ). ( see Enclosure 2)
- Note: Notary public services are often available through the university's business office.

### Step 2: District Notarial Certificate (Washington, D.C. universities)

 Proceed to the District Building, 717 14th Street NW, Room 230, to obtain a formal notarial certificate for foreign use.

#### Step 3: State Authentication

 Submit the authenticated documents from Steps 1 through 2 to the U.S. Department of State Authentications Office, following the instructions provided on their official website ( <a href="https://www.state.gov/m/a/auth/">www.state.gov/m/a/auth/</a>) to obtain the Federal Authentication Certificate.

#### **Step 4: Kuwait Embassy / Consulate**

- To obtain authentication of the U.S. Department of State Seal at the Embassy or Consulate of the State of Kuwait, submit the following:
  - All documents obtained in Steps 1 through 3
  - Sealed transcripts and a photocopy of each
  - Copy of your passport



#### Requirements for Authentication of Diplomas for non Kuwaitis

To authenticate Diplomas, the applicant has to provide the Embassy with a sealed transcript as well as verified certificate from the National Student Clearinghouse at <a href="https://www.studentclearinghouse.org">www.studentclearinghouse.org</a>. These documents have to be presented with the Diplomas for which authentication is requested.

- Original Diploma has to be attested by the U.S. State Department in Washington, DC. – Telephone number: 202-647-5002
- 2- Fees of \$25.00 in cash or money order payable to "Embassy of the State of Kuwait". <u>Personal checks are not accepted.</u>
- 3- Copy of applicant's valid passport.
- 4- Prepaid self addressed return envelope.

Diplomas that do not meet the above requirements will be returned .
