4. All payments shall be made by check as follows:
 - a. \$_____ shall be paid as a non refundable deposit by the Purchaser to
the Speakers, at the time the contract is signed and your date is reserved.

- b. The balance of \$ _____ shall be paid by the Purchaser to the Speaker upon arrival for the event in _____.
 - c. The Purchaser shall pay additional payments for travel expenses to the Speakers. All expenses will be billed and are due upon receipt of invoice.
5. The Purchaser agrees that if Presentation is canceled (by Purchaser) 60 calendar days prior to the scheduled event the deposit of \$ _____ will be forfeited. If Purchaser cancels Presentation less than 30 days prior to the scheduled event, the Purchaser agrees to pay the full agreed upon price, plus any incurred travel expenses already booked, regardless of the cause of the cancellation.
6. The Purchaser agrees to furnish at its own expense, all that is necessary for the proper Presentation: including a suitable theater, church, hall, or auditorium; well heated (or cooled), lighted, clean and in good order, and a public address system is in perfect working condition including microphones (s) in number and quality required by Speaker.
7. Speaker shall have the sole and exclusive right but not the obligation, to sell products including (but not limited to) book, audio, and video recordings, in connection with, and at, the above Presentation and the receipts shall belong exclusively to the Speaker. No merchandise fees and or commissions shall be paid to the venue or auditoriums unless agreed to at the signing of the Agreement. If this approval has not been obtained, the Purchaser will be responsible for merchandise fees and or commissions; Purchaser further agrees to provide two volunteers, age eighteen or older, for administration of Speakers product sales. Purchaser will provide one 4' X 8' table and a clean table cloth, to be used exclusively by speaker for product sales. Purchaser shall see that volunteers are the table forty-five minutes prior to Presentation to receive instructions from the Speakers.
8. The Purchaser shall not broadcast, televise, or record, nor permit anyone in attendance to broadcast, televise, or record, any part of the Presentation of the Speaker, without the express, written permission of the Speakers.
9. The Purchaser shall not have the right to assign the Agreement, or any of its provisions. Nothing in the Agreement shall ever be understood as to constitute a partnership or joint venture or that the Speaker shall be liable in whole or in part for any obligation that may be incurred by the Purchaser in the Purchaser's carrying out any of the provisions in the Agreement or other wise. The person executing this agreement on the Purchaser's behalf has the authority to do so.
10. This constitutes the sole, complete and binding Agreement between the Speaker and the Purchaser.
11. In the event that the Purchaser refuses or neglects to provide any of the items or to perform any of its obligations herein stated, and/or fails to make any of the payments provided herein, speaker shall have the right to refuse to perform this Agreement,

shall retain, any amounts theretofore paid to the speakers by Purchaser, and Purchaser shall remain liable to the Speakers for all fees and expenses herein required.

12. In the event of cancellation by speaker due to illness or an unforeseen emergency, Speaker will attempt to provide a comparable speaker, acceptable to Purchaser and any fees already paid to Speaker will be passed on to the replacement speaker. If Milan and Kay are both Speakers and one of the two above mentioned is sick, or an unforeseen emergency arises, one speaker instead of two shall conduct the event.
13. Purchaser agrees to maintain the absolute confidentiality of all terms, conditions, and arrangements contained herein and/or associated with this engagement.
14. This agreement may not be changed, modified or altered except by a written document signed by both parties. This agreement shall be interpreted according to the laws of the State of California.

Signing this agreement binds both parties to the contract as outlined in these pages.
