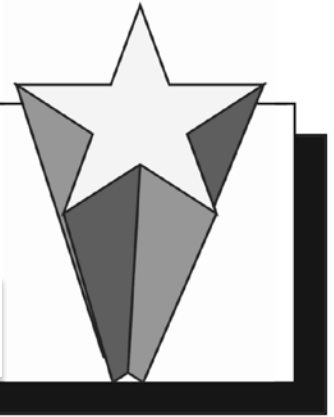




IAFE Young Professionals Initiative
RISING STAR AWARD



ABOUT

A young person (40 years or younger) will be honored during the IAFE Annual Convention in San Antonio, TX. The IAFE Young Professionals Initiative (YPI) began during the 2008 Convention with over two dozen individuals setting a plan of action for 2009 which included identifying young leaders throughout every zone of the IAFE and bringing selected members together for a strategic planning session.

From the strategic planning session came the mission statement, “To provide a venue for young professionals to guide the future of the fair industry through leadership, development, mentoring, incentives, education, and idea sharing with the IAFE.”

One of the goals of the YPI was to create a “Rising Star Award” to recognize leadership and industry contributions of IAFE members, age 40 and younger.

Nominees not selected (includes all nominees not selected in past years) will need to be re-submitted each year to be considered. Deadline for nomination is **August 31, 2019**.

Following are the rules and nomination form for the Annual Rising Star Award. The award will be presented during the IAFE Annual Convention.

ELIGIBILITY

Nominees shall be associated as an employee, volunteer, or board member of a member fair, show, exposition, or exhibition in good standing with the IAFE.

Nominees **shall not** have reached their 41st birthday prior to the first day of the IAFE Convention for the year of the nomination.

PROCEDURE

1. Nominations are due in the IAFE office by **August 31, 2019 to lhart@fairsandexpos.com**
2. Nomination shall consist of the Official Nomination Form and answering the following four questions:
 - How has the nominee gone above and beyond the call of duty for his or her fair or the fair industry as a whole?
 - What sets the nominee apart from other young professionals?
 - Give an example of how the nominee has made a positive impact at a fair or on the industry.
 - What participation, involvement, or leadership roles has the nominee held in the industry and in their community?
3. The nomination shall be limited to the nomination form itself (2 pages) plus a maximum of three (3) pages of supporting documentation or additional information.
4. The person who is selected to receive the award will be notified to ensure attendance at the IAFE convention as well as to collect information and photos for the presentation.

JUDGING

Judging will be done by a committee of five: three from the core group of YPI and two from the IAFE board (the immediate past chair and one selected by the chair).

The committee reserves the right to determine additional persons for consideration.
