Date Collected: May 24, 2016

Scope: Eight (8) samples of water were collected by Hub Testing Laboratory at the above

noted project addresses. Two (2) samples were collected at the Cummings School, three (3) samples were collected at the Somerville High School, one (1) sample was collected at the Edgerly Education Center and two (2) samples were collected at the Winter Hill Community School. It was requested that the samples be analyzed for lead and copper. The samples were collected from kitchen sinks and wash rooms in the Nurse's Rooms in the school. Sample locations were flushed the previous evening and sampled as a first draw sample in the morning

before being occupied.

Methodology: Lead was analyzed using SM 3113B. Copper was analyzed using EPA 200.7.
