Methodology


- Environics Research Group conducted a survey on behalf of IFAW Canada on Canadians' attitudes toward animal issues.
 The survey was conducted between June 3 and 18, 2015 as part of a national omnibus telephone survey among 2,003 adult Canadians aged 18 and over.
- The results of a survey of this magnitude can be considered accurate to within plus or minus 2.2 points, 19 times out of 20.

Animal welfare issues

With the exception of Atlantic Canada, most think Canada's commercial seal hunt should have government support cut off & left to survive or fail on its own


Preference for direction of government support of seal hunt

Most Canadians support regulations that require hunters to retrieve both pelt & meat from seals they kill


Support for requiring hunters to retrieve both pelt & meat from seals they kill

Overwhelming support for updating the criminal code to make it easier to convict on acts of cruelty to animals


Support for updating criminal code to make it easier to convict on animal cruelty



Q7. Canada's current animal cruelty legislation was written in 1892 and has not been changed in over 100 years. Under the legislation, animals are considered property and wild and stray animals have very little protection. Nearly unanimous agreement that Canada needs to do more to protect species at risk


Agreement that Canada needs to do more to protect at-risk species

Vast majority agree that Canada should close loop holes that allow meat from endangered animals to be shipped through our country


Agreement that Canada should close loop holes that allow meat from endangered animals to be shipped through our country

Strong agreement across the country that Canada should ensure laws are updated within 90 days of new species being added to the endangered list


Agreement that Canada should ensure laws are updated within 90 days of new species being added to endangered list

Universal support for a ban on international trade in polar bear parts


Support for ban on international trade in polar bear parts

A slim majority say animal welfare issues will be at least somewhat important in their federal vote decision


Importance of animal welfare issues in deciding on federal election vote
