Isaiah 13-23

- We did not finish our study of the origins of the Gentiles last week. Therefore—
- We continue with the idea that there is a **history of the Gentiles** (Gen. 1-11) that can be squeezed out of the ancient “mythological” accounts.
- We are trusting John Pilkey with this task—it is his work that we present. To get that account see—
- Last weeks lesson on-line at the Sound Words app under Classes, Father Knows Best.

Two Points from Last Week

- The idea of “myth” was attached to the biblical accounts for prejudicial reasons. Further—

The liberal view is that the myths were made up and were sources for the Bible—thus the Bible is mythological. It serves the interest of skeptics if all ancient writings were myths without any historical value.

- So 200 years of traditional knowledge and research was lost.
- The evangelicals understandably had a hard time with **myths** and ceded the territory to the liberal minded. But in the process lost continuity with the history of the Gentiles.

Two Points from Last Week

- There is a whole story behind the early archaeological finds in the 1840-1900 period.
- The motivations were either to find the Bible true if certain discoveries were made and then there were those who hoped to find things that discredited the Bible.
- Both used the finds to advance their particular cause.
- BTW the Bible needs no attestation. But it is attestation as we have in our study the Assyrians tell the story of the “conquest of Judah” exactly as described in the Bible. The Assyrian text adds that Sennacherib caged King of Judah as a bird in a cage—but Jerusalem did not fall.

Two Points from Last Week

Return to Myths: The second lost point is that the personalities in these “myths” were assumed to be **imagined figures that were made up with the storied accounts.**

As we have stated the **myths were not “made up”** out of whole cloth but began as **true histories written in a manner that made sense to them.**

All rumors, myths, divinities etc **start with some truth,**

In these accounts there are beings that proposit supernatural qualities of long life.

These extraordinary “God-like” figures of “eternity” were given “gods” status. The Bible recognizes this kind of use.

- Among most other nations Noah's community of elite [54-51] children and descendants were known as gods and goddesses like those named as such in Psalm 82 and John 10.
- They were rulers of almost inconceivably high status.
- Ed: Psalm 82:6 I said, "You are gods, And all of you are sons of the Most High. John 10:3 " Jesus answered them, "Has it not been written in your Law, 'I said, you are gods'?"

Two Points from Last Week

- However, these accounts will be corrupted in time from the original form, but still there may be some truth to these stories as there is a reality in the persons that make up the so called “gods.”
- This is a provable point—it has been widely known that the gods of the Greek and Roman cultures are the same gods with different names.

Same Persons by Variety of Names

Greek Name	Bible	Roman Name
Zeus	Shem	Jupiter, Jove
Poseidon	Easy cognate form Sidon	Neptune
Hades, Plouton	Brother of Sidon	Pluto, Dis
Here	Naphtuh-Anath Wife of Zeus Jupiter	Juno

We see these with their variant in names.

Also Jacob is Israel. Abram becomes Abraham —Sari, Sarah
These are cognate forms.

Two Points from Last Week

- Pilkey lists some of these in “A Designed World-Origin of Mankind According to Genesis 10-11.
- He gives pg. 195-225 to establish the identities of the 54 (of 77 listed) unique personages in Gen. 10. He says that his list of hundreds of names is not comprehensive—these are just those known to him!
- The implication is great. Histories are not separate national stories, but the world as one community has a common history shown in the cognate uses of names.
- In other words Noah and his history is in all cultures!

Sample of the “gods” as Men

- Noah is Uta-napishtiem in the Epic of Gilgamesh
- Noah is Anu, Priest of An (El Elyon) upper Tigris
- Noah is Apsu; outraged father of Ham, Marduk Epic.
- Noah is Viracocha Peruvian father god
- Noah is Ziusudra Ark building in Epic of Gilgamesh

THE god of Melchizedek king of Salem, El 'Elyon the Lord of Heaven and Earth,' is an isolated feature in Biblical literature. The true names of God are used in various Noahic communities.
This is not idolatry but more like polytheism. Different names for the same God.

Sample of the “gods” as Men

- **Shem** Amun Re Egyptian sun god of Thebes.
- **Shem** is Brahma Indian creator god of the Trimurti (trinity).
- **Shem** is Melchizedek king of Salem Gen 14:18
- **Shem** is Seth son of Get (Noah) in the Egyptian Ennead nine.
- **Shem** is Zeus Hellenic Olympian sky and storm god

Sample of the “gods” as Men

- Ham is Bera, King of Amorite Sodom in Gen. 14:2
- Ham is Havilah, a vassel of Cush in Gen 10:7
- Ham is Hermes, Hellenic Olympian god; brother of Dardanus (Shem)

Sample of the “gods” as Men

- **Japheth** Atum Re Egyptian sun god of lower Egypt. Head of the **Egyptian 9 gods**.
- **Japheth** is Sheba vassal of Cush Gen 10:7
- **Japheth** has many gods listed as Egyptian—upper is different from lower Egypt.
- **Gomer** is **Cheops**, Hellenistic of **Kufu**. Pharaoh of Dynasty IV. Great pyramids in Cairo.

Sample of the “gods” as Men

- **Ashkenaz** founder of the American 2158 (and Asian) continents populations.
- Kanati **Cherokee** hunter god
- Quetzalcoatl **Aztec** god of priests
- Skan **Sioux** creator god
- Wabasso **Algonquin** god
- Wakan-Tanka **Dakotan** god in 16 persons
- Yarilo **Slovic** love God (Siberia)

Conventional Christian Understanding

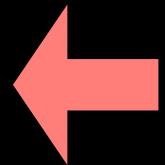
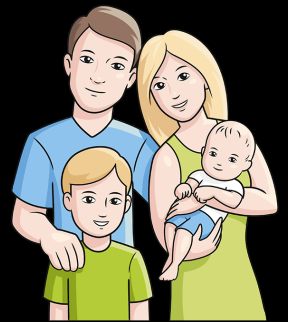
- **Ed:** The families of Adam and Noah did not adhere to the ideals set forth in God directive to Moses the writer of Genesis, a redactor, no doubt working with existing records.

Genesis 2:24 For this reason a man shall leave his father and his mother, and be joined to his wife; and they shall become one flesh.

Ed: It has long been understood that the first families married sisters. Monogamous marriage is forth by Moses in Gen. 2:24, Mosses under inspiration sets forth the “ideal” for the normal population. Are Adam and Noah held to this standard? There are exceptions that abound in order to accomplish God’s intentions for the population before and after the Flood. (Careful on this point.)

Conventional Christian Understanding The question of family building and incest!

- **Pilkey: Any “incest relationships” are emphatically denied and deemed contrary to God’s law for the nuclear family.**
- **Even the secularists missed God’s direction and rejected the accounts supporting the Biblical narrative.**
- **Their moralism against incest, blinded them to the rules of the repopulation mandate.**



Conventional Christian Understanding The question of family building and incest!

- Pilkey: Any “incest relationship” is **emphatically** **dead** to God’s law.
- **This is dangerous ground.**
However we will never be able to
Sort out this period without
a concession to this point.
- The **church** against incest, blinded them to the **rules of the repopulation mandate.**

Conventional Christian Understanding The question of family building and incest!

- Ed: However, it is **God's law** and thus it functions under the auspices the Law Giver (There are exceptions to all law).
- It is clear that God not only allowed variants of the one man one woman order as with Jacob's two wives and two concubines but that incest was ordered Onan who was to raise up a protege upon his brother's death. Gen. 38:8.
- Onan defied God's order that "violated" the Genesis order.

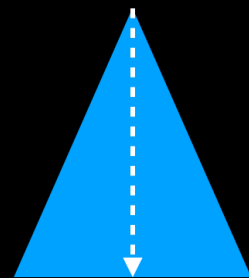
Conventional Christian Understanding The question of family building and incest!

- Ed: However, it is **God's law** and thus it functions under the auspices the Law Giver (The Law is given to all law).
- It is clear that **sex** is not gratuitous sex and understand that incest is not the one man one woman sex as an essential act of Noah's repopulation orders. **See** the one who was to raise up a protegee until brother death. Gen. 38:8.
- Onan denied **God's order** that "violated" the Genesis order.

We must let go of the idea of gratuitous sex and understand that incest is not the one man one woman sex as an essential act of Noah's repopulation orders.

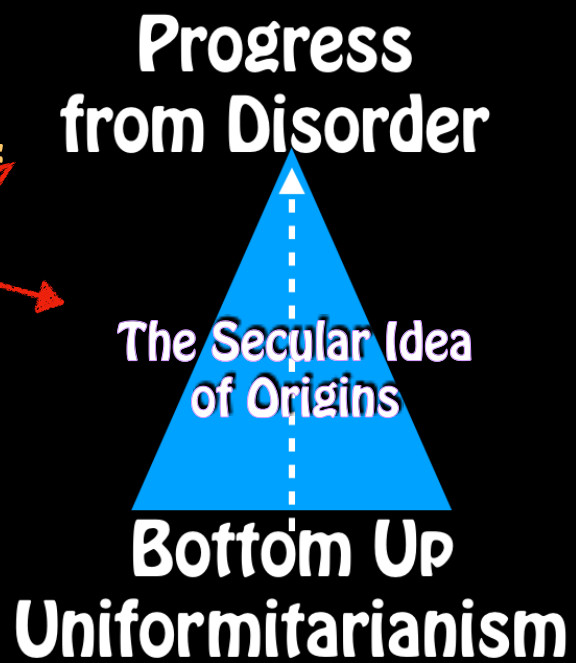
- **Pilkey:** “The historical record of humankind in the third millennium (3000-2000 b c) before Christ bears the stamp of Noah's family and of the events and structures outlined in Genesis 9-11.

- Pilkey's "goal is to create a coherent (clear) Christian synthesis of the disjointed data of antiquarian (antique) study."

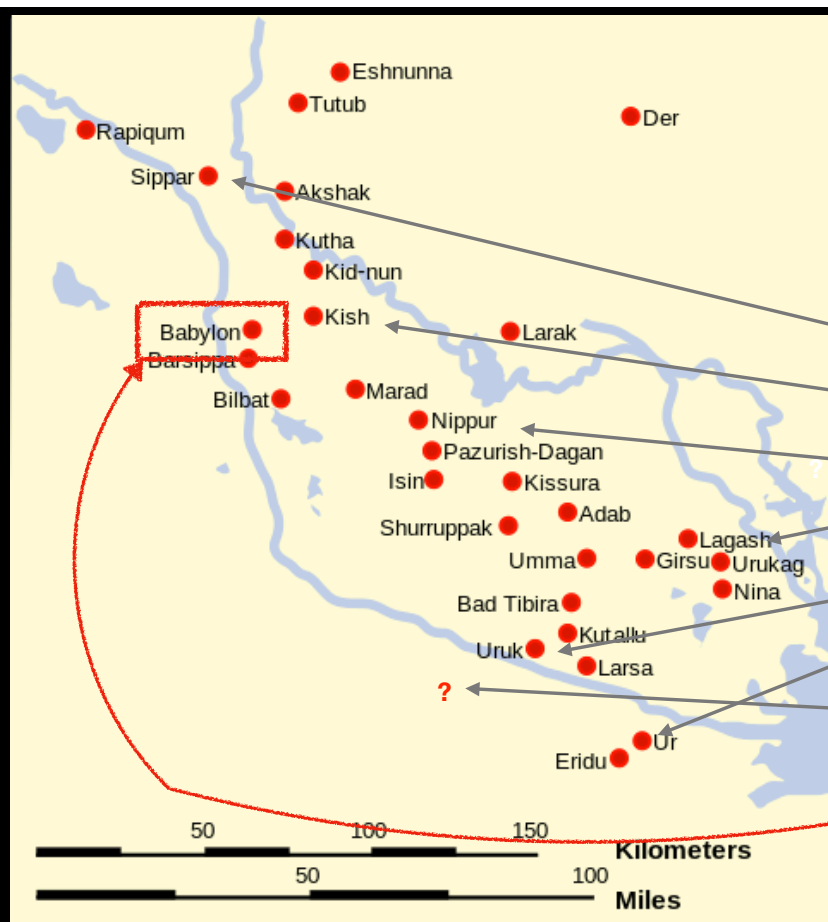


- The first thirty years the family of eight traveled the Arabian/ Mesopotamia

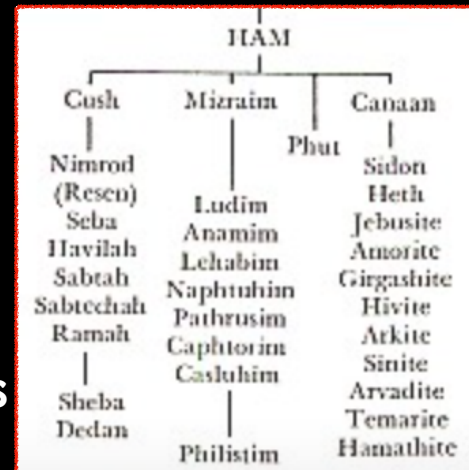

Briefly two Issues

- The incident of Noah cursing Ham's son Canaan occurred in 2359. This is 129 after the first 30 year sweep to establish territories finishing in 2488.
- Later, (2nd sweep) apparently Noah made a “mistake in the order of settlement” and Canaan used this opportunity to depose Noah (partly).
- As families stick together, Canaan's father Ham founded Babylon in 2340 which has become infamous as the center of opposition to God in human history.
- Repopulating the world now is adversarially being carried on. (Details are not clear to me.)



Tower of Babel

- Nimrod, the rebel, attempted to forge one language for all people. He was attempting, in the building of the tower of Babel, a “one world” he as chief—without Noah and the God he served. **He forced the labors to speak his language.**
- **God disapproved of the tower and the unified humanity and one language being the great unifier of people.**
- **God causes the language of Ham (universal to them) to be forgotten, scattering the people into their own people groups seen today.**

Tower of Babel

- We are now ready with some background to pick up the curse of Babylon.
- By now she has piled on sins upon sins and it is no wonder that as the judgments begin, Babylon is the first in the cue!
- Babylon will be the last in the judgment that smoke will rise forever even in the Kingdom, a reminder of what happens when Man assume the divine prerogatives.

Thus far—
