IIN's Health Coach Day 2020 Scholarship

How to Apply: To apply, in a 500-word essay ("Essay") (2 pages double spaced) or 3 to 5 minute video describe how you or someone you would like to nominate emulates the three pillars: (1) Community A leader in their community who is source of positive change, self-development, and growth; (2) Education Embraces learning and new ways to do things. Passionate in the education of holistic health and wellness; and (3) Service Supports, leads, or works with organizations to make the world a healthier, happier place. Provide two letters of recommendation from someone in leadership within your community (e.g. Teacher, Service program leader, or professional boss). Submit application via email to: scholarships@integrativenutrition.com and please specify ("Health Coach Day 2020 Scholarship") in the subject line. Videos must meet the Video Requirements set forth below. Each person making a submission ("Applicant") must be the original author and exclusive owner of the written essay or video being submitted. Multiple Applicants may not enter using the same email address. Applications nominating anyone entitled to protections under GDPR will not be accepted.
- **5. Scholarship:** One winner will receive one Scholarship for free tuition to IIN's online Health Coach Training Program ("HCTP"). The winner must enroll in an HCTP class with a start date during Fall 2020 and winter 2021. The Scholarship may not be used for later HCTP classes. Videos may not include any content (images, music, etc.) that constitutes copyright infringement or otherwise infringes or violates the

privacy, publicity or other rights of any person. Applicant must have signed permission from all individuals (parents/legal guardian of minor children, if featured and if not your own) that appear in the Video to use their image and to grant the rights set forth herein. If requested by Sponsor, Applicant must be able to provide such permissions, and any other third-party consents or licenses required under these Official Rules, in a form acceptable to Sponsor. Applicant's Representations and Warranties: By applying for the Scholarship, you represent and warrant that you have complied with the Terms and that: a) You own or have the necessary licenses, rights, consents, and permissions to reproduce, distribute and publicly perform any and all works of authorship or other content, including images or likenesses of any person, contained in your Video, and you have the right under all trademark, copyright or other proprietary rights laws to grant to IIN the licenses described in these Terms; b) At the time of entry or any time thereafter, your Video does not contravene any contractual, legal or other obligation to any person or entity; c) At the time of entry or any time thereafter, your Video does not infringe the copyrights, trademarks, moral rights, rights of privacy/publicity or intellectual property rights of any person or entity, and no other party has any right, title, claim, or interest in the Video, except persons who have licensed, consented or otherwise granted permission to you to grant to IIN the licenses described in these Official Rules; d) Your Video does not contain any pornographic, obscene, racist, or defamatory materials or materials that would be deemed offensive to a person of reasonable sensibilities; e) Use of the Video by IIN, as contemplated by these Terms, will not infringe any copyrights, rights of publicity, rights of privacy, or any other rights of any person, living or dead; f) Your Video is not subject to any prior agreements that would limit the scope of the permission granted to IIN under these Terms; g) You have complied with all relevant laws, rules

and regulations in the production of your Video and your Video complies with all such laws, rules and regulations; h) Your Video complies with the YouTube Community Guidelines; and i) Your Video has not been entered into any other contest or won any other Award. IIN reserves the right, in its sole and absolute discretion, not to post or to remove and disqualify any Video that it believes violates these Terms, the law, or the rights of any person or is otherwise inappropriate for a Scholarship of this nature. In addition, applicants that do not comply with the YouTube Community Guidelines will be disqualified.

- **8. Winner Selection:** One Applicant will be selected to receive the Scholarship based on the following criteria:
- a) The level of inspiration and enthusiasm for the IIN community
- b) What You hope to gain from an IIN education
- c) The level of creativity, humor, and originality
- d) Ability to invoke a sense of urgency and/or commitment
- e) Overall quality and clarity of presentation

Decisions of IIN shall be final and binding in all respects.

- **9. Notification of Winner:** The Scholarship winner ("Winner") will be notified via email at the email address provided with their application within approximately thirty (30) days from the end of the Entry Period. If the notification delivery is returned as undeliverable, or a potential winner fails to return any required documents within the specified time, the Scholarship will be forfeited and IIN may select another winner from the remaining eligible applications. IIN is not responsible for undeliverable Scholarship notifications due to change in Winner's email address or any other reason. If a potential Winner is disqualified for any reason, IIN may award the Scholarship to an alternate Winner from among all remaining eligible Applicants.
- 10. Entrant's Grant of License: By submitting an Essay or Video, each Applicant, in consideration for the opportunity to win the Scholarship, grants an irrevocable, perpetual, royalty-free, worldwide, non-exclusive, sub- licensable and transferable license to IIN, its parent, subsidiaries, affiliates, successors, and assigns ("Authorized Parties") to reproduce, store, distribute, publicly display and create derivative works of the Essay or Video, with or without attribution or prior notice, in any media now or hereafter known, in connection with the Scholarship and in connection with the marketing, advertising and promotion of the business or services of such Authorized Party, including, but not limited to, display, reproduction, publication and distribution of the Essay or Video or a derivative or portion thereof, worldwide, including but not limited to on IIN's website, in social media and in printed publications.
