AMENDED ORDER OF FORFEITURE

After a review of the government's Motion for an Amended Order of Forfeiture and the pertinent record, it is this 3<sup>rd</sup> day of April 2009 **ORDERED, ADJUDGED, AND DECREED** as follows:

1. The following real property is condemned and all rights, title, and interests of Richard Walters, and any and all other persons **HEREBY FORFEITED** to the United States:

- a. Real property located at 5-1 Estate Sorjenfri, Southside Quarter, St. Thomas, Virgin Islands, as shown on P.W.D. No. C9-41-T62, consisting of approximately .64 acres more or less, Asset Id No. 08-FBI-003387;
- b. Undeveloped property located at 3C-47 Estate Fortuna, No. 8 West End Quarter, St. Thomas, Virgin Islands, as shown on P.W.D. No. D9-5889-T95, consisting of approximately 12,082 sq. ft., more or less, Asset Id No. 08-FBI-003393.

2. The U.S. Marshal Service is directed to dispose the above-described property in accordance with law, and after reasonable expenses, directed to submit all proceeds to the Office of the General Counsel, Office of the Chief Financial Officer, Government of the District of Columbia, Washington, D.C.
