FINAL ORDER AND JUDGMENT OF FORFEITURE

This matter is before the Court on the United States' Motion for Final Order of Forfeiture regarding property belonging to Defendant, Richard Gene Shaw. The Court entered a Consent Preliminary Order of Forfeiture on July 23, 2008, forfeiting the following properties to the United States pursuant to 18 U.S.C. § 1963(a) (3) and 21 U.S.C. § 853(a):

a. Real property located at 2087 Potash Road, Cedartown, Polk County, Georgia, more particularly described as:

All that tract or parcel of land lying and being in Land Lot 170 of the 2nd District, 4th Section, Polk County, Georgia, being Lot 1, containing 5.48 acres, as shown on Plat of Survey for Lassiter Properties, Inc., recorded in Plat Book P, Page 143, Polk County Records, to which plat reference is made for a more detailed description. Being improved property known as 2087 Potash Road, Cedartown, according to the present system of numbering houses in Polk County, Georgia.

The United States published notice of the forfeiture action in *The Rome News-Tribune*, a newspaper of general circulation in the Northern District of Georgia, Rome Division, once a week for three

consecutive weeks. The United States also sent notice of the forfeiture action via certified mail to the Polk County, Georgia, Tax Commissioner¹, a lienholder on the property, and, to Lloyd Granger, Inc., c/o its registered agent, Stuart Schwarczchild, 3747 Peachtree Road, Apt. 813, Atlanta, Georgia 30319. No one has filed a claim to the property and the deadline for doing so has expired.

This Court having found that the Defendant Richard Gene Shaw has an interest in the property subject to forfeiture pursuant to 18 U.S.C. § 1963(a)(3) and 21 U.S.C. § 853(a), it is hereby ORDERED, ADJUDGED AND DECREED that:

1. Final forfeiture judgment against the following property is hereby entered pursuant to 18 U.S.C. § 1963(a)(3) and 21 U.S.C. § 853(a):


- a. Real property located at 2087 Potash Road, Cedartown, Polk County, Georgia, more particularly described as:

All that tract or parcel of land lying and being in Land Lot 170 of the 2nd District, 4th Section, Polk County, Georgia, being Lot 1, containing 5.48 acres, as shown on Plat of Survey for Lassiter Properties, Inc., recorded in Plat Book P, Page 143, Polk County Records, to which plat reference is made for a more detailed description. 2. All right, title and interest in the property listed above is hereby condemned, forfeited and vested in the United States and shall be disposed of according to law.
3. The interest of Lloyd Granger, Inc., is hereby extinguished.
4. The United States District Court shall retain jurisdiction in this case for the purpose of enforcing this Order.
