FINAL ORDER OF FORFEITURE

WHEREAS, on September 11, 2008, this Court entered a Preliminary Order of Forfeiture in this action (Doc. 14), thereby divesting any interest held by defendant Billy Flint East in the following real and personal properties:

WHEREAS, the United States caused to be published on an official internet government forfeiture site (www.forfeiture.gov), notice of this forfeiture and of the intent of the United States to dispose of said properties in accordance with the law and as specified in the Preliminary Order of Forfeiture, and further notifying all third parties of their right to petition the Court within thirty (30) days for a hearing to adjudicate the validity of their alleged legal interest in said properties. The government also sent personal notice to those parties it believed may possess an interest in the subject properties; and

WHEREAS, a timely petition was filed by General Motors Acceptance Corporation ("GMAC") as to the 2002 Chevrolet Corvette, VIN [REDACTED] however, said vehicle was subsequently released by the government pursuant to an agreement between those parties and GMAC has now withdrawn its petition. (Doc. 30). No other petitions have been filed as to any other property identified in the Preliminary Order of Forfeiture, as more particularly described therein, and the time for filing such petitions has now expired; and

NOW THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED, having previously found that defendant Billy Flint East had an interest in said properties, that the following properties are hereby FORFEITED to the United States of America pursuant to 21 U.S.C. § 853(a):


IT IS FURTHER ORDERED, ADJUDGED AND DECREED that all right, title and interest to the real and personal properties identified above are hereby
