AMENDED VERIFIED COMPLAINT FOR FORFEITURE IN REM
 PURSUANT TO SUPPLEMENTAL RULE G

Plaintiff, United States of America, brings this amended complaint, in accordance with Supplemental Rule G(2) of the Supplemental Rules for Certain Admiralty and Maritime Claims, and alleges as follows:

NATURE OF THE ACTION

This is an amended action to forfeit and condemn to the use and benefit of the United States of America the defendants *in rem* for violations of 21 U.S.C. § 881(a)(4) and (6).

JURISDICTION AND VENUE

Plaintiff brings this amended action *in rem* in its own right to forfeit and condemn the defendant properties under 21 U.S.C. § 881. This Court has jurisdiction over this action under 28 U.S.C. §§ 1345 and 1355. Venue is proper in this district pursuant to 28 U.S.C. §§ 1395 and 1355(b)(1)(A) and (B).
