ORDERED that upon liquidation of the property known as Real Property known as Lot 6, in Block 2 of La Caleta Estates, Val Verde County, Texas, the United States Marshals Service and/or its designated custodian shall pay any and all ad valorem taxes that are due and owing on said property to Val Verde County, Texas; and IT IS FURTHER


ORDERED that upon liquidation of the property known as Real Property located and situated at 3404 American Drive, Unit 3326, Lago Vista, Travis County, Texas, the United States Marshals Service and/or its designated custodian shall pay any and all ad valorem taxes that are due and owing on said property to Travis
