FINAL ORDER OF FORFEITURE

On May 28, 2010, the court entered a Preliminary Order of Forfeiture forfeiting, pursuant to 21 U.S.C. § 853, one blue 2000 Ford Taurus with Connecticut license plate [REDACTED], registered to Ariana Rodriguez at 2225 Main Street, Bridgeport, CT. Pursuant to 21 U.S.C. § 853(n) and Rule G(4) of the Supplemental Rules for Admiralty or Maritime and Asset Forfeiture Claims, beginning on June 2, 2010 and ending on July 1, 2010, for 30 consecutive days, the United States published on the official internet government forfeiture site, [www.forfeiture.gov](http://www.forfeiture.gov) notice of this forfeiture and of the intent of the United States to dispose of the property as the Attorney General may direct, and further notifying all third parties of their right to petition the court within thirty days for a hearing to adjudicate the validity of their alleged legal interest in the property. A Declaration of Publication was filed with the Court on July 30, 2010. On June 1, 2010, the United States sent a certified letter to Ariana Rodriguez at 2225 Main Street, Bridgeport, Connecticut, giving her notice of this forfeiture, informing her of her right to file a claim within

thirty days of the receipt of the certified letter and notifying her of the intent of the United States to dispose of this property. No petitions have been filed.

Accordingly, it is hereby ORDERED, ADJUDGED, and DECREED:

That, pursuant to 21 U.S.C. § 853(n)(7), the right, title, and interest to one blue 2000 Ford Taurus with Connecticut license plate [REDACTED], registered to Ariana Rodriguez at 2225 Main Street, Bridgeport, CT is hereby condemned, forfeited, and vested in the United States of America and that no right, title, or interest to the property shall exist in any other party.

That pursuant to 21 U.S.C. § 853(g)-(i), the United States may dispose of this property according to law.

That the Clerk of Court is directed to send two (2) certified copies of this Final Order of Forfeiture to S. Dave Vatti, Assistant United States Attorney, 450 Main Street, Hartford, Connecticut 06103, as well as copies of this order to all counsel or parties of record.
