## 4. FIRST AID MEASURES

<b>Eye Contact.</b> Check for and remove any contact lenses. Flush with large quantities of water, holding eyelids open for 15 minutes. Seek medical attention immediately.

## 6. ACCIDENTAL RELEASE MEASURES

**Spill Clean Up.** Put on appropriate personal protective equipment (see section 8). Stop leak if without risk. Move Containers from spill area.
