Official Rules

1. HOW TO ENTER: Complete an entry form online at www.blackhawks.fancam.com between 12:00 a.m. Central Time ("CT"), March 19, 2021 and 11:59 p.m. CT, May 8, 2021. One entry per person. Proof of sending or submission will not be deemed to be proof of receipt by the Chicago Blackhawks.
