

OFFICIAL RULES FOR THE “2022 KNOXVILLE NATIONALS Fancam SWEEPSTAKES”

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

SWEEPSTAKES PERIOD: THE 2022 Knoxville Nationals Fancam Sweepstakes (“Sweepstakes”) begins on August 15, 2022, at 9:00 a.m. Eastern Daylight Savings Time (“EDT”) and ends on September 12, 2022, at 11:59 p.m. (the “Sweepstakes Period”).

HOW TO ENTER During the Sweepstakes Period, there is one (1) way to enter: **Online:** Enter the Sweepstakes by visiting <https://knoxvillenationals.fancam.com> and click the sweepstakes banner. Follow the instructions to complete the registration form by entering your name, email, phone, and zip code information. Entries generated by script, macro, or other automated or mechanical means or by means which subvert the entry process are void. Limit one (1) entry per person, per email address. Entries received from any person in excess of the limitation will be void. All entries become the sole property of the Administrator (as defined below) and will not be returned. Released Parties (as defined below) are not responsible for lost, late, incomplete, delayed, or misdirected entries. Incomplete or fraudulent entries will be void.

ELIGIBILITY: Sweepstakes is open to legal residents of the fifty (50) United States and the District of Columbia who are of the age of majority or older in the applicable jurisdiction. Employees of board members of the Marion County Fair Association, the Knoxville Raceway, Spire Sports & Entertainment, LLC, and Fancam (PTY) LTD, their respective parents, subsidiaries, limited liability and affiliated companies, and advertising and promotion agencies, and each of their respective family members (parent, child, spouse, sibling and their respective spouses regardless of where they reside), and members of their households, whether or not legally related, are not eligible to enter to win. PRIZES: One Grand Prize winner will receive two (2) tickets to the 2023 Knoxville Nationals at the Knoxville Raceway in Knoxville, Iowa (exact date TBD). Approximate Retail Value ("ARV") of the Grand Prize is \$116. All applicable federal, state, and local taxes, any other expenses associated with prize acceptance and use not specifically listed herein as provided (including air/ground transportation, luggage fees, meals, gratuities, delivery charges, etc.) are the responsibility of each winner. Prizes are awarded "as is" with no warranty or guarantee, either express or implied by Administrator. No substitution, transfer, or cash redemption of prizes is permitted, except by Administrator, which reserves the right to substitute a prize (or portion thereof) with one of comparable or greater value. Total ARV of the prize is \$116. All prize details are at Administrator's sole discretion.
