In this role, Treasurer Mitchell serves as the Chair of the Indiana Bond Bank, the Statewide 911 Board, the Indiana Education Savings Authority, the ABLE Authority, and as the Sole Trustee of the State Police Pension Trust, among a number of other positions. As the Chief Investment Officer for the State, she is responsible for the management of approximately five to seven billion dollars on a daily basis.

For seven years prior to becoming Treasurer, Kelly Mitchell worked in the Treasurer of State's Office as the Director of TrustINdiana, Indiana's local

government investment pool. Before joining the Indiana Treasurer of State's Office, Kelly Mitchell was a County Commissioner for eight years in Cass County, Indiana. During her tenure as Commissioner, she served as President of the Board of Commissioners for five years and was named First-Term Commissioner of the Year by the Association of County Commissioners.

Treasurer Mitchell holds a B.A. in Political Science from Valparaiso University and a M.A. in Philanthropic Studies from Indiana University – Purdue University, Indianapolis (IUPUI). Treasurer Mitchell resides in Indianapolis, with her husband Larry, and they have a blended family of four children and two grandchildren.

Benjamin Hunter, Superintendent of Public Safety at IU



Benjamin Hunter began his role as superintendent of public safety at IU in January, 2017. As superintendent, he is responsible for comprehensive strategy, policy and practices for public safety across Indiana University, including the Indiana University Police Department, which has more than 135 sworn officers across all IU campuses. He also is responsible for the Indiana University Police Academy.

community relations and government affairs at Butler University. At Butler, he also served for a period as chief of staff to Butler University President James M. Danko while overseeing the university's Department of Public Safety and University Events office. His law enforcement career included a stint with IUPD-IUPUI and then 10 years with the Indianapolis Police Department before his transition to higher education law enforcement at Butler. Hunter has a deep interest in community policing, something he developed while working as a community liaison for three different deputy police chiefs at the Indianapolis Police Department (now called Indianapolis Metropolitan Police Department). He also was elected to two four-year terms on the Indianapolis City-County Council, ending in December 2015.


Dr. Lori Reesor, Vice Provost for Student Affairs and Dean of Students
